3	the State Accident Insurance Fund Corporation (SAIF) as a vocational rehabilitation coordinator;

5	Whereas during John Shilts' 13 years with SAIF, he served in progressively responsible leader-
6	ship positions, including as a claims supervisor and as the manager of the public corporation's
7	Medford office; and
8	Whereas John Shilts' main role at SAIF began in 1989, when he was appointed to manage and
9	develop its newly instituted return-to-work program; and
10	Whereas John Shilts was again promoted, and he served in his final three years with SAIF as
11	the director of its risk management services; and
12	Whereas in 1997, John Shilts accepted a position with the Workers' Compensation Division of
13	the Department of Consumer and Business Services and managed the division's Benefits and Policy
14	Services Section; and
15	Whereas highly respected in his department, John Shilts was promoted to administrator of the
16	Workers' Compensation Division in May 2000; and
17	Whereas John Shilts was instrumental in developing what is considered one of the best workers'
18	compensation programs in the country, which during his tenure increased benefit levels and lowered
19	premiums; and
20	Whereas at the Capitol, John Shilts' testimony before legislative committees frequently provided
21	information vital to the completion of legislation; and
22	Whereas a true public servant, John Shilts rejected lucrative offers from the private sector be-
