

# House Joint Resolution 16

Sponsored by Representative BARRETO, Senator HANSELL; Representatives DOHERTY, ESQUIVEL, HACK, HAYDEN, NEARMAN, WITT

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Proposes amendment to Oregon Constitution requiring that signature requirements for statewide initiatives and referenda be satisfied in each congressional district in state.

Refers proposed amendment to people for their approval or rejection at next regular general election.

## JOINT RESOLUTION

**Be It Resolved by the Legislative Assembly of the State of Oregon:**

**PARAGRAPH 1.** Section 1, Article IV of the Constitution of the State of Oregon, is amended to read:

**Sec. 1.** (1) The legislative power of the state, except for the initiative and referendum powers reserved to the people, is vested in a Legislative Assembly, consisting of a Senate and a House of Representatives.

(2)(a) The people reserve to themselves the initiative power, which is to propose laws and amendments to the Constitution and enact or reject them at an election independently of the Legislative Assembly.

(b) An initiative law may be proposed only by a petition signed by a number of qualified voters **in each congressional district in this state** equal to six percent of the total number of votes cast for all candidates for Governor **in that congressional district** at the election at which a Governor was elected for a term of four years next preceding the filing of the petition.

(c) An initiative amendment to the Constitution may be proposed only by a petition signed by a number of qualified voters **in each congressional district in this state** equal to eight percent of the total number of votes cast for all candidates for Governor **in that congressional district** at the election at which a Governor was elected for a term of four years next preceding the filing of the petition.

(d) An initiative petition shall include the full text of the proposed law or amendment to the Constitution. A proposed law or amendment to the Constitution shall embrace one subject only and matters properly connected therewith.

(e) An initiative petition shall be filed not less than four months before the election at which the proposed law or amendment to the Constitution is to be voted upon.

(3)(a) The people reserve to themselves the referendum power, which is to approve or reject at an election any Act, or part thereof, of the Legislative Assembly that does not become effective earlier than 90 days after the end of the session at which the Act is passed.

(b) A referendum on an Act or part thereof may be ordered by a petition signed by a number of qualified voters **in each congressional district in this state** equal to four percent of the total number of votes cast for all candidates for Governor **in that congressional district** at the election

1 at which a Governor was elected for a term of four years next preceding the filing of the petition.  
2 A referendum petition shall be filed not more than 90 days after the end of the session at which the  
3 Act is passed.

4 (c) A referendum on an Act may be ordered by the Legislative Assembly by law.  
5 Notwithstanding section 15b, Article V of this Constitution, bills ordering a referendum and bills  
6 on which a referendum is ordered are not subject to veto by the Governor.

7 (4)(a) Petitions or orders for the initiative or referendum shall be filed with the Secretary of  
8 State. The Legislative Assembly shall provide by law for the manner in which the Secretary of State  
9 shall determine whether a petition contains the required number of signatures of qualified voters  
10 **from each congressional district.** The Secretary of State shall complete the verification process  
11 within the 30-day period after the last day on which the petition may be filed as provided in para-  
12 graph (e) of subsection (2) or paragraph (b) of subsection (3) of this section.

13 (b) Initiative and referendum measures shall be submitted to the people as provided in this sec-  
14 tion and by law not inconsistent therewith.

15 (c) All elections on initiative and referendum measures shall be held at the regular general  
16 elections, unless otherwise ordered by the Legislative Assembly.

17 (d) Notwithstanding section 1, Article XVII of this Constitution, an initiative or referendum  
18 measure becomes effective 30 days after the day on which it is enacted or approved by a majority  
19 of the votes cast thereon. A referendum ordered by petition on a part of an Act does not delay the  
20 remainder of the Act from becoming effective.

21 (5) The initiative and referendum powers reserved to the people by subsections (2) and (3) of this  
22 section are further reserved to the qualified voters of each municipality and district as to all local,  
23 special and municipal legislation of every character in or for their municipality or district. The  
24 manner of exercising those powers shall be provided by general laws, but cities may provide the  
25 manner of exercising those powers as to their municipal legislation. In a city, not more than 15  
26 percent of the qualified voters may be required to propose legislation by the initiative, and not more  
27 than 10 percent of the qualified voters may be required to order a referendum on legislation.

28 **(6) The requirements set forth in this section for initiative and referendum measures,**  
29 **including but not limited to the requirement that signatures be gathered from electors in**  
30 **each congressional district in this state, do not apply to any qualification requirements es-**  
31 **tablished by law for the circulation of initiative and referendum measures.**

33 **PARAGRAPH 2. The amendment proposed by this resolution shall be submitted to the**  
34 **people for their approval or rejection at the next regular general election held throughout**  
35 **this state.**
