Requires Bureau of Labor and Industries to include information about earned income tax credits in posters regarding state minimum wage. Requires Employment Department to provide information to recipients of unemployment

Requires Employment Department to provide information to recipients of unemployment insurance benefits about earned income tax credits.

Takes effect on 91st day following adjournment sine die.
