

## HOUSE AMENDMENTS TO SENATE BILL 1055

1 On page 1 of the printed bill, delete lines 5 through 30 and delete page 2.

2 On page 3, delete lines 1 through 31 and insert:

3 **“SECTION 1.** ORS 107.145 is amended to read:

4 **“107.145. (1) The Legislative Assembly finds and declares that:**

5 **“(a) Establishing a fair, efficient and expeditious process to resolve child custody and**  
6 **visitation issues when a parent is deployed with the Armed Forces of the United States,**  
7 **National Guard or other reserve component is in the best interests of the child of such a**  
8 **deployed parent; and**

9 **“(b) Courts should, to the extent feasible within existing resources and court practices,**  
10 **prioritize the scheduling for hearing of family law matters involving a deployed parent or a**  
11 **parent whose deployment is imminent, avoid unnecessary delays or continuances and ensure**  
12 **that deployed parents are not denied access to their children because of their deployment.**

13 **“[(1)] (2)** As used in this section and ORS 107.146:

14 **“(a) ‘Deployed parent’** means a parent of a minor child whose parental rights have not been  
15 terminated who is deployed with the Armed Forces of the United States, National Guard or other  
16 reserve component.

17 **“(b) ‘Deployment’ or ‘deployed’:**

18 **“(A) Means** military service in compliance with written orders received by an active duty or  
19 reserve member of the Armed Forces of the United States, National Guard or other reserve compo-  
20 nent to report for combat operations, contingency operations, peacekeeping operations, temporary  
21 duty, a remote tour of duty or other active military service;

22 **“(B) Includes** the period of time from which the deployed parent receives and is subject to  
23 written orders to deploy to the actual date of deployment; and

24 **“(C) Includes** any period of time in which the deployed parent is awaiting travel to or from a  
25 deployment destination or remains deployed because of sickness, wounds, leave or other lawful  
26 cause.

27 **“[(2)] (3)** Notwithstanding ORS 107.135 and except as provided in subsection [(3)] (4) of this  
28 section, a court may not set aside, alter or modify any portion of a judgment of annulment, sepa-  
29 ration or dissolution of marriage that provides for the custody, parenting time, visitation, support  
30 and welfare of a minor child of a deployed parent until 90 days after the completion of the deployed  
31 parent’s deployment unless a motion to set aside, alter or modify was filed with, heard by and de-  
32 cided by the court before the commencement of the deployed parent’s deployment.

33 **“[(3)(a)] (4)(a)** Notwithstanding ORS 107.138 and 107.139, a court may enter a temporary order  
34 modifying the terms of a preexisting judgment of annulment, separation or dissolution of marriage  
35 that provides for the custody, parenting time, visitation, support and welfare of a minor child of a

1 deployed parent to reasonably accommodate the circumstances of the deployed parent's deployment  
2 in the best interests of the child, upon motion filed by either party and after service of notice on  
3 the other party in the manner provided by ORCP 7, and after notice to the Administrator of the  
4 Division of Child Support of the Department of Justice or the branch office providing support ser-  
5 vices when required by subsection [(4)] (6) of this section. The nondeployed parent bears the burden  
6 of proof that the provisions of a temporary order made under this subsection are not in the best  
7 interests of the child.

8 “(b) A temporary order entered under this subsection must include the following provisions:

9 “(A) Parenting time for the deployed parent during periods of approved leave in the best inter-  
10 ests of the child;

11 “(B) Parenting time for the deployed parent during periods of deployment in the best interests  
12 of the child including but not limited to contact by telephone, electronic mail and other electronic  
13 means such as video and visual imaging;

14 “(C) Modification of the child support provisions of the preexisting judgment to reflect the  
15 changed circumstances of the parents and the child during the period of deployment;

16 “(D) A requirement that the nondeployed parent provide the court and the deployed parent with  
17 written notice 30 days prior to a change of address or telephone number during the period of de-  
18 ployment;

19 “(E) That the temporary order entered under this subsection terminates by operation of law  
20 upon completion of deployment and that the provisions of the preexisting judgment that have been  
21 modified by the temporary order are automatically reinstated unless a request is made and granted  
22 under subsection [(5)] (7) of this section;

23 “(F) That all other provisions of the preexisting judgment not modified by the temporary order  
24 remain in effect; and

25 “(G) That deployment is considered completed for purposes of reinstating the provisions of the  
26 preexisting judgment that have been modified by the temporary order 10 days after the date on  
27 which the deployed parent serves the nondeployed parent and provides to the court and to the Ad-  
28 ministrator of the Division of Child Support of the Department of Justice or the branch office pro-  
29 viding support services to the county in which the motion is filed copies of written orders or other  
30 official notification that the deployed parent is no longer deployed [*or in active military service*].

31 “(5) A temporary order entered under subsection (4) of this section may include a pro-  
32 vision allowing or requiring reasonable visitation between the child of a deployed parent and  
33 a stepparent, grandparent or other family member related to the child with whom the child  
34 has an ongoing relationship as defined in ORS 109.119. In determining the best interests of  
35 the child, the court shall consider the factors set forth in ORS 109.119 (4) and whether  
36 awarding visitation will facilitate the child's contact with the deployed parent. For purposes  
37 of this subsection, a legal parent is presumed to act in the best interests of the child. In  
38 making an order under this subsection, the court shall apply a preponderance of the evidence  
39 standard.

40 “[4] (6) A true copy of a motion under subsection [(3)] (4) of this section shall be served by the  
41 moving party by mail or personal delivery on the Administrator of the Division of Child Support of  
42 the Department of Justice or on the branch office providing support services to the county in which  
43 the motion is filed.

44 “[5] (7) Prior to reinstatement of the provisions of a preexisting judgment, a parent may re-  
45 quest ex parte a temporary order alleging that the child will be irreparably harmed or placed in

1 immediate danger if the provisions of the preexisting judgment are automatically reinstated upon  
2 completion of deployment.

3 “[6] (8) When a court has entered a temporary order under subsection [(3)] (4) of this section,  
4 the absence of a child from this state during a deployed parent’s deployment is considered a tem-  
5 porary absence for purposes of the Uniform Child Custody Jurisdiction and Enforcement Act and  
6 this state shall retain exclusive continuing jurisdiction in accordance with ORS 109.701 to 109.834.

7 “[7] (9) The court may award attorney fees and costs reasonably incurred in a proceeding un-  
8 der this section if the court finds that a party caused unreasonable delays, failed to provide infor-  
9 mation as required by this section or acted to unreasonably interfere with or frustrate contact  
10 between a deployed parent and a minor child.”.
