

A-Engrossed Senate Bill 1057

Sponsored by COMMITTEE ON RULES (at the request of Senators Ginny Burdick, Ted Ferrioli)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides Oregon Liquor Control Commission with additional power to enforce state marijuana laws.

Provides that commission licensee may be designated by commission as exclusively medical licensee.

Provides that licensee, under certain conditions, may transport marijuana items to and exhibit marijuana items at trade show, Oregon State Fair or similar event.

Directs Oregon Health Authority to create database for sharing registry identification cardholder information with commission.

Transfers duty to adopt labeling standards from authority to commission.

Adjusts limit on number of immature marijuana plant that registry identification cardholder may own. Provides that total of 10 mature marijuana plants may be kept at one address.

Requires propagation, production, processing and transfer of marijuana and marijuana-derived products by marijuana grow sites, marijuana processing sites and medical marijuana dispensaries to be tracked by system developed and maintained by commission for tracking similar activities conducted by licensees of commission.

Provides that State Department of Agriculture may possess, test and dispose of marijuana items [for horticultural purposes].

Makes technical changes.

[Takes effect on 91st day following adjournment sine die].

Declares emergency, effective on passage.

15 **SECTION 1.** ORS 475B.010 is amended to read:

16 475B.010. ORS 475B.010 to 475B.395 shall be known and may be cited as the [*Control and Reg-*
17 *ulation of Marijuana Act.*] **Adult and Medical Use of Cannabis Act.**

23 license issued under ORS 475B.560 if the commission determines that a person that has a

14 SECTION 16. Section 17 of this 2017 Act is added to and made a part of ORS 475B.010 to
15 475B.395.

16 SECTION 17. (1) Notwithstanding ORS 475B.160 or any other provision prohibiting the
17 transportation of marijuana items to or from a location for which a license has not been is-
18 sued under ORS 475B.010 to 475B.395 or prohibiting the possession of marijuana items at a
19 location for which a license has not been issued under ORS 475B.010 to 475B.395, a licensee
20 may transport marijuana items to and exhibit marijuana items at a trade show, the Oregon
21 State Fair or a similar event if:

22 (a) The marijuana items are tracked using the system developed and maintained under
23 ORS 475B.150;

24 (b) All of the marijuana items are returned to a premises for which a license has been
25 issued under ORS 475B.010 to 475B.395 immediately after the conclusion of the event; and

26 (c) The licensee complies with any other requirement imposed by the Oregon Liquor
27 Control Commission by rule or order for the purpose of ensuring the security of the

33 (2) Notwithstanding ORS 475B.160 or any other provision prohibiting the transportation
34 of marijuana items to or from a location for which a license has not been issued under ORS
35 475B.010 to 475B.395 or prohibiting the possession of marijuana items at a location for which
36 a license has not been issued under ORS 475B.010 to 475B.395, a licensee may transport
37 marijuana items to and exhibit marijuana items at the 2017 Oregon State Fair if:

38 (a) The licensee is acting pursuant to an order issued by the Oregon Liquor Control
39 Commission providing for the transportation and exhibition;

40 (b) All of the marijuana items are returned to a premises for which a license has been
41 issued under ORS 475B.010 to 475B.395 immediately after the conclusion of the event; and

42 (c) The licensee complies with any other requirement imposed by the commission for the
43 purpose of ensuring the security of the marijuana items, for the purpose of preventing mi-
44 nors from having access to the marijuana items or for any other purpose deemed relevant
45 by the commission.

4 **PRODUCTION, PROCESSING AND SALE FOR MEDICAL PURPOSES**

6 **SECTION 19.** Section 2, chapter 83, Oregon Laws 2016, is amended to read:

7 **Sec. 2.** *[(1) As used in this section, “designated primary caregiver,” “marijuana processing site,”*
8 *“medical marijuana dispensary” and “registry identification cardholder” have the meanings given those*
9 *terms in ORS 475B.410.]*

10 [(2)] **(1)** To produce marijuana for medical purposes, a marijuana producer that holds a license
11 **issued** under ORS 475B.070 must register with the Oregon Liquor Control Commission under this
12 section.

13 [(3)] **(2)** The commission shall register a marijuana producer for the purpose of producing
14 marijuana for medical purposes if the marijuana producer:

- 15 (a) Holds a license **issued** under ORS 475B.070;
16 (b) Meets any qualifications adopted by the commission by rule;
17 (c) Applies to the commission in a form and manner prescribed by the commission; and
18 (d) Pays any fee adopted by the commission by rule.

19 [(4)(a)] *A marijuana producer registered under this section may produce marijuana for a registry*
20 *identification cardholder, and provide usable marijuana to the registry identification cardholder or to*
21 *the designated primary caregiver of the registry identification cardholder, if the marijuana producer*
22 *enters into an agreement with the registry identification cardholder for whom the marijuana producer*
23 *is producing the marijuana. An agreement entered into under this subsection:]*

24 [(A)] *Must be submitted to the commission in a manner prescribed by the commission;]*

25 [(B)] *Except as provided in subparagraph (C) of this paragraph, may not allow the marijuana pro-*
26 *ducer to be compensated for producing the marijuana or providing the usable marijuana;]*

27 [(C)] *May require a registry identification cardholder, or a designated primary caregiver on behalf*
28 *of a registry identification cardholder, to reimburse a marijuana producer for all costs associated with*
29 *producing marijuana for the registry identification cardholder or providing usable marijuana to the*
30 *registry identification cardholder or designated primary caregiver;]*

31 [(D)] *May not allow the marijuana producer to produce for the registry identification cardholder*
32 *an amount of mature marijuana plants that exceeds the amount that a registry identification cardholder*
33 *and a designated primary caregiver may jointly possess under ORS 475B.428;]*

34 [(E)] *May not allow the marijuana producer to provide to the registry identification cardholder an*
35 *amount of usable marijuana that exceeds the amount that a registry identification cardholder and a*
36 *designated primary caregiver may jointly possess under ORS 475B.430; and]*

37 [(F)] *May allow the marijuana producer to keep a portion of the usable marijuana harvested from*
38 *the marijuana produced for the registry identification cardholder for the purposes of:]*

39 [(i)] *Providing usable marijuana to additional registry identification cardholders or designated pri-*
40 *mary caregivers; and]*

41 [(ii)] *Transferring or selling usable marijuana to marijuana processing sites or medical marijuana*
42 *dispensaries.]*

43 [(c)] *Marijuana produced for a registry identification cardholder, and usable marijuana transferred*
44 *or sold to a marijuana processing site or medical marijuana dispensary, pursuant to an agreement*
45 *entered into under this subsection must be tracked by the system developed and maintained under ORS*

2 [(d)(A) Upon request by the commission, the Oregon Health Authority shall provide the commission,
3 notwithstanding any laws relating to the confidentiality of information under ORS 475B.460 and
4 475B.462, with the registration information of:]

5 [(i) A registry identification cardholder who enters into an agreement under this subsection; or]

6 [(ii) A registry identification cardholder, designated primary caregiver, marijuana processing site
7 or medical marijuana dispensary that receives usable marijuana pursuant to an agreement entered into
8 under this subsection.]

9 [(B) Registration information received by the commission under this paragraph that is confidential
10 and not subject to public disclosure under ORS 475B.460 and 475B.462 remains confidential and not
11 subject to public disclosure after being provided to the commission.]

13 to rules restricting the size of mature marijuana plant grow canopies adopted by the commission under

16 [(A) For the equitable conversion of a number of mature marijuana plants to a size of mature
17 marijuana plant grow canopy;]

18 [(B) Limiting the amount of marijuana that may be produced under section (4) of this section;]

19 [(C) Limiting the amount of usable marijuana that may be provided, transferred or sold under
20 subsection (4)(a)(F) of this section;]

21 [(D) Limiting the number of registry identification cardholders for whom a marijuana producer
22 registered under this section may produce marijuana; and]

23 [(E) Prohibiting a registry identification cardholder from entering into more than one agreement
24 with a marijuana producer registered under this section.]

25 **(3) Subject to subsection (4) of this section, a marijuana producer registered under this**
26 **section may produce marijuana plants on a medically designated grow canopy in addition to**
27 **producing marijuana plants on the grow canopy allowed under rules adopted under ORS**
28 **475B.075. The commission shall specify the size of medically designated grow canopies by**
29 **rule, provided that the size of any medically designated grow canopy does not exceed 10**
30 **percent of the total size of both the medically designated grow canopy and the grow canopy**
31 **allowed under rules adopted under ORS 475B.075 at the time that the marijuana producer**
32 **applies for registration under this section.**

33 **(4) A marijuana producer registered under this section must provide, for no consider-**
34 **ation, at least 75 percent of the annual yield of usable marijuana harvested from the**
35 **marijuana producer's medically designated grow canopy to registry identification cardholders**
36 **and designated primary caregivers.**

37 **(5) A marijuana producer registered under this section may not, during a single trans-**
38 **action, provide a registry identification cardholder or the designated primary caregiver of a**
39 **registry identification cardholder an amount of usable marijuana that exceeds the amount**
40 **of usable marijuana that a registry identification cardholder and a designated primary**
41 **caregiver may jointly possess under ORS 475B.430.**

42 **(6)(a) The commission shall adopt rules necessary to administer this section.**

43 **(b) The rules must establish sanctions for failure to meet the requirements of this sec-**
44 **tion or a rule adopted under this section, including revocation of permission for the**
45 **marijuana producer's medically designated grow canopy.**

9 (2) The commission shall register a marijuana processor for the purpose of processing marijuana
10 for medical purposes if the marijuana processor:

- 11 (a) Holds a license **issued** under ORS 475B.090;
- 12 (b) Meets any qualifications adopted by the commission by rule;
- 13 (c) Applies to the commission in a form and manner prescribed by the commission; and
- 14 (d) Pays any fee adopted by the commission by rule.

15 (3) A marijuana processor registered under this section may:

16 (a) Process marijuana and usable marijuana into medical grade cannabinoid products,
17 cannabinoid concentrates and cannabinoid extracts[.]; **and**

18 (b) **Notwithstanding ORS 475B.160, receive marijuana and usable marijuana from, and for**
19 **a fee process that marijuana and usable marijuana into cannabinoid products, cannabinoid**
20 **concentrates and cannabinoid extracts for, a registry identification cardholder or the desig-**
21 **ned primary caregiver of a registry identification cardholder, provided that the cannabinoid**
22 **products, cannabinoid concentrates and cannabinoid extracts meet the requirements of ORS**
23 **475B.550 to 475B.590 and 475B.625.**

24 (4)(a) The commission shall adopt rules necessary to administer this section.

25 (b) The rules must provide that any fee adopted by the commission under subsection (2)(d) of
26 this section be in an amount reasonably calculated to not exceed, together with other fees collected
27 under ORS 475B.010 to 475B.395, the cost of administering ORS 475B.010 to 475B.395.

28 **SECTION 21.** Section 4, chapter 83, Oregon Laws 2016, is amended to read:

29 **Sec. 4.** (1) To sell marijuana **items** at wholesale for medical purposes, a marijuana wholesaler
30 that holds a license **issued** under ORS 475B.100 must register with the Oregon Liquor Control
31 Commission under this section.

32 (2) The commission shall register a marijuana wholesaler for the purpose of selling marijuana
33 **items** at wholesale for medical purposes if the marijuana wholesaler:

- 34 (a) Holds a license under ORS 475B.100;
- 35 (b) Meets any qualifications adopted by the commission by rule;
- 36 (c) Applies to the commission in a form and manner prescribed by the commission; and
- 37 (d) Pays any fee adopted by the commission by rule.

38 (3) A marijuana wholesaler registered under this section may sell medical grade cannabinoid
39 products, cannabinoid concentrates and cannabinoid extracts at wholesale.

40 (4) The commission shall adopt rules necessary to administer this section. The rules must pro-
41 vide that any fee adopted by the commission under subsection (2)(d) of this section be in an amount
42 reasonably calculated to not exceed, together with other fees collected under ORS 475B.010 to
43 475B.395, the cost of administering ORS 475B.010 to 475B.395.

44 **SECTION 22.** Section 5, chapter 83, Oregon Laws 2016, is amended to read:

45 **Sec. 5.** [(1) As used in this section, “designated primary caregiver” and “registry identification

2 [(2)] (1) To sell marijuana **items** at retail for medical purposes, a marijuana retailer that holds
3 a license **issued** under ORS 475B.110 must register with the Oregon Liquor Control Commission
4 under this section.

5 [(3)] (2) The commission shall register a marijuana retailer for the purpose of selling marijuana
6 **items** at retail for medical purposes if the marijuana retailer:

- 7 (a) Holds a license **issued** under ORS 475B.110;
- 8 (b) Meets any qualifications adopted by the commission by rule;
- 9 (c) Applies to the commission in a form and manner prescribed by the commission; and
- 10 (d) Pays any fee adopted by the commission by rule.

11 [(4)] (3) A marijuana retailer registered under this section:

12 (a) May sell medical grade cannabinoid products, cannabinoid concentrates and cannabinoid
13 extracts to registry identification cardholders and designated primary caregivers;

14 (b) May not sell medical grade cannabinoid products, cannabinoid concentrates and cannabinoid
15 extracts to individuals other than registry identification cardholders and designated primary
16 caregivers;

17 (c) May sell usable marijuana and medical grade cannabinoid products, cannabinoid concen-
18 trates and cannabinoid extracts to registry identification cardholders and designated primary
19 caregivers at a discounted price; and

20 (d) May provide, **for no consideration**, usable marijuana and medical grade cannabinoid pro-
21 ducts, cannabinoid concentrates and cannabinoid extracts to a registry identification [*cardholders*
22 *and designated primary caregivers free of charge*] **cardholder and the designated primary**
23 **caregiver of the registry identification cardholder.**

24 [(5)] (4)(a) The commission shall adopt rules necessary to administer this section.

25 (b) The rules must provide that any fee adopted by the commission under subsection [(3)(d)]

31 **producer that holds a license issued under ORS 475B.070 and that is registered under section**
32 **2, chapter 83, Oregon Laws 2016, as an exclusively medical licensee if the marijuana producer**
33 **attests, in a form and manner prescribed by the commission, to:**

- 34 (a) **Producing marijuana only for medical purposes; and**
- 35 (b) **Transferring usable marijuana only to marijuana processors registered under section**
36 **3, chapter 83, Oregon Laws 2016, marijuana wholesalers registered under section 4, chapter**
37 **83, Oregon Laws 2016, marijuana retailers registered under section 5, chapter 83, Oregon**
38 **Laws 2016, registry identification cardholders and designated primary caregivers.**

39 (2) **If the commission makes a designation under this section, the commission shall keep**
40 **a record of the designation.**

41 **SECTION 25. (1) The Oregon Liquor Control Commission shall designate any marijuana**
42 **processor that holds a license issued under ORS 475B.090 and that is registered under section**
43 **3, chapter 83, Oregon Laws 2016, as an exclusively medical licensee if the marijuana**
44 **processor attests, in a form and manner prescribed by the commission, to:**

- 45 (a) **Processing marijuana only for medical purposes;**

1 (b) Receiving usable marijuana only from a marijuana producer registered under section
2 2, chapter 83, Oregon Laws 2016; and

3 (c) Transferring cannabinoid products, cannabinoid concentrates and cannabinoid ex-
4 tracts only to marijuana wholesalers registered under section 4, chapter 83, Oregon Laws
5 2016, marijuana retailers registered under section 5, chapter 83, Oregon Laws 2016, registry
6 identification cardholders and designated primary caregivers.

7 (2) If the commission makes a designation under this section, the commission shall keep
8 a record of the designation.

9 **SECTION 26.** (1) The Oregon Liquor Control Commission shall designate any marijuana
10 wholesaler that holds a license issued under ORS 475B.100 and that is registered under sec-
11 tion 4, chapter 83, Oregon Laws 2016, as an exclusively medical licensee if the marijuana
12 wholesaler attests, in a form and manner prescribed by the commission, to:

13 (a) Selling marijuana items only for a medical purposes;

14 (b) Receiving usable marijuana only from marijuana producers registered under section
15 2, chapter 83, Oregon Laws 2016, and marijuana processors registered under section 3,
16 chapter 83, Oregon Laws 2016;

17 (c) Receiving cannabinoid products, cannabinoid concentrates and cannabinoid extracts
18 only from a marijuana processor registered under section 3, chapter 83, Oregon Laws 2016;
19 and

20 (d) Transferring usable marijuana, cannabinoid products, cannabinoid concentrates and
21 cannabinoid extracts only to marijuana retailers registered under section 5, chapter 83,
22 Oregon Laws 2016.

23 (2) If the commission makes a designation under this section, the commission shall keep
24 a record of the designation.

25 **SECTION 27.** (1) The Oregon Liquor Control Commission shall designate any marijuana
26 retailer that holds a license issued under ORS 475B.110 and that is registered under section
27 5, chapter 83, Oregon Laws 2016, as an exclusively medical licensee if the marijuana retailer
28 attests, in a form and manner prescribed by the commission, to:

29 (a) Selling marijuana items only for medical purposes;

30 (b) Receiving usable marijuana only from marijuana producers registered under section
31 2, chapter 83, Oregon Laws 2016, marijuana processors registered under section 3, chapter
32 83, Oregon Laws 2016, and marijuana wholesalers registered under section 4, chapter 83,
33 Oregon Laws 2016;

34 (c) Receiving cannabinoid products, cannabinoid concentrates and cannabinoid extracts
35 only from a marijuana processor registered under section 3, chapter 83, Oregon Laws 2016,
36 and marijuana wholesalers registered under section 4, chapter 83, Oregon Laws 2016; and

37 (d) Transferring usable marijuana, cannabinoid products, cannabinoid concentrates and
38 cannabinoid extracts only to registry identification cardholders and designated primary
39 caregivers.

40 (2) If the commission makes a designation under this section, the commission shall keep
41 a record of the designation.

44 475B.800. (1) The governing body of a city or county may adopt ordinances to be referred to the

10 **Oregon Liquor Control Commission has designated as an exclusively medical licensee under**
11 **section 24 of this 2017 Act;**

12 **(h) Marijuana processors that hold a license issued under ORS 475B.090 and that the**
13 **commission has designated as an exclusively medical licensee under section 25 of this 2017**

SECTION 30. Section 31 of this 2017 Act is added to and made a part of ORS 475B.400 to 475B.525.

SECTION 31. (1) Except as provided in subsection (5) of this section, the Oregon Health Authority shall establish, maintain and operate an electronic system for the keeping of information received by the authority under ORS 475B.415 and 475B.420 or information included on a registry identification card issued under ORS 475B.415 or on a marijuana grow site registration card issued under ORS 475B.420.

(2) The authority may contract with a state agency or private entity to ensure the effective establishment, maintenance or operation of the electronic system.

(3) Except as provided in subsection (4) of this section, information kept in the electronic system is confidential and not subject to public disclosure under ORS 192.410 to 192.505. Except as provided in subsection (4) of this section, the authority may not disclose the information for any reason.

(4) Except as provided in subsection (5) of this section, the authority shall establish the electronic system in a manner that allows the Oregon Liquor Control Commission and the Department of Revenue to remotely access the electronic system. Information disclosed to the commission and the department under this subsection remains confidential and not subject to public disclosure under ORS 192.410 to 192.505. The commission and the department may not disclose the information for any reason.

(5) The authority is not required to keep in the database, and the commission and the department may not access, the following types of information:

(a) Information related to the debilitating condition of a registry identification cardholder; or

(b) The contact information or address of a registry identification cardholder or a designated primary caregiver, unless the contact information or address are the same as the contact information or address of a marijuana grow site.

(6) The electronic system must be immediately accessible by the commission and the department at all times.

32 marijuana, cannabinoid products and cannabinoid concentrates and extracts transferred by a med-
33 ical marijuana dispensary registered under ORS 475B.450 to be labeled in accordance with sub-
34 section (1) of this section and rules adopted under subsection (1) of this section.

21 may jointly possess under ORS 475B.428, and the amount of usable marijuana that a registry
22 identification cardholder and the designated primary caregiver of the registry identification
23 cardholder may jointly possess under ORS 475B.430, is in addition to, and not in lieu of, the
24 number of marijuana plants and the amount of usable marijuana that may be possessed at
25 a household as described in ORS 475B.245.

26 **SECTION 37.** ORS 475B.428, as amended by section 23, chapter 24, Oregon Laws 2016, is
27 amended to read:

28 475B.428. [(1)] (1)(a) [*Subject to subsection (2) of this section,*] A registry identification cardholder
29 and the designated primary caregiver of the registry identification cardholder may jointly possess:

30 (A) Six or fewer mature marijuana plants[.]; and

12 plants **and no more than 96 immature marijuana plants** may be produced at the address; or

15 January 1, 2015[.]:

16 (A) No more than the amount of mature marijuana plants located at that address on December

19 **SECTION 39.** Sections 40 and 41 of this 2017 Act are added to and made a part of ORS
20 **475B.400 to 475B.525.**

21 **SECTION 40.** (1) The Oregon Health Authority shall enter into an agreement with the
22 Oregon Liquor Control Commission under which the commission shall use the system de-
23 veloped and maintained under ORS 475B.150 to track:

24 (a) The propagation of immature marijuana plants and the production of marijuana by
25 marijuana grow sites;

26 (b) The processing of marijuana into medical cannabinoid products, cannabinoid concen-
27 trates and cannabinoid extracts that are transferred to a medical marijuana dispensary;

28 (c) The transfer of usable marijuana, immature marijuana plants, medical cannabinoid
29 products, cannabinoid concentrates and cannabinoid extracts by a marijuana grow site or a

2 tracking under this section, the medical marijuana dispensary is exempt from the require-
3 ments of ORS 475B.453 and the provisions of ORS 475B.450 that relate to ORS 475B.453.

4 (6) The commission may conduct inspections and investigations of alleged violations of
5 ORS 475B.400 to 475B.525 about which the commission obtains knowledge as a result of per-
6 forming the commission's duties under this section. Notwithstanding section 6 of this 2017
7 Act, the commission may use regulatory specialists, as defined in ORS 471.001, to conduct
8 the inspections and investigations, including inspections and investigations of marijuana
9 grow sites located at a primary residence.

15 and collateralization agreements, bond documents, certificates of participation and other debt re-
16 payment agreements, and any associated contracts, agreements and documents, regardless of
17 whether the obligations that the contracts, agreements or documents establish are general, special
18 or limited, except that the State Treasurer's public contracting for goods and services is subject to
19 ORS chapter 279B;

20 (q) Contracts, agreements or other documents entered into, issued or established in connection
21 with:

22 (A) The issuance of obligations, as defined in ORS 286A.100 and 287A.310, of a public body;

23 (B) The making of program loans and similar extensions or advances of funds, aid or assistance
24 by a public body to a public or private body for the purpose of carrying out, promoting or sustaining
25 activities or programs authorized by law; or

26 (C) The investment of funds by a public body as authorized by law, and other financial trans-
27 actions of a public body that by their character cannot practically be established under the com-
28 petitive contractor selection procedures of ORS 279B.050 to 279B.085;

29 (r) Contracts for employee benefit plans as provided in ORS 243.105 (1), 243.125 (4), 243.221,
30 243.275, 243.291, 243.303 and 243.565;

31 (s) Contracts for employee benefit plans as provided in ORS 243.860 to 243.886; or

32 (t) Any other public contracting of a public body specifically exempted from the code by another
33 provision of law.

34 (3) The Public Contracting Code does not apply to the contracting activities of:

35 (a) The Oregon State Lottery Commission;

36 (b) The legislative department;

37 (c) The judicial department;

38 (d) Semi-independent state agencies listed in ORS 182.454, except as provided in ORS 279.835 to
39 279.855 and 279A.250 to 279A.290;

40 (e) Oregon Corrections Enterprises;

41 (f) The Oregon Film and Video Office, except as provided in ORS 279A.100 and 279A.250 to
42 279A.290;

43 (g) The Travel Information Council, except as provided in ORS 279A.250 to 279A.290;

44 (h) The Oregon 529 Savings Network and the Oregon 529 Savings Board;

45 (i) The Oregon Innovation Council;

1 (j) The Oregon Utility Notification Center; or

2 (k) Any other public body specifically exempted from the code by another provision of law.

3 (4) ORS 279A.200 to 279A.225 and 279B.050 to 279B.085 do not apply to contracts made with
4 qualified nonprofit agencies providing employment opportunities for individuals with disabilities un-
5 der ORS 279.835 to 279.855.

6 **SECTION 95.** ORS 471.705 is amended to read:

7 471.705. (1) There is created the Oregon Liquor Control Commission, consisting of [*five*
8 *persons*] **seven commissioners** appointed by the Governor. One [*member shall*] **commissioner must**
9 **be from among the [*bona fide*] residents of each congressional district of [*the*] this state. **One ad-**
10 **ditional commissioner must be from eastern Oregon. One additional commissioner must be**
11 **from western Oregon.** One [*member shall*] **commissioner must** be from the food and alcoholic
12 beverage retail industry. Not more than [*three*] **four** commissioners [*shall*] **may** be of the same pol-
13 itical party [*and one shall be designated by*]. The Governor **shall designate one commissioner** to
14 be chairperson of the commission. The commissioners are entitled to compensation and expenses as
15 provided in ORS 292.495.**

16 (2) Each commissioner at the time of appointment [*and qualification shall*] **must** be a resident
17 of this state and [*shall*] **must** have resided in this state for at least five years next preceding ap-
18 pointment and qualification. [*The*] **Each** commissioner [*shall*] **must** be an elector [*therein*] **in this**
19 **state and may not be** less than 30 years of age. [*A commissioner shall cease to hold office*] **The term**
20 **of office of a commissioner terminates** if the commissioner ceases to possess the residency or
21 industry qualification for appointment [*and*]. **If the term of office of a commissioner terminates**
22 **under this subsection,** the Governor shall appoint a qualified individual to complete the unexpired
23 term **of the commissioner.**

24 [(2)] (3) The term of office of a commissioner [*shall be*] **is** four years from the time of appoint-
25 ment and qualification and until a successor qualifies **for appointment.** The terms of the commis-
26 sioners [*shall*] commence April 1. [*In case any*] **If a** commissioner is allowed to hold [*over*] **office**
27 after the expiration of [*the*] **a** term, the [*successor shall be appointed*] **Governor shall appoint the**
28 **successor** for the [*balance*] **remainder** of the unexpired term. [*Vacancies in the commission shall*
29 *be filled by the Governor for the unexpired term.*] **If a vacancy occurs in the commission, the**
30 **Governor shall appoint the successor for the remainder of the unexpired term.** Each commis-
31 sioner is eligible for reappointment, but [*no person shall be*] **an individual is not** eligible to serve
32 for more than two full terms.

33 [(3)] (4) [*All*] Appointments of commissioners by the Governor **under this section** are subject
34 to confirmation by the Senate pursuant to section 4, Article III, Oregon Constitution.

42 **SECTION 97.** The Oregon Liquor Control Commission shall adopt rules necessary to im-
43 plement the amendments to sections 2 and 3, chapter 83, Oregon Laws 2016, by sections 19
44 and 20 of this 2017 Act on or before January 1, 2018.

45 **SECTION 98.** The amendments to section 2, chapter 83, Oregon Laws 2016, by section 19

1 of this 2017 Act do not affect any contract entered into between a marijuana producer reg-
2 istered under section 2, chapter 83, Oregon Laws 2016, and a registry identification
3 cardholder, as defined in ORS 475B.410, before the effective date of this 2017 Act.

4 **SECTION 99.** (1) Sections 24 to 27 and 31 of this 2017 Act and the amendments to ORS
5 475B.605 and 475B.655 by sections 33 and 34 of this 2017 Act become operative on January 1,
6 2018.

7 (2) The Oregon Liquor Control Commission and the Oregon Health Authority may take
8 any action before the operative date specified in subsection (1) of this section that is neces-
9 sary to enable the commission and authority to exercise, on and after the operative date
10 specified in subsection (1) of this section, all the duties, functions and powers conferred on
11 the commission and authority by sections 24 to 27 and 31 of this 2017 Act and the amend-
12 ments to ORS 475B.605 and 475B.655 by sections 33 and 34 of this 2017 Act.

13 **SECTION 100.** The unit captions used in this 2017 Act are provided only for the conven-
14 ience of the reader and do not become part of the statutory law of this state or express any
15 legislative intent in the enactment of this 2017 Act.

16 **SECTION 101.** This 2017 Act being necessary for the immediate preservation of the public
17 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect
18 on its passage.
