4	"[(2)] (3) The term of office of a commissioner [shall be] is four years from the time of appoint-
5	ment and qualification and until a successor qualifies for appointment. The terms of the commis-
6	sioners [shall] commence April 1. [In case any] If a commissioner is allowed to hold [over] office
7	after the expiration of [the] a term, the [successor shall be appointed] Governor shall appoint the
8	successor for the [balance] remainder of the unexpired term. [Vacancies in the commission shall
9	be filled by the Governor for the unexpired term.] If a vacancy occurs in the commission, the
10	Governor shall appoint the successor for the remainder of the unexpired term. Each commis-
11	sioner is eligible for reappointment, but [no person shall be] an individual is not eligible to serve
12	for more than two full terms.
13	"[(3)] (4) [All] Appointments of commissioners by the Governor under this section are subject
14	to confirmation by the Senate pursuant to section 4, Article III, Oregon Constitution.

25	"SECTION 98. The amendments to section 2, chapter 83, Oregon Laws 2016, by section
26	19 of this 2017 Act do not affect any contract entered into between a marijuana producer
27	registered under section 2, chapter 83, Oregon Laws 2016, and a registry identification
28	cardholder, as defined in ORS 475B.410, before the effective date of this 2017 Act.
29	"SECTION 99. (1) Sections 24 to 27 and 31 of this 2017 Act and the amendments to ORS
30	475B.605 and 475B.655 by sections 33 and 34 of this 2017 Act become operative on January 1,
31	2018.
32	"(2) The Oregon Liquor Control Commission and the Oregon Health Authority may take
33	any action before the operative date specified in subsection (1) of this section that is neces-
34	sary to enable the commission and authority to exercise, on and after the operative date
35	specified in subsection (1) of this section, all the duties, functions and powers conferred on
36	the commission and authority by sections 24 to 27 and 31 of this 2017 Act and the amend-
37	ments to ORS 475B.605 and 475B.655 by sections 33 and 34 of this 2017 Act.
38	"SECTION 100. The unit captions used in this 2017 Act are provided only for the con-
39	venience of the reader and do not become part of the statutory law of this state or express
40	any legislative intent in the enactment of this 2017 Act.
41	"SECTION 101. This 2017 Act being necessary for the immediate preservation of the
42	public peace, health and safety, an emergency is declared to exist, and this 2017 Act takes
43	effect on its passage.".
