SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes formation of children's special districts. Authorizes children's special districts to levy property taxes to fund programs that offer children's services. Defines "children's services" as services provided outside of school hours to children who are school-aged or younger, including, without limitation, services related to [education,] civics, culture, arts and music, physical recreation, health and well-being, technology and development of skills.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1.** ORS 198.010 is amended to read:

(2) Children's special districts may be formed to provide funding for programs that offer 14 15 children's services. 16 (3)(a) ORS 198.705 to 198.955 apply to children's special districts. (b) Notwithstanding paragraph (a) of this subsection, the petition for formation of a 17 18 children's special district must be signed by not less than 15 percent of the electors or 100 electors, whichever is greater, registered in the territory subject to the petition. 19 SECTION 3. (1)(a) The directors of a children's special district shall be a district board 20of five members serving four-year terms. 2122(b) A district board member must be an elector residing within the children's special 23district. (c) The district board members shall be elected as provided in ORS 198.815 and this sec-24 tion. 25(2) Five district board members shall be elected at the election for district formation and 2627shall serve for the following terms: (a) If the effective date of the formation of the district occurs in an odd-numbered year, 28two district board members shall be elected for four-year terms and the other three district 2930 board members shall be elected for two-year terms. 31 (b) If the effective date of the formation of the district occurs in an even-numbered year, two district board members shall be elected for three-year terms and the other three district 32board members shall be elected for one-year terms. 33 34 (3) Each district board member shall hold office until election and qualification of a suc-35cessor. SECTION 4. (1) The district board shall be the governing body of a children's special 36 37 district and shall exercise all powers of the district. 38 (2) At the first meeting of the district board, or as soon as practicable, the board shall choose one of the members of the board as president. 39 SECTION 5. A children's special district has the power: 40 (1) To have and use a common seal. 41 (2) To sue and be sued in the name of the district. 42 (3) To make and accept any and all contracts, deeds, leases, releases and documents of 43 any kind that, in the judgment of the district board, are necessary and proper to the exercise 44 of any power of the district, and to direct the payment of all lawful claims or demands. 45

1 (4) To assess, levy and collect taxes to pay the cost of children's services within the 2 boundaries of the district, any lawful claims against the district and the operating expenses

3 of the district.

4 (5) To employ all necessary agents and assistants.

5 (6) To select the children's services programs that, after a competitive process conducted 6 by the district, are to receive funding from the district.

7 (7) To call elections for the district after the formation of the district.

8 (8) To enlarge the boundaries of the district as provided by ORS 198.705 to 198.955.

9 (9) Generally to do and perform any and all acts necessary and proper to the complete

exercise and effect of any of the powers of the district or the purposes for which the district
was formed.

12 <u>SECTION 6.</u> Each year, the district board of a children's special district shall determine 13 and fix the amount of moneys to be levied and raised by taxation for the purposes of the 14 district.
