

SENATE AMENDMENTS TO SENATE BILL 140

By JOINT COMMITTEE ON WAYS AND MEANS

1 Delete lines 4 through 10 of the printed bill and insert:

2 **“SECTION 1. There is established in the State Treasury, separate and distinct from the**
3 **General Fund, the Veterans’ Services Fund, to be administered by the Oregon Department**
4 **of Administrative Services. Interest earned by the fund is credited to the fund. Pursuant to**
5 **Article XV, section 4f, of the Oregon Constitution, one and one-half percent of the net pro-**
6 **ceeds from the Oregon State Lottery shall be deposited in the Veterans’ Services Fund. All**
7 **moneys transferred from the State Lottery Fund and all other moneys authorized to be**
8 **transferred to the Veterans’ Services Fund from whatever source are appropriated contin-**
9 **uously to provide services for the benefit of veterans.**

10 **“SECTION 2. (1) On December 31 in each odd-numbered year, all amounts remaining**
11 **unspent by a state agency from statutory allocations made from the Veterans’ Services Fund**
12 **to that agency for the prior biennium shall revert to the Veterans’ Services Fund.**

13 **“(2) Subsection (1) of this section does not apply to allocations for debt service, capital**
14 **construction, continuing contracts, contested claims or special allocations designated by**
15 **legislative action.**

16 **“SECTION 3. The Veterans’ Department of Veterans’ Affairs Dedicated Lottery Fund is**
17 **established in the State Treasury, separate and distinct from the General Fund. The**
18 **Veterans’ Department of Veterans’ Affairs Dedicated Lottery Fund consists of moneys allo-**
19 **cated or transferred to the fund from the Veterans’ Services Fund established under section**
20 **1 of this 2017 Act. The moneys in the Veterans’ Department of Veterans’ Affairs Dedicated**
21 **Lottery Fund are continuously appropriated to the Department of Veterans’ Affairs to pro-**
22 **vide services for the benefit of veterans. Moneys in the fund may be used only for purposes**
23 **for which moneys in the Veterans’ Services Fund may be used under section 1 of this 2017**
24 **Act and Article XV, section 4f, of the Oregon Constitution.**

25 **“SECTION 4. The Veterans’ Housing and Community Services Department Dedicated**
26 **Lottery Fund is established in the State Treasury, separate and distinct from the General**
27 **Fund. The Veterans’ Housing and Community Services Department Dedicated Lottery Fund**
28 **consists of moneys allocated or transferred to the fund from the Veterans’ Services Fund**
29 **established under section 1 of this 2017 Act or from the Veterans’ Department of Veterans’**
30 **Affairs Dedicated Lottery Fund established under section 3 of this 2017 Act. The moneys in**
31 **the Veterans’ Housing and Community Services Department Dedicated Lottery Fund are**
32 **continuously appropriated to the Housing and Community Services Department to provide**
33 **services for the benefit of veterans. Moneys in the fund may be used only for purposes for**
34 **which moneys in the Veterans’ Services Fund may be used under section 1 of this 2017 Act**
35 **and Article XV, section 4f, of the Oregon Constitution.**
