## Senate Bill 190

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with presession filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on General Government and Accountability)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Creates Task Force on Committees. Directs task force to study and recommend methods to reduce number of committees in state government. Sunsets December 31, 2018.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to committees; and declaring an emergency.

Be It Enacted by the People of the State of Oregon: 3

4 SECTION 1. (1) The Task Force on Committees is established.

5 (2) The task force consists of five members appointed as follows:

- 6 (a) The President of the Senate shall appoint three members from among members of the 7 Senate.

8 (b) The Speaker of the House of Representatives shall appoint two members from among

9 members of the House of Representatives.

- (3) The task force shall study and recommend ways to reduce the number of committees 10
- in state government, including committees denominated as boards, commissions, task forces, 11 12 councils, advisory groups or similar names.
- (4) A majority of the members of the task force constitutes a quorum for the transaction 13 of business. 14
- 15(5) Official action by the task force requires the approval of a majority of the members 16 of the task force.
- (6) The task force shall elect one of its members to serve as chairperson. 17
- (7) If there is a vacancy for any cause, the appointing authority shall make an appoint-18 19 ment to become immediately effective.

20 (8) The task force shall meet at times and places specified by the call of the chairperson 21or of a majority of the members of the task force.

- 22 (9) The task force may adopt rules necessary for the operation of the task force.
- (10) The task force may presession file legislation in the manner provided in ORS 171.130 2324 for interim committees. All legislation recommended by official action of the task force must 25 indicate that it is introduced at the request of the task force.
- 26 (11) The task force shall report to the Legislative Assembly in the manner provided in 27ORS 192.245 at any time within 30 days after its final meeting or at a time the President and 28Speaker designate.
- 29 (12) The Legislative Administrator may employ persons necessary for the performance

1 of the functions of the task force. The Legislative Administrator shall fix the duties and

2 amounts of compensation of these employees. The task force shall use the services of con-

tinuing legislative staff, without employing additional persons, to the greatest extent practi cable.

5 (13) All agencies of state government, as defined in ORS 174.111, are directed to assist

6 the task force in the performance of the duties of the task force and, to the extent permitted

7 by laws relating to confidentiality, to furnish the information and advice the members of the

8 task force consider necessary to perform their duties.

9 <u>SECTION 2.</u> Section 1 of this 2017 Act is repealed on December 31, 2018.

10 <u>SECTION 3.</u> This 2017 Act being necessary for the immediate preservation of the public 11 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect 12 on its passage.
