### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates references to federal education law to reflect passage of Every Student Succeeds Act. Aligns provisions related to modified diplomas and students in foster care with federal law.

Declares emergency, effective July 1, 2017.

### A BILL FOR AN ACT

2 Relating to federal education law; creating new provisions; amending ORS 279A.050, 326.575, 327.026,  
3 329.105, 329.115, 329.451, 329.485, 338.120, 339.030, 339.115, 339.133, 339.134, 340.005, 344.075,  
4 352.287, 673.625, 676.815, 687.420 and 807.066 and section 2, chapter 109, Oregon Laws 2016; and  
5 declaring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 279A.050 is amended to read:

8 279A.050. (1)(a) Except as otherwise provided in the Public Contracting Code, a contracting  
9 agency shall exercise all of the contracting agency's procurement authority in accordance with the  
10 provisions of the Public Contracting Code.

11 (b) If a contracting agency has authority under this section to carry out functions described in  
12 this section, or has authority to make procurements under a provision of law other than the Public  
13 Contracting Code, the contracting agency need not exercise the contracting agency's authority in  
14 accordance with the provisions of the code if, under ORS 279A.025, the code does not apply to the  
15 contract or contracting agency.

16 (2)(a) Except as otherwise provided in paragraph (b) of this subsection and the Public Con-  
17 tracting Code, for state agencies the Director of the Oregon Department of Administrative Services  
18 has all the authority available to carry out the provisions of the Public Contracting Code.

19 (b) Except as otherwise provided in the Public Contracting Code, for state agencies the director  
20 may delegate to the State Chief Information Officer the authority to procure or supervise the pro-  
21 curement of all goods, services and personal services related to information technology and tele-  
22 communications for state contracting agencies. This paragraph does not apply to contracts under  
23 which the contractor delivers to the state agency information technology products or services inci-  
24 dentally in performing a personal services contract described in ORS chapter 279C or a construction  
25 contract described in ORS chapter 279C.

1 (3) Except as otherwise provided in the Public Contracting Code, the Director of Transportation  
2 has all the authority available to:

3 (a) Procure or supervise the procurement of all services and personal services to construct, ac-  
4 quire, plan, design, maintain and operate passenger terminal facilities and motor vehicle parking  
5 facilities in connection with any public transportation system in accordance with ORS 184.689 (5);

6 (b) Procure or supervise the procurement of all goods, services, public improvements and per-  
7 sonal services that relate to operating, maintaining or constructing highways, bridges and other  
8 transportation facilities that are subject to the authority of the Department of Transportation; and

9 (c) Establish standards for, prescribe forms for and conduct the prequalification of prospective  
10 bidders on public improvement contracts that relate to operating, maintaining or constructing  
11 highways, bridges and other transportation facilities that are subject to the authority of the De-  
12 partment of Transportation.

13 (4) Except as otherwise provided in the Public Contracting Code, the Secretary of State has all  
14 the authority to procure or supervise the procurement of goods, services and personal services re-  
15 lated to programs under the authority of the Secretary of State.

16 (5) Except as otherwise provided in the Public Contracting Code, the State Treasurer has all the  
17 authority to procure or supervise the procurement of goods, services and personal services related  
18 to programs under the authority of the State Treasurer.

19 (6) The state agencies listed in this subsection have all the authority to do the following in ac-  
20 cordance with the Public Contracting Code:

21 (a) The Department of Human Services to procure or supervise the procurement of goods, ser-  
22 vices and personal services under ORS 179.040 for the department's institutions and the procurement  
23 of goods, services and personal services for constructing, demolishing, exchanging, maintaining, op-  
24 erating and equipping housing for the purpose of providing care to individuals with intellectual  
25 disabilities or other developmental disabilities, subject to applicable provisions of ORS 427.335;

26 (b) The Oregon Health Authority to procure or supervise the procurement of goods, services and  
27 personal services under ORS 179.040 and construction materials, equipment and supplies for the  
28 authority's institutions and the procurement of goods, services, personal services, construction ma-  
29 terials, equipment and supplies for constructing, demolishing, exchanging, maintaining, operating  
30 and equipping housing for individuals with chronic mental illness, subject to applicable provisions  
31 of ORS 426.504;

32 (c) The State Department of Fish and Wildlife to procure or supervise the procurement of con-  
33 struction materials, equipment, supplies, services and personal services for public improvements,  
34 public works or ordinary construction described in ORS 279C.320 that is subject to the authority  
35 of the State Department of Fish and Wildlife;

36 (d) The State Parks and Recreation Department to procure or supervise the procurement of all  
37 goods, services, public improvements and personal services related to state parks;

38 (e) The Oregon Department of Aviation to procure or supervise the procurement of construction  
39 materials, equipment, supplies, services and personal services for public improvements, public works  
40 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon  
41 Department of Aviation;

42 (f) The Oregon Business Development Department to procure or supervise the procurement of  
43 all goods, services, personal services and public improvements related to its foreign trade offices  
44 operating outside the state;

45 (g) The Housing and Community Services Department to procure or supervise the procurement

1 of goods, services and personal services as provided in ORS 279A.025 (2)(o);

2 (h) The Department of Corrections to procure or supervise the procurement of construction  
3 materials, equipment, supplies, services and personal services for public improvements, public works  
4 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Depart-  
5 ment of Corrections;

6 (i) The Department of Corrections, subject to any applicable provisions of ORS 279A.120,  
7 279A.125, 279A.145 and 283.110 to 283.395, to procure or supervise the procurement of goods, ser-  
8 vices and personal services under ORS 179.040 for its institutions;

9 (j) The Department of Veterans' Affairs to procure or supervise the procurement of real estate  
10 broker and principal real estate broker services related to programs under the department's au-  
11 thority;

12 (k) The Oregon Military Department to procure or supervise the procurement of construction  
13 materials, equipment, supplies, services and personal services for public improvements, public works  
14 or ordinary construction described in ORS 279C.320 that is subject to the authority of the Oregon  
15 Military Department;

16 (L) The Department of Education, subject to any applicable provisions of ORS 329.075, 329.085  
17 and 329.485 and the federal [*No Child Left Behind Act of 2001 (P.L. 107-110, 115 Stat. 1425)*] **Every**  
18 **Student Succeeds Act (P.L. 114-95, 129 Stat. 1802)**, to procure or supervise the procurement of  
19 goods, services, personal services and information technology related to student assessment; and

20 (m) Any state agency to conduct a procurement when the agency is specifically authorized by  
21 any provision of law other than the Public Contracting Code to enter into a contract.

22 (7)(a) Notwithstanding this section and ORS 279A.140 (1), the Director of the Oregon Depart-  
23 ment of Administrative Services has exclusive authority, unless the director delegates the authority,  
24 to procure or supervise the procurement of all price agreements on behalf of the state agencies  
25 identified in subsection (6) of this section under which more than one state agency may order goods,  
26 services or personal services.

27 (b) The director may delegate to the State Chief Information Officer the exclusive authority to  
28 procure or supervise the procurement of all price agreements related to information technology and  
29 telecommunications on behalf of the state agencies identified in subsection (6) of this section.  
30 Notwithstanding any authority that a state agency may have under subsection (3) or (6) of this  
31 section, the state agency may not establish a price agreement or enter into a contract for goods,  
32 services or personal services without the approval of the director or the State Chief Information  
33 Officer if the director or the State Chief Information Officer has established a price agreement for  
34 the goods, services or personal services.

35 (c) The State Chief Information Officer may review any solicitation document for procuring in-  
36 formation technology or telecommunications that a state agency intends to issue before the state  
37 agency issues the solicitation document and may require the state agency to name the State Chief  
38 Information Officer as a third-party beneficiary with full authority to enforce the terms and condi-  
39 tions of any public contract for information technology or telecommunications. The State Chief In-  
40 formation Officer must approve a state agency's procurement for information technology or  
41 telecommunications if the procurement has an anticipated contract price of \$1 million or more. The  
42 State Chief Information Officer may require the state agency to name the State Chief Information  
43 Officer as the contracting party on behalf of the State of Oregon in a procurement for information  
44 technology or telecommunications that has an anticipated contract price of \$1 million or more.

45 **SECTION 2.** ORS 329.105 is amended to read:

1 329.105. (1) The Superintendent of Public Instruction shall collect data and produce annual  
2 school district and school performance reports to provide information to parents and to improve  
3 schools.

4 (2) The superintendent shall include in the school district and school performance reports data  
5 for the following areas, for each school or district, that are available to the Department of Educa-  
6 tion from the most recent school year:

7 (a) Data required by the federal [*No Child Left Behind Act of 2001 (P.L. 107-110, 115 Stat.*  
8 *1425)*] **Every Student Succeeds Act (P.L. 114-95, 129 Stat. 1802)**;

9 (b) Information about how to access the website that is maintained by the State Department of  
10 Geology and Mineral Industries as provided by ORS 516.030 (6)(b);

11 (c) Information related to the number of children served in the district and the number of chil-  
12 dren who are susceptible to restrictable disease, as reported under ORS 433.269 (2)(a); and

13 (d) Any other data identified by the Department of Education as required by federal law to be  
14 in the reports.

15 (3) In addition to the data required by subsection (2) of this section, the superintendent may  
16 include other data on the school district and school performance reports.

17 (4) The department shall work with stakeholders to:

18 (a) Design and implement an accountability system of progressive interventions for schools and  
19 school districts that do not demonstrate improvement; and

20 (b) Provide technical assistance to schools and school districts that do not demonstrate im-  
21 provement.

22 **SECTION 3.** ORS 329.115 is amended to read:

23 329.115. (1) Prior to December 1 of each year, the Superintendent of Public Instruction shall is-  
24 sue an Oregon Report Card on the state of the public schools of this state.

25 (2) The Oregon Report Card shall include information on the following:

26 (a) Data required by the federal [*No Child Left Behind Act of 2001 (P.L. 107-110, 115 Stat.*  
27 *1425)*] **Every Student Succeeds Act (P.L. 114-95, 129 Stat. 1802)**; and

28 (b) Any other data identified by the Department of Education as required by federal law.

29 (3) In addition to the information required under subsection (2) of this section, the superinten-  
30 dent may include other information in the Oregon Report Card.

31 **SECTION 4.** ORS 338.120 is amended to read:

32 338.120. (1) In addition to any other requirements of this chapter for a public charter school, a  
33 virtual public charter school must have:

34 (a) A plan for academic achievement that addresses how the school will improve student learn-  
35 ing and meet academic content standards required by ORS 329.045.

36 (b) Performance criteria the school will use to measure the progress of the school in meeting  
37 the academic performance goals set by the school for its first five years of operation.

38 (c) A plan for implementing the proposed education program of the school by directly and sig-  
39 nificantly involving parents and guardians of students enrolled in the school and involving the pro-  
40 fessional employees of the school.

41 (d) A budget, business plan and governance plan for the operation of the school.

42 (e) In the charter of the school, a requirement that the school:

43 (A) Monitor and track student progress and attendance; and

44 (B) Provide student assessments in a manner that ensures that an individual student is being  
45 assessed and that the assessment is valid.

1 (f) Notwithstanding ORS 338.135 (7), a plan to ensure that:

2 (A) All superintendents, assistant superintendents and principals of the school are licensed to  
3 administer by the Teacher Standards and Practices Commission; and

4 (B) Teachers who are licensed to teach by the Teacher Standards and Practices Commission  
5 [*and who are highly qualified as described in the federal No Child Left Behind Act of 2001 (P.L.*  
6 *107-110, 115 Stat. 1425)*] teach at least 95 percent of the school's instructional hours.

7 (g) A plan for maintaining student records and school records, including financial records, at a  
8 designated central office of operations that is located:

9 (A) If the sponsor is a school district, within the school district that is the sponsor and as  
10 specified in the charter of the school; or

11 (B) If the sponsor is the State Board of Education, at a central office located in Oregon and as  
12 specified in the charter of the school.

13 (h) A plan to provide equitable access to the education program of the school by ensuring that  
14 each student enrolled in the school:

15 (A) Has access to and use of computer and printer equipment as needed;

16 (B) Is offered an Internet service cost reimbursement arrangement under which the school re-  
17 imbursees the parent or guardian of the student, at a rate set by the school, for the costs of obtaining  
18 Internet service at the minimum connection speed required to effectively access the education pro-  
19 gram provided by the school; or

20 (C) Has access to and use of computer and printer equipment and is offered Internet service cost  
21 reimbursement.

22 (i) A plan to provide access to computer and printer equipment and the Internet service cost  
23 reimbursement as described in paragraph (h) of this subsection by students enrolled in the school  
24 who are from families that qualify as low-income under Title I of the federal Elementary and Sec-  
25 ondary Education Act of 1965 (20 U.S.C. 6301 et seq.).

26 (j) A plan to conduct school-sponsored optional educational events at least six times each school  
27 year at locations selected to provide convenient access to all students enrolled in the school who  
28 want to participate.

29 (k) A plan to conduct meetings at least twice a week between teachers and students enrolled  
30 in the school, either in person or through the use of conference calls or other technology.

31 (L) A plan to provide opportunities for face-to-face meetings between teachers and students en-  
32 rolled in the school at least six times each school year.

33 (m) A plan to provide, at the time of a student's enrollment, written notice to the sponsor and,  
34 if different, to the school district where the student is a resident. Notification must be provided  
35 within 10 days after enrollment and must include:

36 (A) The name, age and address of the student; and

37 (B) The name of the school in which the student was formerly enrolled.

38 (n) A plan to provide, at the time of a student's withdrawal for a reason other than graduation  
39 from high school, written notice to the sponsor and, if different, to the school district where the  
40 student is a resident. Notification must be provided within 10 days after withdrawal and must in-  
41 clude:

42 (A) The name, age and address of the student;

43 (B) The reason the student no longer is enrolled and, if applicable, the name of the school in  
44 which the student will enroll, if known to the virtual public charter school; and

45 (C) The last day on which the student was enrolled at the virtual public charter school.

1 (o) An agreement to provide a student's education records to the student's resident school dis-  
2 trict or to the sponsor, upon request of the resident school district or sponsor.

3 (2) For a virtual public charter school:

4 (a) A person who is a member of the school district board for the sponsor of the virtual public  
5 charter school may not be:

6 (A) An employee of the virtual public charter school;

7 (B) A member of the governing body of the virtual public charter school; or

8 (C) An employee or other representative of any third-party entity with which the virtual public  
9 charter school has entered into a contract to provide educational services.

10 (b) A person who is a member of the governing body of the virtual public charter school may  
11 not be an employee of a third-party entity with which the virtual public charter school has entered,  
12 or intends to enter, into a contract to provide educational services.

13 (3) If a virtual public charter school enters into a contract with a third-party entity to provide  
14 educational services for the virtual public charter school:

15 (a) No employee or member of the governing board of the third-party entity may attend an  
16 executive session of the school district board of the school district that is the sponsor of the virtual  
17 public charter school;

18 (b) An employee of the virtual public charter school may not promote the sale or benefits of  
19 private supplemental services or classes offered by the third-party entity;

20 (c) The educational services provided by the third-party entity must be consistent with state  
21 standards and requirements, and must be changed on the same timelines that changes are imposed  
22 on the nonvirtual public charter schools of this state; and

23 (d) The virtual public charter school must have on file the third-party entity's budget for the  
24 provision of educational services and that budget must itemize:

25 (A) The salaries of supervisory and management personnel and consultants who are providing  
26 educational or related services for a public charter school in this state; and

27 (B) The annual operating expenses and profit margin of the third-party entity for providing ed-  
28 ucational services to a public charter school in this state.

29 (4)(a) The sponsor or a member of the public may request access to any of the documents de-  
30 scribed in subsections (1) and (3)(d) of this section that are public records, as provided by ORS  
31 192.410 to 192.505.

32 (b) Upon request by a sponsor or a member of the public, a virtual public charter school must  
33 provide reasonable access to the documents described in subsections (1) and (3)(d) of this section  
34 that are public records, as provided by ORS 192.410 to 192.505. The documents may be provided  
35 electronically.

36 **SECTION 5.** ORS 327.026 is amended to read:

37 327.026. (1) In order to accomplish the purpose described in ORS 326.700, the State Board of  
38 Education shall adopt by rule definitions and procedures to be applied to the computation of the  
39 State School Fund allocations where necessary to make students enrolled in the Youth Corrections  
40 Education Program, as defined in ORS 326.695, and the Juvenile Detention Education Program, as  
41 defined in ORS 326.695, equivalent to students enrolled in common and union high school districts  
42 for purposes of distribution of the fund.

43 (2)(a) The Youth Corrections Education Program shall receive from the State School Fund for  
44 each school year a special State School Fund grant, consisting of a general purpose grant that is  
45 equal to the Youth Corrections Education Program extended ADMw multiplied by Funding Per-

1 centage and further multiplied by Statewide Target per ADMw Grant. For the purpose of the cal-  
2 culation made under this paragraph:

3 (A) ADMw equals ADM multiplied by 2.0 multiplied by the additional per student weight, as  
4 calculated in ORS 327.013 (1)(c)(A)(i).

5 (B) Extended ADMw equals ADMw or ADMw of the prior year, whichever is greater.

6 (b) Notwithstanding paragraph (a) of this subsection, the Youth Corrections Education Program  
7 may not receive moneys under this section from the State School Fund for any youth in the program  
8 who:

9 (A) Has received a high school diploma **or a modified diploma**; or

10 (B) Is 21 years of age or older.

11 (3) The Juvenile Detention Education Program shall receive from the State School Fund for each  
12 school year a special State School Fund grant, consisting of a general purpose grant that is equal  
13 to the Juvenile Detention Education Program extended ADMw multiplied by Funding Percentage  
14 and further multiplied by Statewide Target per ADMw Grant. For the purpose of the calculation  
15 made under this subsection:

16 (a) ADMw equals ADM multiplied by 1.5.

17 (b) Extended ADMw equals ADMw or ADMw of the prior year, whichever is greater.

18 (4) Funds allocated to the Youth Corrections Education Program and the Juvenile Detention  
19 Education Program from the State School Fund shall remain with the Department of Education and  
20 shall be adjusted in the year following the distribution to reflect the actual ADMw of students in  
21 the Youth Corrections Education Program and the Juvenile Detention Education Program in the  
22 same manner as for the school districts under ORS 327.101.

23 **SECTION 6.** ORS 329.451 is amended to read:

24 329.451. (1)(a) At or before grade 12, a school district or public charter school shall award a high  
25 school diploma to a student who completes the requirements established by subsection (2) of this  
26 section.

27 (b) A school district or public charter school shall award a modified diploma to a student who  
28 satisfies the requirements established by subsection (7) of this section, an extended diploma to a  
29 student who satisfies the requirements established by subsection (8) of this section or an alternative  
30 certificate to a student who satisfies the requirements established by subsection (9) of this section.

31 (c) A school district or public charter school may not deny a student who has the documented  
32 history described in subsection (7)(b) or (8)(b) of this section the opportunity to pursue a diploma  
33 with more stringent requirements than a modified diploma or an extended diploma for the sole rea-  
34 son that the student has the documented history.

35 (d) A school district or public charter school may award a modified diploma or extended diploma  
36 to a student only upon receiving consent as provided by subsection (6) of this section.

37 (2)(a) In order to receive a high school diploma from a school district or public charter school,  
38 a student must satisfy the requirements established by the State Board of Education and the school  
39 district or public charter school and, while in grades 9 through 12, must complete at least:

40 (A) Twenty-four total credits;

41 (B) Three credits of mathematics; and

42 (C) Four credits of English.

43 (b) If a school district or public charter school requires a student to complete more than 24 total  
44 credits, as provided by paragraph (a)(A) of this subsection, the school district or public charter  
45 school may only require the student to complete additional credits for:

1 (A) Subjects for which the State Board of Education has established academic content standards  
2 under ORS 329.045;

3 (B) Courses provided as part of a career and technical education program; or

4 (C) Courses that provide, or qualify to provide, credit at post-secondary institutions of education.

5 (3) A student providing work samples to demonstrate proficiency in Essential Learning Skills  
6 as may be required under subsection (2) of this section must be allowed to use accommodations de-  
7 scribed in the student's individualized education program or the student's plan developed in ac-  
8 cordance with section 504 of the Rehabilitation Act of 1978, 29 U.S.C. 794. As used in this  
9 subsection, the term "accommodations":

10 (a) Includes, but is not limited to:

11 (A) Additional time to demonstrate proficiency.

12 (B) The ability to demonstrate proficiency in an alternative location that is secure and  
13 proctored.

14 (C) The use of text-to-speech or speech-to-text technology or other assistive technology.

15 (b) Does not include modifications that lower the proficiency standards or that are used solely  
16 to earn modified credit.

17 (4) A student may satisfy the requirements of subsection (2) of this section in less than four  
18 years. If a student satisfies the requirements of subsection (2) of this section and a school district  
19 or public charter school has received consent as provided by subsection (6) of this section, the  
20 school district or public charter school shall award a high school diploma to the student.

21 (5) If a school district or public charter school has received consent as provided by subsection  
22 (6) of this section, the school district or public charter school may advance the student to the next  
23 grade level if the student has satisfied the requirements for the student's current grade level.

24 (6)(a) For the purpose of receiving consent as provided by subsections (1)(d), (4) and (5) of this  
25 section, consent shall be provided by:

26 (A) The parent or guardian of the student, if the student:

27 (i) Is under 18 years of age and is not emancipated pursuant to ORS 419B.550 to 419B.558; or

28 (ii) Has been determined not to have the ability to give informed consent regarding the student's  
29 education pursuant to a protective proceeding under ORS chapter 125; or

30 (B) The student, if the student is 18 years of age or older or is emancipated pursuant to ORS  
31 419B.550 to 419B.558.

32 (b) For the purpose of awarding a modified diploma or extended diploma as provided by sub-  
33 section (1)(d) of this section or of awarding a high school diploma as provided by subsection (4) of  
34 this section, consent must be received during the school year for which the diploma will be awarded.

35 (7) A school district or public charter school shall award a modified diploma only to students  
36 who have demonstrated the inability to meet the full set of academic content standards for a high  
37 school diploma with reasonable modifications and accommodations. To be eligible for a modified di-  
38 ploma, a student must:

39 (a) Satisfy the requirements for a modified diploma established by the State Board of Education;  
40 and

41 (b) Have a documented history of an inability to maintain grade level achievement due to sig-  
42 nificant learning and instructional barriers or have a documented history of a medical condition that  
43 creates a barrier to achievement.

44 (8) A school district or public charter school shall award an extended diploma only to students  
45 who have demonstrated the inability to meet the full set of academic content standards for a high



1 school diploma with reasonable modifications and accommodations. To be eligible for an extended  
2 diploma, a student must:

3 (a) While in grade nine through completion of high school, complete 12 credits, which may not  
4 include more than six credits earned in a self-contained special education classroom and shall in-  
5 clude:

- 6 (A) Two credits of mathematics;
- 7 (B) Two credits of English;
- 8 (C) Two credits of science;
- 9 (D) Three credits of history, geography, economics or civics;
- 10 (E) One credit of health;
- 11 (F) One credit of physical education; and
- 12 (G) One credit of the arts or a world language; and

13 (b) Have a documented history of:

14 (A) An inability to maintain grade level achievement due to significant learning and instruc-  
15 tional barriers;

16 (B) A medical condition that creates a barrier to achievement; or

17 (C) A change in the student's ability to participate in grade level activities as a result of a se-  
18 rious illness or injury that occurred after grade eight.

19 (9) A school district or public charter school shall award an alternative certificate to a student  
20 who does not satisfy the requirements for a high school diploma, a modified diploma or an extended  
21 diploma if the student meets requirements established by the board of the school district or public  
22 charter school.

23 (10) A student shall have the opportunity to satisfy the requirements of subsection (7), (8) or (9)  
24 of this section by the later of:

25 (a) Four years after starting grade nine; or

26 (b) The student reaching the age of 21 years, if the student is entitled to a public education until

28 (11)(a) A student may satisfy the requirements described in subsection (7), (8) or (9) of this sec-  
29 tion in less than four years if consent is provided in the manner described in subsection (6)(a) of this

31 (b) The consent provided under this subsection must be written and must clearly state that the  
32 parent, guardian or student is waiving the time allowed under subsection (10) of this section. A  
33 consent may not be used to allow a student to satisfy the requirements of subsection (7), (8) or (9)  
34 of this section in less than three years.

35 (c) A copy of all consents provided under this subsection for students in a school district must  
36 be forwarded to the district superintendent.

37 (d) Each school district must provide to the Superintendent of Public Instruction information  
38 about the number of consents provided during a school year.

39 (12)(a) A student who **qualifies to receive or** receives a modified diploma, an extended diploma  
40 or an alternative certificate shall:

41 (A) Have the option of participating in a high school graduation ceremony with the class of the  
42 student; and

43 (B) Have access to instructional hours, hours of transition services and hours of other services  
44 that are designed to:

45 (i) Meet the unique needs of the student; and

1 (ii) When added together, provide a total number of hours of instruction and services to the  
2 student that equals at least the total number of instructional hours that is required to be provided

4 (b)(A) The number of instructional hours, hours of transition services and hours of other ser-  
5 vices that are appropriate for a student shall be determined by the student's individualized education

8 struction and services to which the student has access under paragraph (a)(B) of this subsection.

9 (B) A school district may not unilaterally decrease the total number of hours of instruction and  
10 services to which the student has access under paragraph (a)(B) of this subsection, regardless of the  
11 age of the student.

12 (c) If a student's individualized education program team decides that the student will not access  
13 the total number of hours of instruction and services to which the student has access under para-  
14 graph (a)(B) of this subsection, the school district shall annually:

15 (A) Provide the following information in writing to the parent or guardian of the student:

16 (i) The school district's duty to comply with the requirements of paragraph (a)(B) of this sub-

18 (ii) The prohibition against a school district's unilaterally decreasing the total number of hours

41 **(C) The individual has had the same legal residence and has continuously been enrolled in a**  
42 **school in the district since the boundary change.**

43 *[(6) As used in this section:]*

44 *[(a)(A) "Person in parental relationship" means an adult who has physical custody of an individual*  
45 *or resides in the same household as the individual, interacts with the individual daily, provides the*

1 *individual with food, clothing, shelter and incidental necessities and provides the individual with*  
2 *necessary care, education and discipline.]*

3 [(B) “Person in parental relationship” does not mean a person with a power of attorney or other  
4 written delegation of parental responsibilities if the person does not have other evidence of a parental  
5 relationship.]

6 [(b) “Substitute care program” means family foster care, family group home care, parole foster care,  
7 family shelter care, adolescent shelter care and professional group care.]

8 **SECTION 20. The amendments to ORS 339.133 by sections 17 to 19 of this 2017 Act first**  
9 **apply to the 2017-2018 school year.**

10 **SECTION 21.** ORS 326.575 is amended to read:

11 326.575. (1) Within 10 days of a student’s seeking initial enrollment in a public or private school  
12 or when a student is placed in a state institution, other than an institution of post-secondary edu-  
13 cation, or a day treatment program, residential treatment program, detention facility or youth care  
14 center, the school, institution, program, facility or center shall notify the public or private school  
15 or the institution, program, facility or center in which the student was formerly enrolled and shall  
16 request the student’s education records.

17 (2) Any public or private school, state institution, day treatment program, residential treatment  
18 program, detention facility or youth care center receiving the request described in subsection (1)  
19 of this section shall transfer all student education records relating to the particular student to the  
20 requesting school, institution, program, facility or center no later than 10 days after the receipt of  
21 the request. The education records shall include any education records relating to the particular  
22 student retained by an education service district.

23 (3) Notwithstanding subsections (1) and (2) of this section, for students who are in substitute  
24 care programs:

25 (a) A school, institution, program, facility or center shall notify the school, institution, program,  
26 facility or center in which the student was formerly enrolled and shall request the student’s educa-

3       (f) “Youth care center” means a center as defined in ORS 420.855.

4       **SECTION 22.** ORS 329.485 is amended to read:

5       329.485. (1) As used in this section:

6       (a) “Content-based assessment” means testing of the understanding of a student of a predeter-  
7 mined body of knowledge.

8       (b) “Criterion-referenced assessment” means testing of the knowledge or ability of a student with  
9 respect to some standard.

10       (c) “Performance-based assessment” means testing of the ability of a student to use knowledge  
11 and skills to create a complex or multifaceted product or complete a complex task.

12       (2)(a) The Department of Education shall implement statewide a valid and reliable assessment  
13 system for all students that meets technical adequacy standards. The assessment system shall in-  
14 clude criterion-referenced assessments including performance-based assessments, content-based as-  
15 sessments, and other valid methods to measure the academic content standards and to identify  
16 students who meet or exceed the standards.

17       (b) The department shall develop the statewide assessment system in mathematics, science,  
18 English, history, geography, economics and civics.

19       (3) In addition to the assessment system implemented under subsection (2) of this section, the  
20 department may make available to school districts and public charter schools an assessment system  
21 that uses criterion-referenced assessments, including performance-based assessments and content-  
22 based assessments to:

23       (a) Measure a student’s progress toward mastery of the knowledge and skills of the student’s  
24 current grade level or course content level;

25       (b) Determine the student’s level of mastery, which shall be determined regardless of the actual  
26 grade level of the student and may be determined by adapting the assessment during the assessment  
27 process as a result of the performance of the student;

28       (c) Track and provide reports on the progress of a student based on the information provided

30       (d) Provide predictions of anticipated student progress that are based on the information pro-

32       (4)(a) School districts and public charter schools shall implement the statewide assessment sys-  
33 tem in mathematics, science and English. In addition, school districts and public charter schools  
34 may implement the statewide assessment system in history, geography, economics and civics.

35       (b) School districts and public charter schools may choose to implement the assessment system  
36 described in subsection (3) of this section.

37       (5)(a) Each year the resident school district shall be accountable for determining the student’s  
38 progress toward achieving the academic content standards. Progress toward the academic content

6 exceeding the academic content standards. No more than three indicators of academic knowledge  
7 and skills per content area reporting category shall be required as provided by this section. A  
8 school district may use more than three indicators of academic knowledge and skills per content  
9 area reporting category if the school district implements a proficiency education system as provided  
10 by ORS 329.119.

11 (6) In addition to the requirements described in subsection (5) of this section, the school district  
12 shall adopt and implement a reporting system based on the school district board adopted course  
13 content of the school district's curriculum. The reporting system:

14 (a) Shall clearly show the student and parents whether the student is achieving course require-  
15 ments at the student's current grade level or course content level;

16 (b) Shall be based on the student's progress toward mastery of a continuum of academic knowl-  
17 edge and skills; and

18 (c) May be based on the student's progress in a continuum of knowledge and skills that are not  
19 academic and that may include student behaviors that are defined by the school district.

20 (7) If a student has not met or has exceeded all of the academic content standards, the school  
21 district shall make additional services or alternative educational or public school options available  
22 to the student.

23 (8) If the student to whom additional services or alternative educational options have been made  
24 available does not meet or exceed the academic content standards within one year, the school dis-  
25 trict, with the consent of the parents, shall make an appropriate placement, which may include an  
26 alternative education program or the transfer of the student to another public school in the school

34 339.134. (1) Notwithstanding ORS 339.133 [(3)] (4), a child with a disability shall be considered  
35 a resident for school purposes in the school district in which the child's parent or guardian resides  
36 if:

37 (a) The child is voluntarily placed outside the child's home by the child's parent or guardian;

38 (b) The child's parent or guardian retains legal guardianship of the child;

39 (c) There is a plan for the child to return home;

40 (d) The placement is within 20 miles by the nearest traveled road from the original school  
41 building, unless there are physiographic conditions that make transportation to the original school  
42 building not feasible; and

43 (e) The child's parent or guardian and the school staff can demonstrate that it is in the best  
44 interest of the child to continue to attend the school the child was attending prior to the placement.  
45 The best interest of the child may be demonstrated by factors, including but not limited to the fol-

3           (B) A change in the child's routine would be detrimental to the child; or

4           (C) The child has developed and maintained a network of personal contacts, support services

8           (3) Nothing in this section shall affect the ability of school districts to enter into agreements  
9 with other school districts for the transportation of students.

10           **SECTION 24. This 2017 Act being necessary for the immediate preservation of the public**  
11 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**  
12 **July 1, 2017.**
