

Senate Bill 220

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Education)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Governor to appoint Deputy Superintendent of Public Instruction from among recommendations submitted to Governor by State Board of Education. Directs Governor to designate duties to deputy superintendent after consideration of recommendations made by State Board of Education.

2 Relating to the administration of the Department of Education; creating new provisions; and

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 326.300 is amended to read:

6 326.300. (1) As provided by section 1, Article VIII of the Oregon Constitution, the Governor is
7 the Superintendent of Public Instruction.

8 (2)(a) The Governor, acting as Superintendent of Public Instruction, shall appoint a Deputy Su-
9 perintendent of Public Instruction **from among recommendations submitted to the Governor**
10 **by the State Board of Education**. The deputy superintendent must have at least five years of ex-
11 perience in the administration of an elementary school or a secondary school. The appointment of
12 the deputy superintendent shall be subject to confirmation by the Senate as provided by ORS 171.562
13 and 171.565.

14 (b) The deputy superintendent shall:

15 (A) Perform any act or duty of the office of Superintendent of Public Instruction that is desig-
16 nated by the Governor[, *and*] **after consideration of recommendations made by the State Board**
17 **of Education**. The Governor is responsible for any acts of the deputy superintendent.

18 (B) Coordinate with the Chief Education Officer as provided by section 2, chapter 519, Oregon
19 Laws 2011.

20 (3) The deputy superintendent may be removed from office by the Governor following consulta-
21 tion with the State Board of Education.

22 (4) The deputy superintendent shall receive a salary set by the Governor, and shall be reim-
23 bursed for all expenses actually and necessarily incurred by the deputy superintendent in the per-
24 formance of official duties.

25 **SECTION 2.** ORS 326.300, as amended by section 43, chapter 774, Oregon Laws 2015, is
26 amended to read:

15 **SECTION 3. The amendments to ORS 326.300 by sections 1 and 2 of this 2017 Act apply**
 16 **to appointments for Deputy Superintendent of Public Instruction made on or after the ef-**
 17 **fective date of this 2017 Act.**
