SENATE AMENDMENTS TO SENATE BILL 256

On page 1 of the printed corrected bill, after line 2, insert: 1 $\mathbf{2}$ "Whereas the Willamette Falls Navigation Canal and Locks were opened in 1873; and 3 "Whereas the navigation canal and locks are a primary historic asset in the Willamette Falls State Heritage Area; and 4 $\mathbf{5}$ "Whereas the United States Army Corps of Engineers purchased the navigation canal and locks 6 in 1915 to ensure free public passage through the navigation canal and locks; and 7 "Whereas in 2011 the United States Army Corps of Engineers placed the navigation canal and locks into nonoperational status; and 8 9 "Whereas in May 2017 the United States Army Corps of Engineers issued a draft disposition 10 study stating an intent to divest federal ownership of the navigation canal and locks; and 11 "Whereas the navigation canal and locks offer opportunities for economic development, recre-12ation, transportation and cultural enrichment for the people of this state; and 13 "Whereas the navigation canal and locks provide a transportation route in the event of a na-14 tural disaster; and 15"Whereas Columbia River tribes have usual and accustomed claims to use the Willamette Falls 16 area; and 17 "Whereas the Confederated Tribes of the Grand Ronde Community of Oregon have historical 18 claims through treaty to the Willamette Falls area; and 19 "Whereas the Confederated Tribes of the Grand Ronde Community of Oregon, Metro, Clackamas 20 County, Marion County, Multnomah County, Linn County, Polk County and the cities of Eugene, 21Milwaukie, Portland, Oregon City, Salem, West Linn and Wilsonville have each adopted resolutions 22in support of the repair and reopening of the navigation canal and locks; now, therefore,". 23 Delete lines 4 through 24 and delete pages 2 through 4 and insert: 24 "SECTION 1. (1) There is established the Willamette Falls Locks Commission for the 25purposes described in section 2 of this 2017 Act, consisting of 23 members appointed as follows: 26"(a) The Governor shall appoint: 2728"(A) One member who is the chair or a member of the Clackamas County Board of 29County Commissioners, pursuant to a recommendation of the board; "(B) One member who is the chair or a member of the Marion County Board of County 30 31 Commissioners, pursuant to a recommendation of the board; 32"(C) One member who is the chair or a member of the Yamhill County Board of County 33 Commissioners, pursuant to a recommendation of the board; 34 "(D) One member who is the president or a member of the governing body of the met-35ropolitan service district for the Portland metropolitan area, pursuant to a recommendation 1 from the governing body;

"(E) One member who is a representative of the Confederated Tribes of the Grand Ronde
 Community of Oregon, pursuant to a recommendation of the tribal council;

4 "(F) One member who is a representative of a Columbia River tribe that is a party to the 5 terms of a treaty of 1855 between the tribe and the United States of America;

6 "(G) One member who is a representative of the State Parks and Recreation Department;

7 "(H) One member who is a representative of the Port of Portland;

"(I) One member who is a representative of the Department of Transportation;

- 9 "(J) One member who is a representative of the Oregon Business Development Depart 10 ment;
- "(K) Pursuant to a recommendation by that city's governing body, one member who is the mayor or a member of the governing body of each of the following cities, to represent the cities' interests in the Willamette Falls navigation canal and locks:
- 14 "(i) The City of Oregon City;
- 15 "(ii) The City of West Linn; and

16 "(iii) The City of Wilsonville;

"(L) One member to represent the collective interests of local businesses and economic
development in Clackamas County, pursuant to a recommendation of the Clackamas County
Board of County Commissioners;

"(M) One member to represent the collective interests of the tourism and recreation in dustries in Clackamas County, pursuant to a recommendation by the Clackamas County
 Board of County Commissioners;

23 "(N) One member to represent the residents of Clackamas County, pursuant to a rec-24 ommendation by the Clackamas County Board of County Commissions; and

25 "(0) One member to represent an environmental or ecological nonprofit organization.

26 "(b) The President of the Senate shall appoint one member from among the members of27 the Senate.

"(c) The Senate Minority Leader shall appoint one member from among the members of
 the Senate.

"(d) The Speaker of the House of Representatives shall appoint two members from among
 the members of the House of Representatives.

"(e) The House Minority Leader shall appoint two members from among the members
 of the House of Representatives.

34 "(2) The term of office of each member of the commission appointed by the Governor is 35 four years, but a member serves at the pleasure of the Governor. Before the expiration of 36 the term of a member, the Governor shall appoint a successor whose term begins on January 37 1 of the following year. A member is eligible for reappointment.

38 "(3) If there is a vacancy for any cause, the appointing authority shall make an appoint-39 ment to become immediately effective for the unexpired term.

40 "(4) Members of the commission are not entitled to compensation and may not be reim41 bursed for travel or other expenses incurred by them in the performance of their official
42 duties.

43 "(5) Members of the Legislative Assembly appointed to the commission are nonvoting
 44 members of the commission and act in an advisory capacity only.

45 "(6) The commission shall select one of its members as chairperson and another as vice

1 chairperson, for terms and with duties and powers necessary for the performance of the 2 functions of the offices as the commission determines.

3 "(7) The commission may elect an executive committee to consist of three or more 4 members. The executive committee has and may exercise all authority of the commission.

5 "(8) Official action by the commission requires the approval of a majority of the voting 6 members of the commission.

7 "(9)(a) The commission shall meet no less than six times per year at times and places 8 specified by the call of the chairperson or of a majority of the voting members of the com-9 mission. The commission shall include an opportunity for public comment as an item on the 10 agenda of at least two meetings per year.

"(b) The commission shall notify federally recognized Indian tribes and known interested
 parties of the dates and times of commission meetings.

13 "(10) ORS 192.410 to 192.505 and 192.610 to 192.690 apply to the records and meetings of 14 the commission.

"SECTION 2. (1) The Willamette Falls Locks Commission shall:

"(a) Serve as a body to advise state, local and regional government agencies on the de velopment and implementation of state policies relating to the repair, reopening, operation
 and maintenance of the Willamette Falls navigation canal and locks;

"(b) Address issues relating to the transfer of ownership, operation and financing of the
 navigation canal and locks from a state, local and regional perspective;

21 "(c) Make recommendations for, and assist in coordination of, funding responsibilities, 22 including possible recommendations for the formation of an intergovernmental agreement 23 between state, local, regional and federal agencies for the repair, reopening, operation and 24 maintenance of the navigation canal and locks;

"(d) Investigate a framework for the ownership, operations and management of the nav igation canal and locks;

"(e) Negotiate ownership, operation and management of the navigation canal and locks
with the United States Army Corps of Engineers;

29 "(f) Communicate state policies relating to the repair, reopening, operation and mainte-30 nance of the navigation canal and locks to the Oregon Congressional Delegation; and

"(g) Consider any other matters the commission considers necessary with respect to the
 ownership and operation of the navigation canal and locks.

"(2) The commission may establish advisory or technical committees as the commission considers necessary to aid and advise the commission in the performance of its functions. The committees may be continuing or temporary committees. The commission shall determine the representation, membership, terms and organization of the committees and shall appoint the members of the committees.

38 "(3) Oregon Solutions at Portland State University shall provide staffing and other re-39 sources as required by the commission to carry out the duties of the commission.

"<u>SECTION 3.</u> In addition to and not in lieu of any other appropriation, there is appropriated to the Higher Education Coordinating Commission, for the biennium beginning July
1, 2017, out of the General Fund, the amount of \$190,000, for distribution to Portland State
University for the purposes of sections 1 and 2 of this 2017 Act.

44 "SECTION 4. Sections 1 and 2 of this 2017 Act are repealed on December 31, 2023.

45 "SECTION 5. This 2017 Act being necessary for the immediate preservation of the public

- 1 peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect
- 2 on its passage.".
