SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Makes permanent] **Extends sunset for provisions making discretionary** Commissioner of Bureau of Labor and Industries' *[discretion]* **authority** to prepare formal charges and pursue certain matters in court.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to discretion of the Commissioner of the Bureau of Labor and Industries to pursue matters
3 on behalf of certain complainants; amending sections 3, 6 and 7, chapter 609, Oregon Laws 2015;
4 and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** Section 3, chapter 609, Oregon Laws 2015, is amended to read:

7 **Sec. 3.** No later than February 1, *[2017]* **2021**, the Commissioner of the Bureau of Labor and
8 Industries shall submit to the appropriate legislative committees a written report on the resolution
9 of complaints before the commissioner in the two-year period prior to *[the effective date of this 2015*
10 *Act]* **June 30, 2015**, and on the resolution of those complaints after the implementation of the
11 amendments to ORS 659A.845 and 659A.870 by sections 1 and 2 *[of this 2015 Act]*, **chapter 609,**
12 **Oregon Laws 2015.**

13 **SECTION 2.** Section 6, chapter 609, Oregon Laws 2015, is amended to read:

14 **Sec. 6.** The amendments to ORS 659A.845 and 659A.870 by sections 4 and 5 *[of this 2015 Act]*,
15 **chapter 609, Oregon Laws 2015**, become operative on October 1, *[2017]* **2021.**

16 **SECTION 3.** Section 7, chapter 609, Oregon Laws 2015, is amended to read:

17 **Sec. 7.** Section 3 *[of this 2015 Act]*, **chapter 609, Oregon Laws 2015**, is repealed on October
18 1, *[2017]* **2021.**

19 **SECTION 4.** **This 2017 Act being necessary for the immediate preservation of the public**
20 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
21 **on its passage.**
