

Senate Bill 307

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Joint Interim Committee on Marijuana Legalization)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides for regulation by Oregon Liquor Control Commission of consumption and sale of marijuana items at temporary events, including licensure of premises on which temporary events are held.

Provides for regulation by commission of consumption of marijuana items at cannabis lounges, including licensure of premises where cannabis lounges are located.

Prohibits licensing temporary events or cannabis lounges in cities or counties that have not adopted ordinances allowing for the consumption of marijuana items at temporary events or cannabis lounges.

Excepts from prohibitions on public use, including restrictions set forth in Oregon Indoor Clean Air Act, consumption of marijuana items in designated areas of premises for which temporary event or cannabis lounge license has been issued.

Applies current law regulating licensed marijuana producers, processors, wholesalers and retailers to new types of licensees. Makes certain exceptions.

Becomes operative January 1, 2018.

Takes effect on 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon:

NEW LICENSEES

(Temporary Event License)

SECTION 1. Sections 2 and 3 of this 2017 Act are added to and made a part of ORS 475B.010 to 475B.395.

SECTION 2. (1) The consumption and sale of marijuana items at a temporary event is subject to regulation by the Oregon Liquor Control Commission.

(2) To hold a temporary event for the consumption of marijuana items, a person must have a temporary event license issued by the commission for the premises at which a temporary event is held. To hold a license under this section:

- 1 **(a) The applicant:**
2 **(A) Must apply for the license in the manner described in ORS 475B.040;**
3 **(B) Must provide proof that the applicant is 21 years of age or older; and**
4 **(C) Must submit a plan to the commission, in a form and manner prescribed by the**
5 **commission, detailing how persons under 21 years of age will be prevented from gaining ac-**
6 **cess to the premises where the temporary event is to be held;**
7 **(b) The premises where the temporary event is to be held:**
8 **(A) May not be located in an area that is zoned exclusively for residential use; and**
9 **(B) May not be located within 1,000 feet of:**
10 **(i) A public elementary or secondary school for which attendance is compulsory under**
11 **ORS 339.020; or**
12 **(ii) A private or parochial elementary or secondary school, teaching children as described**
13 **in ORS 339.030 (1)(a); and**
14 **(c) The applicant and the premises where the temporary event is to be held must meet**
15 **the requirements of any rule adopted by the commission under subsection (3) of this section.**
16 **(3) The commission shall adopt rules that:**
17 **(a) Establish application and licensure fees for a license issued under this section;**
18 **(b) Establish the maximum term of a license issued under this section;**
19 **(c) Prohibit licenses issued under this section from being continuously issued for a single**
20 **location;**
21 **(d) Require marijuana items sold on a premises for which a license has been issued under**
22 **this section to be sold by a marijuana retailer that holds a license issued under ORS 475B.110;**
23 **(e) Allow the consumption of marijuana items in designated areas of a premises for which**
24 **a license has been issued under this section;**
25 **(f) Prohibit the consumption and sale of alcoholic beverages and tobacco products on a**
26 **premises for which a license has been issued under this section;**
27 **(g) Prohibit the use of video lottery games as authorized under ORS 461.217, social games**

29 **this section;**
30 **(h) Require each enclosed portion of a building for which a license has been issued under**

5 **SECTION 3. (1) The consumption of marijuana items at a cannabis lounge is subject to**
6 **regulation by the Oregon Liquor Control Commission.**

7 **(2) To provide for the communal consumption of marijuana items at a public or private**
8 **club, a person must have a cannabis lounge license issued by the commission for the prem-**
9 **ises at which the consumption occurs. To hold a license under this section:**

10 **(a) The applicant:**

11 **(A) Must apply for the license in the manner described in ORS 475B.040; and**

12 **(B) Must provide proof that the applicant is 21 years of age or older;**

13 **(b) The premises at which the cannabis lounge is located:**

14 **(A) May not be located in an area that is zoned exclusively for residential use; and**

15 **(B) May not be located within 1,000 feet of:**

16 **(i) A public elementary or secondary school for which attendance is compulsory under**
17 **ORS 339.020; or**

18 **(ii) A private or parochial elementary or secondary school, teaching children as described**
19 **in ORS 339.030 (1)(a); and**

20 **(c) The applicant and the premises at which the cannabis lounge is located must meet**
21 **the requirements of any rule adopted by the commission under subsection (3) of this section.**

22 **(3) The commission shall adopt rules that:**

23 **(a) Require a person that holds a license issued under this section to renew the license**
24 **annually;**

28 **premises for which a license has been issued under this section;**

29 **(d) Prohibit the production, propagation, processing and sale of marijuana items on a**
30 **premises for which a license has been issued under this section;**

31 **(e) Prohibit the consumption and sale of alcoholic beverages and tobacco products on a**
32 **premises for which a license has been issued under this section;**

33 **(f) Prohibit the use of video lottery games as authorized under ORS 461.217, social games**
34 **as defined in ORS 167.117 and betting on a premises for which a license has been issued under**
35 **this section;**

36 **(g) Require each portion of a premises for which a license has been issued under this**
37 **section where marijuana items are smoked, aerosolized or vaporized to have a ventilation**
38 **system that:**

39 **(A) Exhausts smoke, aerosols and vapors from that portion of the premises; and**

40 **(B) Is designed and terminated in accordance with state building code standards for the**
41 **applicable occupancy classification; and**

42 **(h) Require a premises for which a license has been issued under this section to meet**
43 **any public health and safety standards and industry best practices established by the com-**
44 **mission by rule.**

45 **(4) Fees adopted under subsection (3)(b) of this section:**

1 (a) May not exceed, together with other fees collected under ORS 475B.010 to 475B.395,
 2 the cost of administering ORS 475B.010 to 475B.395; and

3 (b) Shall be deposited in the Marijuana Control and Regulation Fund established under

 9 (Exceptions to Public Use Restrictions)

 11 **SECTION 4.** ORS 475B.280 is amended to read:

12 475B.280. (1)(a) **Except as provided in paragraph (b) of this subsection,** it is unlawful for any
 13 person to engage in the use of marijuana items in a public place.

14 (b) **A person 21 years of age or older may engage in the use of marijuana items in des-**
 15 **ignated areas of a premises for which a license has been issued under section 2 or 3 of this**
 16 **2017 Act.**

17 (2) A violation of subsection (1)(a) of this section is a Class B violation.

18 **SECTION 5.** ORS 433.850 is amended to read:

19 433.850. (1) An employer:

20 (a) Shall provide for employees a place of employment that is free of all smoke, aerosols and
 21 vapors containing inhalants; and

22 (b) May not allow employees to smoke, aerosolize or vaporize inhalants at the place of employ-
 23 ment.

24 (2) Notwithstanding subsection (1) of this section:

25 (a) The owner or person in charge of a hotel or motel may designate up to 25 percent of the
 26 sleeping rooms of the hotel or motel as rooms in which the smoking, aerosolizing or vaporizing of
 27 inhalants is permitted.

28 (b) Smoking of noncommercial tobacco products for ceremonial purposes is permitted in spaces
 29 designated for traditional ceremonies in accordance with the American Indian Religious Freedom
 30 Act, 42 U.S.C. 1996.

31 (c) The smoking of tobacco products is permitted in a smoke shop.

32 (d) The smoking of cigars is permitted in a cigar bar that generated on-site retail sales of cigars
 33 of at least \$5,000 for the calendar year ending December 31, 2006.

34 (e) A performer may smoke or carry a lighted smoking instrument that does not contain tobacco
 35 or marijuana, and may aerosolize or vaporize a substance that does not contain nicotine or a
 36 cannabinoid, while performing in a scripted stage, motion picture or television production if:

37 (A) The production is produced by an organization whose primary purpose is producing scripted
 38 productions; and

39 (B) The act of smoking, aerosolizing or vaporizing is an integral part of the production.

40 (f) The medical use of marijuana is permitted in the place of employment of a licensee of a
 41 professional licensing board as described in ORS 475B.485.

42 (g) **The smoking of marijuana and the aerosolizing or vaporizing of a substance that**
 43 **contains cannabinoids is allowed in designated areas of a premises for which a license has**
 44 **been issued under section 2 or 3 of this 2017 Act.**

45 (3) An employer, except in those places described in subsection (2) of this section, shall post

1 signs that provide notice of the provisions of ORS 433.835 to 433.875.

5 **SECTION 6.** (1) **The Oregon Liquor Control Commission may not issue a temporary event**
6 **license under section 2 of this 2017 Act to an applicant applying for the license if the tem-**
7 **porary event will be located:**

8 (a) **Within a city that has not adopted an ordinance allowing the consumption and sale**
9 **of marijuana items at temporary events; or**

10 (b) **Within the unincorporated area of a county that has not adopted an ordinance al-**
11 **lowing the consumption and sale of marijuana items at temporary events.**

12 (2) **The commission may not issue a cannabis lounge license under section 3 of this 2017**
13 **Act to an applicant applying for the license if the public or private club will be located:**

14 (a) **Within a city that has not adopted an ordinance allowing the consumption of**
15 **marijuana items at public or private clubs; or**

16 (b) **Within the unincorporated area of a county that has not adopted an ordinance al-**
17 **lowing the consumption of marijuana items at public or private clubs.**

18 (3) **If the governing body of a city or county adopts an ordinance under this section, the**
19 **governing body must provide the text of the ordinance to the commission, in the manner**
20 **prescribed by the commission.**

22 **DELIVERY AND RECEIPT OF MARIJUANA ITEMS**

24 **SECTION 7.** ORS 475B.160, as amended by section 23, chapter 23, Oregon Laws 2016, section
25 65, chapter 24, Oregon Laws 2016, and section 12, chapter 83, Oregon Laws 2016, is amended to
26 read:

27 475B.160. (1)(a) Except as provided in section 22, chapter 23, Oregon Laws 2016, and section 2,
28 chapter 83, Oregon Laws 2016, a marijuana producer **that holds a license issued under ORS**
29 **475B.070, a marijuana processor that holds a license issued under ORS 475B.090 or a marijuana**
30 **wholesaler that holds a license issued under ORS 475B.100** may deliver marijuana items only to
31 or on a premises **for which a license has been issued under ORS 475B.070, 475B.090, 475B.100**
32 **or 475B.110.**

33 (b) **A marijuana retailer that holds a license issued under ORS 475B.110 may deliver**
34 **marijuana items only on the premises of the marijuana retailer or to or on a premises for**
35 **which a license has been issued under section 2 of this 2017 Act.**

36 (2)(a) [A premises] **A licensee to whom marijuana items may be delivered under subsection**
37 **(1)(a) of this section** may receive marijuana items only from:

38 [(a) *A marijuana producer, marijuana processor or marijuana wholesaler for whom a premises has*
39 *been licensed by the Oregon Liquor Control Commission;*]

40 (A) **A marijuana producer that holds a license issued under ORS 475B.070, marijuana**
41 **processor that holds a license issued under ORS 475B.090 or marijuana wholesaler that holds**
42 **a license issued under ORS 475B.100;**

43 [(b)] (B) **A researcher of cannabis certified under ORS 475B.235 [who] that** transfers limited
44 amounts of marijuana, usable marijuana, cannabinoid products, cannabinoid concentrates and
45 cannabinoid extracts in accordance with procedures adopted under ORS 475B.235 (3)(d) and (e); or

1 [(c)] (C) A marijuana grow site registered under ORS 475B.420, marijuana processing site regis-
 2 tered under ORS 475B.435, or a medical marijuana dispensary registered under ORS 475B.450, acting
 3 in accordance with procedures adopted by the **Oregon Liquor Control** Commission under section
 4 25, chapter 24, Oregon Laws 2016.

5 **(b) A licensee to whom marijuana items may be delivered under subsection (1)(b) of this**
 6 **section may receive marijuana items only from a marijuana retailer that holds a license is-**
 7 **sued under ORS 475B.110.**

8 (3) The sale of marijuana items by a marijuana retailer that holds a license issued under ORS
 9 475B.110 must be restricted to the premises [*described in the license*] **for which the license has**
 10 **been issued**, but deliveries may be made by [*the*] a marijuana retailer to consumers pursuant to a
 11 bona fide order received at the premises prior to delivery.

15 **SECTION 8.** ORS 475B.015, as amended by section 63, chapter 24, Oregon Laws 2016, and sec-
 16 tion 11, chapter 83, Oregon Laws 2016, is amended to read:

17 475B.015. As used in ORS 475B.010 to 475B.395:

18 (1) “Cannabinoid” means any of the chemical compounds that are the active constituents of
 19 marijuana.

20 (2) “Cannabinoid concentrate” means a substance obtained by separating cannabinoids from
 21 marijuana by:

22 (a) A mechanical extraction process;

23 (b) A chemical extraction process using a nonhydrocarbon-based or other solvent, such as water,
 24 vegetable glycerin, vegetable oils, animal fats, isopropyl alcohol or ethanol;

25 (c) A chemical extraction process using the hydrocarbon-based solvent carbon dioxide, provided
 26 that the process does not involve the use of high heat or pressure; or

27 (d) Any other process identified by the Oregon Liquor Control Commission, in consultation with
 28 the Oregon Health Authority, by rule.

29 (3) “Cannabinoid edible” means food or potable liquid into which a cannabinoid concentrate,
 30 cannabinoid extract or dried marijuana leaves or flowers have been incorporated.

31 (4) “Cannabinoid extract” means a substance obtained by separating cannabinoids from
 32 marijuana by:

33 (a) A chemical extraction process using a hydrocarbon-based solvent, such as butane, hexane
 34 or propane;

35 (b) A chemical extraction process using the hydrocarbon-based solvent carbon dioxide, if the
 36 process uses high heat or pressure; or

37 (c) Any other process identified by the commission, in consultation with the authority, by rule.

38 (5)(a) “Cannabinoid product” means a cannabinoid edible and any other product intended for
 39 human consumption or use, including a product intended to be applied to the skin or hair, that
 40 contains cannabinoids or dried marijuana leaves or flowers.

41 (b) “Cannabinoid product” does not include:

42 (A) Usable marijuana by itself;

43 (B) A cannabinoid concentrate by itself;

44 (C) A cannabinoid extract by itself; or

45 (D) Industrial hemp, as defined in ORS 571.300.

1 (6) “Consumer” means a person who purchases, acquires, owns, holds or uses marijuana items
2 other than for the purpose of resale.

3 (7)(a) “Financial consideration” means value that is given or received either directly or indi-
4 rectly through sales, barter, trade, fees, charges, dues, contributions or donations.

5 (b) “Financial consideration” does not include marijuana, cannabinoid products or cannabinoid
6 concentrates that are delivered within the scope of and in compliance with ORS 475B.245.

7 (8) “Homegrown” means grown by a person 21 years of age or older for noncommercial purposes.

8 (9) “Household” means a housing unit and any place in or around a housing unit at which the
9 occupants of the housing unit are producing, processing, possessing or storing homegrown
10 marijuana, cannabinoid products, cannabinoid concentrates or cannabinoid extracts.

11 (10) “Housing unit” means a house, an apartment or a mobile home, or a group of rooms or a
12 single room that is occupied as separate living quarters, in which the occupants live and eat sepa-
13 rately from any other persons in the building and that has direct access from the outside of the
14 building or through a common hall.

15 (11) “Immature marijuana plant” means a marijuana plant that is not flowering.

16 (12) “Licensee” means a person *[who]* **that** holds a license issued under ORS 475B.070, 475B.090,
17 475B.100 or 475B.110 **or section 2 or 3 of this 2017 Act.**

18 *[(13) “Licensee representative” means an owner, director, officer, manager, employee, agent or other*
19 *representative of a licensee, to the extent that the person acts in a representative capacity.]*

20 *[(14)(a)]* **(13)(a)** “Marijuana” means the plant Cannabis family Cannabaceae, any part of the
21 plant Cannabis family Cannabaceae and the seeds of the plant Cannabis family Cannabaceae.

22 (b) “Marijuana” does not include industrial hemp, as defined in ORS 571.300.

23 *[(15)]* **(14)** “Marijuana flowers” means the flowers of the plant genus Cannabis within the plant
24 family Cannabaceae.

25 *[(16)]* **(15)** “Marijuana items” means marijuana, cannabinoid products, cannabinoid concentrates
26 and cannabinoid extracts.

27 *[(17)]* **(16)** “Marijuana leaves” means the leaves of the plant genus Cannabis within the plant
28 family Cannabaceae.

29 *[(18)]* **(17)** “Marijuana processor” means a person who processes marijuana items in this state.

30 *[(19)]* **(18)** “Marijuana producer” means a person who produces marijuana in this state.

31 *[(20)]* **(19)** “Marijuana retailer” means a person who sells marijuana items to a consumer in this
32 state.

33 *[(21)]* **(20)** “Marijuana wholesaler” means a person who purchases marijuana items in this state
34 for resale to a person other than a consumer.

35 *[(22)]* **(21)** “Mature marijuana plant” means a marijuana plant that is not an immature marijuana
36 plant.

37 *[(23)]* **(22)** “Medical grade cannabinoid product, cannabinoid concentrate or cannabinoid
38 extract” means a cannabinoid product, cannabinoid concentrate or cannabinoid extract that has a
39 concentration of tetrahydrocannabinol that is permitted under ORS 475B.625 in a single serving of
40 the cannabinoid product, cannabinoid concentrate or cannabinoid extract for consumers who hold
41 a valid registry identification card issued under ORS 475B.415.

42 *[(24)]* **(23)** “Medical purpose” means a purpose related to using usable marijuana, cannabinoid
43 products, cannabinoid concentrates or cannabinoid extracts to mitigate the symptoms or effects of
44 a debilitating medical condition, as defined in ORS 475B.410.

45 *[(25)]* **(24)** “Noncommercial” means not dependent or conditioned upon the provision or receipt

1 of financial consideration.

2 [(26)(a)] **(25)(a)** “Premises” [or “*licensed premises*”] includes the following areas of a location li-
3 censed under ORS [475B.070, 475B.090, 475B.100 or 475B.110] **475B.010 to 475B.395:**

4 (A) All public and private enclosed areas at the location that are used in the business operated
5 at the location, including offices, kitchens, rest rooms and storerooms;

6 (B) All areas outside a building that the commission has specifically licensed for the processing,
7 wholesale sale or retail sale of marijuana items; and

8 (C) For a location that the commission has specifically licensed for the production of marijuana
9 outside a building, that portion of the location used to produce marijuana.

10 (b) “Premises” [or “*licensed premises*”] does not include a primary residence.

11 [(27)(a)] **(26)(a)** “Processes” means the processing, compounding or conversion of marijuana into
12 cannabinoid products, cannabinoid concentrates or cannabinoid extracts.

13 (b) “Processes” does not include packaging or labeling.

14 [(28)(a)] **(27)(a)** “Produces” means the manufacture, planting, cultivation, growing or harvesting
15 of marijuana.

16 (b) “Produces” does not include:

17 (A) The drying of marijuana by a marijuana processor, if the marijuana processor is not other-
18 wise producing marijuana; or

19 (B) The cultivation and growing of an immature marijuana plant by a marijuana processor,
20 marijuana wholesaler or marijuana retailer if the marijuana processor, marijuana wholesaler or
21 marijuana retailer purchased or otherwise received the plant from a licensed marijuana producer.

22 [(29)] **(28)** “Propagate” means to grow immature marijuana plants or to breed or produce the
23 seeds of the plant Cannabis family Cannabaceae.

24 [(30)] **(29)** “Public place” means a place to which the general public has access and includes,
25 but is not limited to, hallways, lobbies and other parts of apartment houses and hotels not consti-
26 tuting rooms or apartments designed for actual residence, and highways, streets, schools, places of
27 amusement, parks, playgrounds and areas used in connection with public passenger transportation.

28 [(31)(a)] **(30)(a)** “Usable marijuana” means the dried leaves and flowers of marijuana.

29 (b) “Usable marijuana” does not include:

30 (A) The seeds, stalks and roots of marijuana; or

31 (B) Waste material that is a by-product of producing or processing marijuana.

32 **SECTION 9. Section 10 of this 2017 Act is added to and made a part of ORS 475B.010 to**
33 **475B.395.**

34 **SECTION 10. (1) Unless the context requires otherwise or as specifically excepted by the**
35 **Oregon Liquor Control Commission by rule, for purposes of ORS 475B.010 to 475B.395, rules**
36 **adopted under ORS 475B.010 to 475B.395 and any other statutory law of this state that spe-**
37 **cifically references licensees, “licensee” includes an owner, director, officer, manager, em-**
38 **ployee, agent or other representative of a person that holds a license issued under ORS**
39 **475B.010 to 475B.395, to the extent that the person acts in a representative capacity.**

40 **(2) This section does not make an owner, director, officer, manager, employee, agent or**
41 **other representative of a person that holds a license issued under ORS 475B.010 to 475B.395,**
42 **to the extent that the person acts in a representative capacity, a licensee for purposes of**
43 **ORS chapter 183.**

44 **SECTION 11. ORS 475B.025 is amended to read:**

45 475B.025. (1) The Oregon Liquor Control Commission has the [powers and] duties, **functions and**

1 **powers** specified in ORS 475B.010 to 475B.395 and the powers necessary or proper to enable the
2 commission to carry out the commission's duties, functions and powers under ORS 475B.010 to
3 475B.395. The jurisdiction, supervision, duties, functions and powers of the commission extend to any
4 person who [*buys, sells,*] produces, processes, transports [*or delivers any marijuana items within*],
5 **delivers, sells or purchases a marijuana item** in this state. The commission may sue and be sued.

6 (2) The duties, functions and powers of the commission **specified** in ORS 475B.010 to 475B.395
7 include the following:

7 **issued** under ORS 475B.070, a marijuana processor that holds a license **issued** under ORS 475B.090,
8 a marijuana wholesaler that holds a license **issued** under ORS 475B.100, a marijuana retailer that
9 holds a license **issued** under ORS 475B.110, **a person that holds a license issued under section**
10 **2 of this 2017 Act, a person that holds a license issued under section 3 of this 2017 Act,** a
11 laboratory that holds a license under ORS 475B.560 or a person to whom a permit has been issued
12 under ORS 475B.218 is exempt from any criminal law of this state an element of which may be
13 proven by substantiating that a person provides financial services customarily provided by financial
14 institutions pursuant to powers granted by ORS 717.200 to 717.320, 717.900 and 717.905, the Bank
15 Act or ORS chapter 723 to a person who possesses, delivers or manufactures marijuana or marijuana
16 derived products.

17 **SECTION 68.** Section 3, chapter 97, Oregon Laws 2016, is amended to read:

18 **Sec. 3.** (1) Notwithstanding any law relating to the exemption of information from public dis-
19 closure under ORS 475B.010 to 475B.395 or 475B.550 to 475B.590, upon the request of a financial
20 institution, the Oregon Liquor Control Commission shall provide to the financial institution the fol-
21 lowing information:

22 (a) Whether a person with whom the financial institution is doing business holds a license **is-**
23 **sued** under ORS [475B.070, 475B.090, 475B.100, 475B.110 or 475B.560] **475B.010 to 475B.395** or a
24 permit **issued** under ORS 475B.218;

25 (b) The name of any other business or individual affiliated with the person;

26 (c) A copy of the application, and any supporting documentation submitted with the application,
27 for a license or a permit submitted by the person;

28 (d) If applicable, data relating to sales and the volume of product sold by the person;

29 (e) Whether the person is currently compliant with the provisions of ORS 475B.010 to 475B.395,
30 475B.550 to 475B.590 and 475B.600 to 475B.655 and rules adopted under ORS 475B.010 to 475B.395,
31 475B.550 to 475B.590 and 475B.600 to 475B.655;

32 (f) Any past or pending violation by the person of a provision of ORS 475B.010 to 475B.395,
33 475B.550 to 475B.590 or 475B.600 to 475B.655 or a rule adopted under ORS 475B.010 to 475B.395,
34 475B.550 to 475B.590 or 475B.600 to 475B.655; and

35 (g) Any penalty imposed upon the person for violating a provision of ORS 475B.010 to 475B.395,
36 475B.550 to 475B.590 or 475B.600 to 475B.655 or a rule adopted under ORS 475B.010 to 475B.395,
37 475B.550 to 475B.590 or 475B.600 to 475B.655.

38 (2) Upon receiving a request under subsection (1) of this section, the commission shall provide
39 the requesting financial institution with the requested information.

40 (3) The commission may charge a financial institution a reasonable fee to cover the adminis-
41 trative costs of providing information under this section.

13 ience of the reader and do not become part of the statutory law of this state or express any
14 legislative intent in the enactment of this 2017 Act.
