

## HOUSE AMENDMENTS TO RESOLVE CONFLICTS TO A-ENGROSSED SENATE BILL 374

1 On page 5 of the printed A-engrossed bill, delete lines 27 through 45.

2 On page 6, delete lines 1 through 14 and insert:

3 “**SECTION 15.** ORS 807.050, as amended by section 2, chapter 306, Oregon Laws 2017 (Enrolled  
4 Senate Bill 36), is amended to read:

5 “807.050. An application for a **driver** license shall be in a form approved by the [Oregon] De-  
6 partment of Transportation. An application must contain all the following:

7 “(1) The applicant’s full legal name, [age,] sex, **date of birth**, residence address, except as oth-  
8 erwise provided for corrections officers in ORS 802.253, eligible employees in ORS 802.250 or Ad-  
9 dress Confidentiality Program participants in ORS 192.846, and post-office address other than  
10 general delivery. The department may provide by rule for acceptance of something other than an  
11 actual residence or post-office address if the department determines that the applicant does not have  
12 an actual address. The department shall require proof to verify the address in addition to anything  
13 else the department may require of the applicant. The department shall adopt rules to identify what  
14 constitutes proof of address for purposes of this subsection. [Verification of] Proof of address may  
15 include, but is not limited to, providing a utility bill, a tax return, a record from a financial insti-  
16 tution, a proof of insurance card or a health benefits card, a selective service card, a mortgage  
17 document or a lease agreement. The applicant may provide the proof of address by submitting proof  
18 in the form of an original document or a copy of a document, use an electronic device to display  
19 proof of address, or provide proof through the use of a third party address verification system.

20 “(2) The class of **driver** license sought.

21 “(3) The Social Security number of the applicant or other number or identifying information  
22 determined appropriate by the Secretary of the United States Department of Transportation, if the  
23 application is for a commercial driver license or a commercial learner driver permit or if the Oregon  
24 Department of Transportation by rule requires the Social Security number on the application.

25 “(4) Whether or not the applicant wants to make an anatomical gift, as defined in ORS 97.953.

26 “(5) Any other information the department deems necessary to assist the department in deter-  
27 mining whether the applicant is qualified or eligible to be licensed.

28 “(6) **The signature of the applicant.**”

29 On page 7, after line 18, insert:

30 “**SECTION 16a.** If Senate Bill 37 becomes law, section 16 of this 2017 Act (amending ORS  
31 807.110) is repealed and ORS 807.110, as amended by section 11, chapter 190, Oregon Laws 2017  
32 (Enrolled Senate Bill 37), is amended to read:

33 “807.110. (1) A **driver** license issued by the Department of Transportation shall contain all of  
34 the following:

35 “(a) The distinguishing number assigned to the person issued the **driver** license by the depart-

1 ment.

2 “(b) For the purpose of identification, a brief description of the person to whom the **driver** li-  
3 cense is issued.

4 “(c) The full legal name of the person to whom the **driver** license is issued, except that the de-  
5 partment may limit the number of characters displayed on the **driver** license.

6 “(d) The date of birth **and sex** of the person to whom the **driver** license is issued.

7 “(e) Except as provided for corrections officers in ORS 802.253, eligible employees in ORS  
8 802.250 or Address Confidentiality Program participants in ORS 192.846, the residence address of the  
9 person to whom the **driver** license is issued.

10 “(f) Upon request of the person to whom the **driver** license is issued, the fact that the person  
11 is an anatomical donor.

12 “(g) Upon request of the person to whom the **driver** license is issued and presentation of proof,  
13 as determined by the department, the fact that the person is a veteran, as defined in ORS 408.225.

14 “(h) Upon order of the juvenile court, the fact that the person to whom the **driver** license is  
15 issued is an emancipated minor.

16 “(i) Except as otherwise provided in subsection (2) of this section, a photograph described in this  
17 paragraph. A photograph required under this paragraph shall:

18 “(A) Be a full-faced, color photograph of the person to whom the **driver** license is issued;

19 “(B) Be of a size approved by the department; and

20 “(C) Be taken at the time of application for issuance of the **driver** license whether the applica-  
21 tion is for an original **driver** license, replacement of a **driver** license under ORS 807.160 or [for]  
22 renewal of a **driver** license under ORS 807.150, except that the department, by rule, may allow the  
23 applicant to use a photograph already on file with the department.

24 “(j) The class of **driver** license issued and any endorsements granted.

25 “(k) The signature of the person to whom the **driver** license is issued.

26 “**(L) If the driver license is not a Real ID, a design differentiating it from a Real ID.**

27 “(2) The department may issue a valid **driver** license, other than a commercial driver license,  
28 without a photograph to an applicant:

29 “(a) Who objects on religious grounds;

30 “(b) Who objects because of the applicant’s facial disfigurement; or

31 “(c) Who is stationed outside of this state while serving in the active military service in the  
32 Armed Forces of the United States or the National Guard, and the department does not have an  
33 acceptable photograph of the applicant, as determined by the department by rule. This paragraph  
34 applies to an applicant who is renewing or replacing a **driver** license.

35 “(3) A limited term driver license issued under ORS 807.730 shall indicate:

36 “(a) That it is a limited term driver license; and

37 “(b) The date on which the limited term driver license expires.

38 “(4) The department shall use security procedures, processes and materials in the preparation,  
39 manufacture and issuance of any **driver** license that prohibit as nearly as possible anyone’s ability  
40 to alter, counterfeit, duplicate or modify the **driver** license without ready detection. The security  
41 features used in the production of the **driver** licenses shall provide for:

42 “(a) The authentication of a genuine document in a reasonable time; and

43 “(b) The production of the **driver** license only by equipment that requires verification of the  
44 identity of the operator of the equipment before a **driver** license may be produced.”.

45 On page 9, delete lines 34 through 45.

1 On page 10, delete lines 1 through 14 and insert:

2 **“SECTION 19.** ORS 807.730, as amended by section 6, chapter 306, Oregon Laws 2017 (Enrolled  
3 Senate Bill 36), is amended to read:

4 “807.730. (1) The Department of Transportation may issue or replace a limited term driver li-  
5 cense, limited term commercial driver license, limited term driver permit, limited term commercial  
6 learner driver permit or limited term identification card only for a person who provides proof, as  
7 determined by the department by rule, that the person is legally present in the United States on a  
8 temporary basis.

9 “(2) A limited term driver license, limited term commercial driver license or limited term iden-  
10 tification card is valid:

11 “(a) During the applicant’s authorized stay in the United States, but no longer than eight years  
12 from the date of issuance; or

13 “(b) If there is no definite end to the authorized stay, for a period of one year.

14 “(3) A limited term driver permit or a limited term commercial learner driver permit is valid:

15 “(a) During the applicant’s authorized stay in the United States, but no longer than the period  
16 of time for which a driver permit of the same type is issued by the department.

17 “(b) If there is no definite end to the authorized stay, for a period of one year but no longer than  
18 the period of time for which a driver permit of the same type is issued by the department.

19 “(4) A limited term driver license, limited term commercial driver license, limited term driver  
20 permit, limited term commercial learner driver permit or limited term identification card may be  
21 renewed only upon presentation of valid documentation, as determined by the department by rule,  
22 that the status by which the applicant qualified for the limited term driver license, limited term  
23 commercial driver license, limited term driver permit, limited term commercial learner driver permit  
24 or limited term identification card has been extended or is still in effect.

25 “(5) A limited term driver license or limited term driver permit grants the same privileges as a  
26 driver license or driver permit.

27 “(6) A limited term identification card shall bear a statement to the effect that the limited term  
28 identification card is not a license or any other grant of driving privileges to operate a motor ve-  
29 hicle and is to be used for identification purposes only.

30 “(7) A limited term commercial driver license or limited term commercial learner driver permit  
31 grants the same privileges as a commercial driver license or commercial learner driver permit.

32 “(8) The department may issue a limited term commercial driver license or limited term com-  
33 mercial learner driver permit if the applicant is otherwise eligible for commercial driving privileges.  
34 The department may adopt rules describing eligibility requirements for limited term commercial  
35 driver licenses and limited term commercial learner driver permits.

36 **“(9) A limited term driver license, limited term commercial driver license or limited term**  
37 **identification card shall clearly indicate that it is a limited term driver license, limited term**  
38 **commercial driver license or limited term identification card and indicate the date on which**  
39 **it expires.”.**
