

Senate Bill 483

Sponsored by Senator PROZANSKI (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of unlawful use of a global positioning system device. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both, or, if person at time of offense has certain previous convictions or is subject of certain court orders, five years' imprisonment, \$125,000 fine, or both.

2 Relating to unlawful use of a global positioning system device; creating new provisions; and

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) A person commits the crime of unlawful use of a global positioning sys-**
6 **tem device if the person knowingly affixes a global positioning system device to a motor ve-**
7 **hicle without consent of the owner of the motor vehicle.**

8 **(2)(a) Except as provided in paragraph (b) of this subsection, unlawful use of a global**
9 **positioning system device is a Class A misdemeanor.**

10 **(b) Unlawful use of a global positioning system device is a Class C felony if, at the time**
11 **of the offense, the person:**

12 **(A) Has been previously convicted of stalking under ORS 163.732, violating a court's**
13 **stalking order under ORS 163.750 or committing an equivalent crime in another jurisdiction;**
14 **or**

15 **(B) Is the subject of a citation issued under ORS 163.735, an order issued under ORS**
16 **30.866, 107.700 to 107.735 or 163.738 or another court order prohibiting the person from con-**
17 **tacting another person.**

18 **(3) As used in this section, "global positioning system device" means an electronic device**
19 **that permits the tracking of a person or object by means of global positioning system coor-**
20 **dinates.**
