

SENATE AMENDMENTS TO SENATE BILL 488

1 In line 2 of the printed bill, delete “and declaring an emergency” and insert “creating new
2 provisions; and amending ORS 98.852, 98.858, 819.012 and 822.015”.

3 Delete lines 4 through 15 and insert:

5 “STOLEN VEHICLES AND SHARING VEHICLE OWNER’S 6 CONTACT INFORMATION WITH TOWERS 7

8 “**SECTION 1.** ORS 98.852 is amended to read:

9 “98.852. As used in ORS 98.854 to 98.862:

10 “(1) ‘Consideration’ has the meaning given that term in ORS 171.725.

11 “(2) ‘Law enforcement agency’ has the meaning given that term in ORS 131.915.

12 “[2] (3) ‘Motor vehicle’ has the meaning given that term in ORS 801.360.

13 “[3] (4) ‘Parking facility’ has the meaning given that term in ORS 98.805.

14 “[4] (5) ‘Tower’ means a person that:

15 “(a) Owns or operates a tow vehicle for profit; or

16 “(b) Is employed by a person that owns or operates a tow vehicle for profit.

17 “[5] (6) ‘Tow vehicle’ has the meaning given that term in ORS 801.530.

18 “**SECTION 2.** Section 3 of this 2017 Act is added to and made a part of ORS 98.854 to
19 **98.862.**

20 “**SECTION 3.** (1) After a motor vehicle reported as stolen is recovered by a law enforce-
21 ment agency, the agency shall share the owner’s contact information, including home ad-
22 dress and telephone number, from either the Law Enforcement Data System or the stolen
23 vehicle police report, with any tower that assumes control of the vehicle. The contact in-
24 formation may be used only for the purposes described in subsection (2) of this section.

25 “(2) As soon as is practicable after recovering the motor vehicle, the tower shall attempt
26 to provide notice to the owner of the stolen motor vehicle:

27 “(a) That the motor vehicle has been recovered; and

28 “(b) Of the current location of the vehicle.

29 “(3) Fees charged by the tower for storage of a stolen motor vehicle may not begin to
30 accrue until the date that the tower first attempts to notify the owner of the stolen motor
31 vehicle under subsection (2) of this section.
32

33 “STOLEN VEHICLES AND TRANSFER OF TITLE TO TOWER 34

35 “**SECTION 4.** Section 5 of this 2017 Act is added to and made a part of the Oregon Vehicle

1 Code.

2 **“SECTION 5. (1) If a tower recovers a vehicle after a theft and the vehicle is totaled, the**
3 **person who is the owner of the vehicle may transfer the person’s interest in the vehicle to**
4 **the tower in payment or partial payment of the tower’s fees for recovery and storage of the**
5 **vehicle.**

6 **“(2) A tower that accepts a transfer of interest in a vehicle from a person under this**
7 **section may not assess fees against the person for storage of the totaled vehicle that occurs**
8 **on and after the date of the transfer of interest.**

9 **“(3) Notwithstanding the provisions for liens under ORS 98.812 and 98.835, if a person**
10 **transfers their interest in a vehicle under this section to a tower within 14 days of the date**
11 **the person receives notice under section 3 of this 2017 Act, the tower may not bring an**
12 **action against the person for, or otherwise take any affirmative steps to collect or permit**
13 **an agency or assignee to collect, any amount as compensation for towing, caring for or**
14 **storing the totaled vehicle.**

15 **“(4) A tower that receives title under this section is responsible for any fees imposed by**
16 **the Department of Transportation for transferring title.**

17 **“SECTION 6. ORS 819.012 is amended to read:**

18 **“819.012. (1) A person other than an insurer commits the offense of failure to follow procedures**
19 **for a totaled vehicle if the person:**

20 **“(a) Is the registered owner of a vehicle that is a totaled vehicle as defined in ORS 801.527 (1)**
21 **and does not surrender the certificate of title for the vehicle either to the Department of Trans-**
22 **portation or to the insurer within 30 days of the declaration or other relevant act by the insurer.**

23 **“(b) Is the registered owner of a vehicle that is a totaled vehicle as defined in ORS 801.527 (2)**
24 **and does not notify the department of the status of the vehicle within 30 days of the day that the**
25 **vehicle became a totaled vehicle.**

26 **“(c) Is the registered owner of a vehicle that is a totaled vehicle as defined in ORS 801.527 (3)**
27 **and does not surrender the certificate of title for the vehicle to the department within 30 days of**
28 **the date the vehicle became a totaled vehicle.**

29 **“(d) Receives or purchases a totaled vehicle and does not surrender the certificate of title for**
30 **the vehicle to the department within 30 days of purchase or receipt of the vehicle.**

31 **“(2) A person is not required to surrender the certificate of title if the person is unable to obtain**
32 **the certificate for the vehicle. If the person is unable to obtain the certificate, the person shall no-**
33 **tify the department that the vehicle is a totaled vehicle and shall notify the department of the rea-**
34 **son that the person is unable to surrender the certificate.**

35 **“(3) A person is not required to surrender the certificate of title if:**

36 **“(a) The person transferred their interest in the totaled vehicle to a tower pursuant to**
37 **section 5 of this 2017 Act; or**

38 **“(b) The person is a tower that received interest in the totaled vehicle pursuant to sec-**
39 **tion 5 of this 2017 Act and the tower subsequently transfers interest in the totaled vehicle**
40 **to a dismantler within 30 days of the date the tower received interest in the totaled vehicle.**

41 **“[(3)] (4) If the vehicle is one for which title was issued in a form other than a certificate, the**
42 **person shall notify the department that the vehicle is a totaled vehicle and shall follow procedures**
43 **adopted by the department by rule.**

44 **“[(4)] (5) The offense described in this section, failure to follow procedures for a totaled vehicle,**
45 **is a Class A misdemeanor.**

1 “**SECTION 7.** ORS 822.015 is amended to read:

2 “822.015. (1) In addition to any exemptions from the vehicle code under ORS 801.026, ORS
3 822.005 does not apply to the following vehicles or persons:

4 “(a) Road rollers, farm tractors, farm trailers, trolleys, implements of husbandry, emergency ve-
5 hicles, well-drilling machinery and boat or utility trailers with a gross weight of 1,800 pounds or
6 less.

7 “(b) The owner of a vehicle as shown by the vehicle title issued by any jurisdiction if the person
8 owned the vehicle primarily for personal, family or household purposes. If the person has sold,
9 traded, displayed or offered for sale, trade or exchange more than five vehicles in one calendar year,
10 the person shall have the burden of proving that the person owned the vehicles primarily for per-
11 sonal, family or household purposes or for other purposes that the Department of Transportation,
12 by rule, defines as constituting an exemption under this section.

13 “(c) A receiver, trustee, personal representative or public officer while performing any official
14 duties.

15 “(d) The lessor or security interest holder of a vehicle as shown by the vehicle title issued by
16 any jurisdiction.

17 “(e) Except as otherwise provided in this paragraph, a manufacturer who sells vehicles the
18 manufacturer has manufactured in Oregon. Nothing in this paragraph prevents any manufacturer
19 from obtaining a vehicle dealer certificate under ORS 822.020. This paragraph does not exempt a
20 manufacturer who sells or trades campers or travel trailers.

21 “(f) An insurance adjuster authorized to do business under ORS 744.505 or 744.515 who is dis-
22 posing of vehicles for salvage.

23 “(g) Except as otherwise provided in this paragraph, a person who sells or trades or offers to
24 sell or trade a vehicle that has been used in the operation of the person’s business. This paragraph
25 does not exempt a person who is in the business of selling, trading, displaying, rebuilding, renting
26 or leasing vehicles from any requirement to obtain a certificate for dealing in those vehicles.

27 “(h) A person who receives no money, goods or services, either directly or indirectly, for dis-
28 playing a vehicle or acting as an agent in the buying or selling of a vehicle.

29 “(i) A person who collects, purchases, acquires, trades or disposes of vehicles and vehicle parts
30 for the person’s own use in order to preserve, restore and maintain vehicles for the person’s own
31 use or for hobby or historical purposes.

32 “(j) A manufactured structure dealer subject to the licensing requirement of ORS 446.671 or a
33 person exempt from licensing under ORS 446.676 when selling a vehicle, trailer or semitrailer ac-
34 cepted in trade as part of a manufactured structure transaction. A manufactured structure dealer-
35 ship or exempt person may not directly sell more than three vehicles per calendar year under
36 authority of this paragraph, but by consignment with a dealer certified under ORS 822.020 or 822.040
37 may sell an unlimited number of vehicles acquired as described in this paragraph.

38 “(k) A lien claimant who sells vehicles in order to foreclose possessory liens.

39 “(L) A lien claimant who, in a 12-month period, sells 12 or fewer vehicles that the lien claimant
40 acquired through possessory liens if the vehicles are sold at the business location of the lien
41 claimant.

42 “(m) Electric personal assistive mobility devices.

43 “(n) **A tower that received title for a vehicle under section 5 of this 2017 Act.**

44 “(2) Notwithstanding ORS 822.005, the following may participate with other dealers in a display
45 of vehicles, including but not limited to an auto show, if the display is an event that lasts for 10 days

1 or less and is an event for which the public is charged admission:

2 “(a) A person who is licensed as a vehicle dealer in another jurisdiction; or

3 “(b) Any employee of a person who is licensed as a vehicle dealer in another jurisdiction.

4 “(3) Notwithstanding ORS 822.005, a person who is licensed as a vehicle dealer in another ju-
5 risdiction or an employee of a person who is certified or licensed as a vehicle dealer may participate
6 in a vehicle auction if the vehicle auction is:

7 “(a) Conducted by a vehicle dealer who holds a vehicle dealer certificate issued or renewed
8 under ORS 822.020 or 822.040; and

9 “(b) Open only to certified or licensed vehicle dealers or their employees.

10 “(4) The department shall adopt rules to carry out the provisions of this section, including but
11 not limited to specifying which dealers may take vehicles on consignment from other jurisdictions.

13 **“RIGHT TO INSPECT VEHICLE**

14
15 **“SECTION 8.** ORS 98.858 is amended to read:

16 “98.858. (1) A tower in physical possession of a motor vehicle shall permit the owner or person
17 in lawful possession of a motor vehicle the tower has towed to:

18 “(a) Redeem **or inspect** the motor vehicle:

19 “(A) Between 8 a.m. and 6 p.m. Monday through Friday, excluding legal holidays;

20 “(B) At all other hours, within 60 minutes after asking the tower to release **or allow for the**
21 **inspection of** the motor vehicle; and

22 “(C) Within 30 minutes of a time mutually agreed upon between the tower and the owner or
23 person in lawful possession of the motor vehicle;

24 “(b) Contact the tower at any time to receive information about the location of the motor ve-
25 hicle and instructions for obtaining release of the motor vehicle; and

26 “(c) Obtain all personal property of an emergency nature in the motor vehicle within the time
27 allowed under paragraph (a) of this subsection.

28 “(2) A tower may not charge the owner or person in lawful possession of the motor vehicle a
29 fee in any amount to obtain personal property of an emergency nature except for a gate fee between
30 the hours of 6 p.m. and 8 a.m. Monday through Friday, or on a Saturday, a Sunday or a legal holi-
31 day.

32 “(3) As used in this section, ‘personal property of an emergency nature’ includes but is not
33 limited to prescription medication, eyeglasses, clothing, identification, a wallet, a purse, a credit
34 card, a checkbook, cash and child safety car and booster seats.
