

# Senate Bill 5

Sponsored by Senator COURTNEY (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies laws related to student athlete agents.

## A BILL FOR AN ACT

Relating to student athlete agents; creating new provisions; amending ORS 646.608, 702.005, 702.012, 702.017, 702.027, 702.029, 702.030, 702.047, 702.052, 702.054, 702.057 and 702.991; and repealing ORS 702.032 and 702.037.

**Be It Enacted by the People of the State of Oregon:**

## SHORT TITLE

**SECTION 1. ORS 702.005 to 702.065, 702.991 and 702.994 shall be known and may be cited as the Revised Uniform Athlete Agents Act.**

## DEFINITIONS

**SECTION 2.** ORS 702.005 is amended to read:

702.005. As used in ORS 702.005 to 702.065, 702.991 and 702.994:

(1) "Agency contract" means[:]

*[(a) A written or oral] an agreement in which a student athlete authorizes a person, organization or legal, commercial or other entity] to negotiate or solicit on behalf of the student athlete a professional sports services contract or an endorsement contract[; or].*

*[(b) A written or oral agreement entered into by a student athlete that makes the student athlete ineligible to participate in an interscholastic or Intercollegiate sport because of a violation of rules or regulations established by a state or national organization that governs student athlete eligibility or participation].*

*[(2)(a) "Athlete agent" means an individual who, directly or indirectly:]*

*[(A) Represents or attempts to represent a student athlete for the purpose of marketing the student athlete's athletic ability or reputation for financial gain; or]*

*[(B) Seeks to obtain a type of financial gain or benefit from securing a prospective student athlete's enrollment at an educational institution or from a student athlete's potential earnings as a professional athlete.]*

*[(b) "Athlete agent" does not include a spouse, parent, sibling, grandparent or legal guardian of the student athlete or an individual acting solely on behalf of a professional sports team or professional sports organization.]*

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1       **(2)(a) “Athlete agent” means an individual who:**

2       **(A) Directly or indirectly recruits or solicits a student athlete to enter into an agency**  
3 **contract; or**

4       **(B) For compensation, procures employment or offers, promises, attempts or negotiates**  
5 **to obtain employment for a student athlete as a professional athlete or member of a profes-**  
6 **sional sports team or organization;**

7       **(C) For compensation or in anticipation of compensation related to a student athlete’s**  
8 **participation in athletics:**

9       **(i) Serves the athlete in an advisory capacity on a matter related to finances, business**  
10 **pursuits or career management decisions; or**

11       **(ii) Manages the business affairs of the athlete by providing assistance with bills, pay-**  
12 **ments, contracts or taxes;**

13       **(D) In anticipation of representing a student athlete for a purpose related to the athlete’s**  
14 **participation in athletics:**

15       **(i) Gives consideration to the athlete or another person;**

16       **(ii) Serves the athlete in an advisory capacity on a matter related to finances, business**  
17 **pursuits or career management decisions; or**

18       **(iii) Manages the business affairs of the athlete by providing assistance with bills, pay-**  
19 **ments, contracts or taxes; or**

20       **(E) Is a licensed, registered or certified professional and offers or provides services to a**  
21 **student athlete customarily provided by members of the profession and the individual:**

22       **(i) Also recruits or solicits the athlete to enter into an agency contract;**

23       **(ii) Also, for compensation, procures employment or offers, promises, attempts or nego-**  
24 **tiates to obtain employment for the athlete as a professional athlete or member of a pro-**  
25 **fessional sports team or organization; or**

26       **(iii) Receives consideration for providing the services calculated using a different method**  
27 **than for an individual who is not a student athlete.**

28       **(b) “Athlete agent” does not include an individual who:**

29       **(A) Acts solely on behalf of a professional sports team or organization;**

30       **(B) Is employed by, and acts solely on behalf of, a publicly traded corporation engaged in**  
31 **consumer brand marketing and seeking to negotiate an endorsement contract;**

32       **(C) Serves a student athlete in an advisory capacity on a matter related to finances,**  
33 **business pursuits or career management decisions and the individual is an employee of an**  
34 **educational institution acting exclusively as an employee of the institution for the benefit**  
35 **of the institution; or**

36       **(D) Is a licensed, registered or certified professional and offers or provides services to a**  
37 **student athlete customarily provided by members of the profession.**

38       **(3) “Athletic director” means:**

39       **(a) An individual responsible for administering the overall athletic program of an educational**  
40 **institution or, if an educational institution has separately administered athletic programs for male**  
41 **students and female students, the athletic program for males or the athletic program for females,**  
42 **as appropriate;**

43       **(b) If the educational institution is a public or private elementary school or secondary school**  
44 **and the educational institution does not have a person responsible for administering the overall**  
45 **athletic program:**

- 1 (A) The principal of the educational institution; or
- 2 (B) If the educational institution does not have a principal, the person designated by the gov-  
 3 erning body of the school district, education service district or charter school to manage the edu-  
 4 cational institution; or
- 5 (c) If the educational institution is a **technical or vocational school**, community college or  
 6 university and the educational institution does not have a person responsible for administering the  
 7 overall athletic program:
- 8 (A) The president of the educational institution; or
- 9 (B) If the educational institution does not have a president, the person designated by the gov-  
 10 erning body of the educational institution to manage the educational institution.
- 11 (4) “Contact” means a communication, direct or indirect, between an athlete agent and a student  
 12 athlete, to recruit or solicit the student athlete to enter into an agency contract.
- 13 (5) “Educational institution” means a public or private elementary school, secondary school,  
 14 **technical or vocational school**, community college, university or other educational institution.
- 15 (6) “Endorsement contract” means an agreement under which a student athlete is employed or  
 16 receives consideration to use on behalf of the other party any value that the student athlete may  
 17 have because of publicity, reputation, following or fame obtained because of athletic ability or per-  
 18 formance.
- 19 **(7) “Enrolled” means registered for courses and attending athletic practice or class.**
- 20 [(7)] (8) “Intercollegiate sport” means a sport played at the collegiate level for which eligibility  
 21 requirements for participation by a student athlete are established by a national association [*for the*  
 22 *promotion or regulation of*] **that promotes or regulates** collegiate athletics.
- 23 **(9) “Interscholastic sport” means a sport played between educational institutions that**  
 24 **are not community colleges, colleges or universities.**
- 25 **(10) “Licensed, registered or certified professional” means an individual who is licensed,**  
 26 **registered or certified as an attorney, dealer in securities, financial planner, insurance agent,**  
 27 **real estate broker or sales agent, tax consultant or accountant or a member of a profession,**  
 28 **other than that of athlete agent, who is licensed, registered or certified by the state or a**  
 29 **nationally recognized organization that licenses, registers or certifies members of the pro-**  
 30 **fession on the basis of experience, education or testing.**
- 31 [(8)] (11) “Person” means an individual, corporation, business trust, estate, trust, partnership,  
 32 limited liability company, association, **business or nonprofit entity**, joint venture, public body, as  
 33 defined in ORS 174.109, or any other legal or commercial entity.
- 34 [(9)] (12) “Professional sports services contract” means an agreement under which an individual  
 35 is employed, or agrees to render services, as a player on a professional sports team, with a profes-  
 36 sional sports organization or as a professional athlete.
- 37 [(10)] (13) “Record” means information that is inscribed on a tangible medium or that is stored  
 38 in an electronic or other medium and is retrievable in perceivable form.
- 39 (14)(a) **“Recruit or solicit” means attempt to influence the choice of an athlete agent by**  
 40 **a student athlete or, if the athlete is a minor, a parent or guardian of the athlete.**
- 41 (b) **“Recruit or solicit” does not include giving advice on the selection of a particular**  
 42 **athlete agent in a family, coaching or social situation unless the individual giving the advice**  
 43 **does so because of the receipt or anticipated receipt of an economic benefit, directly or in-**  
 44 **directly, from the agent.**
- 45 [(11)] (15) “Registration” means registration as an athlete agent pursuant to ORS 702.005 to

1 702.065, 702.991 and 702.994.

2 (16) **“Sign” means, with present intent to authenticate or adopt a record:**

3 (a) **To execute or adopt a tangible symbol; or**

4 (b) **To attach to or logically associate with the record an electronic symbol, sound or**  
 5 **process.**

6 [(12)] (17) **“State”** means a state of the United States, the District of Columbia, Puerto Rico, the  
 7 United States Virgin Islands or any territory or insular possession subject to the jurisdiction of the  
 8 United States.

9 [(13)] (18) **“Student athlete”** means an individual [attending] **who is eligible to attend** an edu-  
 10 cational institution [within this state] who engages in, is eligible to engage in or may be eligible in  
 11 the future to engage in any interscholastic **sport** or Intercollegiate sport. If an individual is per-  
 12 manently ineligible to participate in a particular interscholastic **sport** or Intercollegiate sport, the  
 13 individual is not a student athlete for purposes of that sport.

14  
 15 **REGISTRATION REQUIREMENTS**

16  
 17 **SECTION 3.** ORS 702.012 is amended to read:

18 702.012. (1) Except as otherwise provided in subsection (2) of this section, an individual may not  
 19 act as an athlete agent in Oregon without holding a certificate of registration issued under this  
 20 section or ORS 702.019.

21 (2) Before being issued a certificate of registration, an individual may act as an athlete agent  
 22 in Oregon for all purposes except entering into an agency contract, if:

23 (a) A student athlete, **or another person acting on behalf of the athlete**, initiates communi-  
 24 cation with the individual; and

25 (b) Within seven days after an initial act as an athlete agent, the individual submits an appli-  
 26 cation for registration as an athlete agent in Oregon.

27 (3) An agency contract resulting from conduct in violation of this section is void and the athlete  
 28 agent shall return any consideration received under the contract.

29 (4) Except as otherwise provided in subsection (5) of this section, the Department of Education  
 30 shall issue a certificate of registration to an individual who complies with ORS 702.017 (1) and (2)  
 31 [or whose application has been accepted under ORS 702.017 (3)].

32 (5) The department may refuse to issue a certificate of registration if the department determines  
 33 that the applicant has engaged in conduct that has a significant adverse effect on the applicant’s  
 34 fitness to act as an athlete agent. In making the determination, the department may consider  
 35 whether the applicant has:

36 (a) **Pleaded guilty or no contest to, has been convicted of, or has charges pending for**  
 37 *[Been convicted of]* a crime that, if committed in Oregon, would be a crime involving moral turpitude  
 38 or a felony;

39 (b) Made a materially false, misleading, deceptive or fraudulent representation in the application  
 40 or as an athlete agent;

41 (c) Engaged in conduct that would disqualify the applicant from serving in a fiduciary capacity;

42 (d) Engaged in conduct prohibited by ORS 702.027;

43 (e) Had a registration or licensure as an athlete agent suspended, revoked or denied or been  
 44 refused renewal of registration or licensure as an athlete agent in any state;

45 (f) Engaged in conduct the consequence of which was that a sanction, suspension or declaration

1 of ineligibility to participate in an interscholastic or Intercollegiate athletic event was imposed on  
 2 a student athlete or educational institution; or

3 (g) Engaged in conduct that significantly adversely reflects on the applicant’s credibility, hon-  
 4 esty or integrity.

5 (6) In making a determination under subsection (5) of this section, the department shall consider:

6 (a) How recently the conduct occurred;

7 (b) The nature of the conduct and the context in which it occurred; and

8 (c) Any other relevant conduct of the applicant.

9 (7) An athlete agent may apply to renew a registration by submitting an application for renewal  
 10 in a form prescribed by the department. The application for renewal must be signed by the applicant  
 11 under penalty of perjury and must contain current information on all matters required in an original  
 12 registration.

13 (8) An individual who has submitted an application for renewal of registration or licensure in  
 14 another state, in lieu of submitting an application for renewal in the form prescribed pursuant to  
 15 subsection (7) of this section, may file a copy of the application for renewal and a valid certificate  
 16 of registration or licensure from the other state. **The department shall renew the registration**  
 17 **if the department determines:**

18 (a) **The registration requirements of the other state are substantially similar to or more**  
 19 **restrictive than ORS 702.005 to 702.065, 702.991 and 702.994; and**

20 (b) **The renewed registration has not been suspended or revoked and no action involving**  
 21 **the individual’s conduct as an athlete agent is pending against the individual or the**  
 22 **individual’s registration in any state.** *[The department shall accept the application for renewal from*  
 23 *the other state as an application for renewal in Oregon if the application to the other state:]*

24 *[(a) Was submitted in the other state within the preceding six months and the applicant certifies*  
 25 *that the information contained in the application for renewal is current;]*

26 *[(b) Contains information substantially similar to or more comprehensive than that required in an*  
 27 *application for renewal submitted in Oregon; and]*

28 *[(c) Was signed by the applicant under penalty of perjury.]*

29 (9) A certificate of registration or a renewal of a registration is valid for two years.

30 (10) The department may suspend, revoke or refuse to renew a registration for conduct that  
 31 would have justified denial of registration under subsection (5) of this section.

32 (11) The department may deny, suspend, revoke or refuse to renew a certificate of registration  
 33 or licensure only after proper notice and an opportunity for a hearing.

 35 **APPLICATION FORM**

36  
 37 **SECTION 4.** ORS 702.017 is amended to read:

38 702.017. (1) An applicant for registration **as an athlete agent** shall submit an application for  
 39 registration to the Department of Education in a form prescribed by the department and, if re-  
 40 quested by the department, shall allow the department to take fingerprints for the purpose of re-  
 41 questing a state or nationwide criminal records check under ORS 181A.195.

42 (2) The application must be in the name of an individual and, except as otherwise provided in  
 43 subsection (3) of this section, signed or otherwise authenticated by the applicant under penalty of  
 44 perjury. The application must state or contain:

45 (a) The name of the applicant and the address of the applicant’s principal place of business;

- 1       **(b) The applicant’s date of birth and place of birth;**  
 2       **(c) The following contact information for the applicant:**  
 3       **(A) Cellular and work telephone numbers; and**  
 4       **(B) Any means of electronic communication, including a facsimile number, electronic**  
 5 **mail address and personal, business or employer website addresses;**  
 6       **[(b)] (d) The following information about the applicant’s business or employer, if applica-**  
 7 **ble:**  
 8       **(A) Name, address and telephone numbers** *[of the applicant’s business or employer, if applica-*  
 9 *ble];*  
 10       **(B) The nature of the business; and**  
 11       **(C) The type of organization;**  
 12       **(e) Each social media account with which the applicant or applicant’s business or em-**  
 13 **ployer is affiliated;**  
 14       **[(c)] (f) Any business or occupation engaged in by the applicant for the five years preceding the**  
 15 **date of submission of the application, including self-employment and employment by others, and**  
 16 **any professional or occupational license, registration or certification held by the applicant**  
 17 **during that time;**  
 18       **[(d)] (g) A description of the applicant’s:**  
 19       **(A) Formal training as an athlete agent;**  
 20       **(B) Practical experience as an athlete agent; and**  
 21       **(C) Educational background relating to the applicant’s activities as an athlete agent;**  
 22       **[(e)] (h) The names and addresses of three individuals not related to the applicant who are**  
 23 **willing to serve as references;**  
 24       **[(f)] (i) The name, sport and last known team for each individual for whom the applicant acted**  
 25 **as an athlete agent during the five years preceding the date of submission of the application;**  
 26       **[(g)] (j) The names and addresses of all persons who are:**  
 27       **[(A) With respect to the athlete agent’s business if the business is not a corporation, the partners,**  
 28 **members, officers, managers, associates or profit sharers of the business; and]**  
 29       **[(B) With respect to a corporation employing the athlete agent, the officers, directors and any**  
 30 **shareholder of the corporation having an interest of five percent or more;]**  
 31       **(A) A partner, member, officer, manager, associate or profit sharer of the athlete agent’s**  
 32 **business or who directly or indirectly hold an equity interest of five percent or greater of the**  
 33 **athlete agent’s business if the business is not a corporation; and**  
 34       **(B) An officer or director of a corporation employing the athlete agent or a shareholder**  
 35 **having an interest of five percent or greater in the corporation;**  
 36       **(k) A description of the status of any application by the applicant, or any person named**  
 37 **under paragraph (j) of this subsection, for a state or federal business, professional or occu-**  
 38 **pational license, other than as an athlete agent, from a state or federal agency, including any**  
 39 **denial, refusal to renew, suspension, withdrawal or termination of the license and any**  
 40 **reprimand or censure related to the license;**  
 41       **[(h)] (L) Whether the applicant or any person named pursuant to paragraph [(g)] (j) of this**  
 42 **subsection has pleaded guilty or no contest to, has been convicted of, or has charges pending**  
 43 **for** *[been convicted of]* **a crime that, if committed in Oregon, would be a crime involving moral**  
 44 **turpitude or a felony, and if so, [identify the crime] identification of the following[;]:**  
 45       **(A) The name of the crime;**

1 **(B) The law enforcement agency involved; and**

2 **(C) If applicable, the date of conviction and penalty imposed;**

3 [(i)] **(m)** Whether there has been any administrative or judicial determination that the applicant  
4 or any person named pursuant to paragraph [(g)] **(j)** of this subsection has made a false, misleading,  
5 deceptive or fraudulent representation;

6 [(j)] **(n)** Whether there has been any denial of an application for, suspension or revocation of,  
7 [or] refusal to renew **or abandonment of** the registration or licensure of the applicant or any per-  
8 son named pursuant to paragraph [(g)] **(j)** of this subsection as an athlete agent in any state;

9 [(k)] **(o)** Any sanction, suspension or disciplinary action taken against the applicant or any  
10 person named pursuant to paragraph [(g)] **(j)** of this subsection arising out of occupational or pro-  
11 fessional conduct; [and]

12 [(L)] **(p)** Any instance in which the conduct of the applicant or any person named pursuant to  
13 paragraph [(g)] **(j)** of this subsection resulted in the imposition of a sanction, suspension or decla-  
14 ration of ineligibility to participate in an interscholastic, [or] Intercollegiate **or professional** ath-  
15 letic event on a student athlete or **an** educational institution[.];

16 **(q) The name of each student athlete for whom the applicant acted as an athlete agent**  
17 **for the five years preceding the date of submission of the application or, if the athlete is a**  
18 **minor, the name of the parent or guardian of the athlete, together with the athlete's sport**  
19 **and last known team;**

20 **(r) Whether, within the 15 years preceding the date of submission of the application, the**  
21 **applicant, or any person named pursuant to paragraph (j) of this subsection, has been a de-**  
22 **fendant or respondent in a civil proceeding, including a proceeding seeking an adjudication**  
23 **of incompetence, and, if so, the date and a full explanation of each proceeding;**

24 **(s) Whether the applicant, or any person named under paragraph (j) of this subsection,**  
25 **has an unsatisfied judgment or order or a judgment of continuing effect for spousal support**  
26 **or child support and the applicant or person is in arrears as of the date of the application;**

27 **(t) Whether, within the 10 years preceding the date of submission of the application, the**  
28 **applicant, or any person named pursuant to paragraph (j) of this subsection, was adjudicated**  
29 **as bankrupt or was an owner of a business that was adjudicated as bankrupt;**

30 **(u) Each state in which the applicant currently is registered as an athlete agent or has**  
31 **applied to be registered as an athlete agent;**

32 **(v) If the applicant is certified or registered by a professional league or player's associ-**  
33 **ation:**

34 **(A) The name of the league or association;**

35 **(B) The date of certification or registration, and the date of expiration of the certification**  
36 **or registration, if any; and**

37 **(C) If applicable, the date of any denial of an application for, suspension or revocation**  
38 **of, refusal to renew, withdrawal of, or termination of, the certification or registration or any**  
39 **reprimand or censure related to the certification or registration; and**

40 **(w) Any other information required by the department.**

41 [(3) *An individual who has submitted an application for and holds a certificate of registration or*  
42 *licensure as an athlete agent in another state may submit a copy of the application and certificate in*  
43 *lieu of submitting an application in the form prescribed pursuant to subsection (2) of this section. The*  
44 *department shall accept the application and the certificate from the other state as an application for*  
45 *registration in Oregon if the application to the other state:]*

1           [(a) Was submitted in the other state within the preceding six months and the applicant certifies  
2 that the information contained in the application is current;]

3           [(b) Contains information substantially similar to or more comprehensive than that required in an  
4 application submitted in Oregon; and]

5           [(c) Was signed by the applicant under penalty of perjury.]

6           **(3) Instead of proceeding under subsection (2) of this section, an individual registered as  
7 an athlete agent in another state may apply for registration as an athlete agent in this state  
8 by submitting to the department:**

9           **(a) A copy of the application for registration in the other state;**

10           **(b) A statement that identifies any material change in the information on the application  
11 or verifies there is no material change in the information, signed under penalty of perjury;  
12 and**

13           **(c) A copy of the certificate of registration from the other state.**

14           **(4) The department shall issue a certificate of registration to an individual who applies  
15 for registration under subsection (3) of this section if the department determines:**

16           **(a) The application and registration requirements of the other state are substantially  
17 similar to or more restrictive than ORS 702.005 to 702.065, 702.991 and 702.994; and**

18           **(b) The registration has not been suspended or revoked and no action involving the  
19 individual's conduct as an athlete agent is pending against the individual or the individual's  
20 registration in any state.**

21           **(5) For purposes of implementing subsection (4) of this section, the department shall:**

22           **(a) Cooperate with national organizations concerned with athlete agent issues and agen-  
23 cies in other states that register athlete agents to develop a common registration form and  
24 determine which states have laws that are substantially similar to or more restrictive than  
25 ORS 702.005 to 702.065, 702.991 and 702.994; and**

26           **(b) Exchange information, including information related to actions taken against regis-  
27 tered athlete agents or their registrations, with those organizations and agencies.**

28  
29   **CONTRACT REQUIREMENTS**

30  
31           **SECTION 5.** ORS 702.047 is amended to read:

32           702.047. (1) A written agency contract must be in a record, signed or otherwise authenticated  
33 by the parties.

34           (2) A written agency contract must state or contain:

35           (a) The amount and method of calculating the consideration to be paid by the student athlete  
36 for services to be provided by the athlete agent under the contract and any other consideration the  
37 athlete agent has received or will receive from any other source for entering into the contract or  
38 for providing the services;

39           (b) The name of any person not listed in the application for registration or renewal of registra-  
40 tion who will be compensated because the student athlete **or, if the athlete is a minor, the parent**  
41 **or guardian of the athlete** signed the written agency contract;

42           (c) A description of any expenses that the student athlete agrees to reimburse;

43           (d) A description of the services to be provided to the student athlete;

44           (e) The duration of the contract; [and]

45           (f) The date of execution[.]; **and**



1 (g) A statement that the athlete agent is registered as an athlete agent in this state and  
2 a list of any other states in which the agent is registered as an athlete agent.

3 (3) A written agency contract must contain, in close proximity to the signature of the student  
4 athlete or, if the athlete is a minor, the signature of the parent or guardian of the athlete,  
5 a conspicuous notice in boldfaced type in capital letters stating:

10 IF YOU [SIGN] OR YOUR PARENT OR GUARDIAN SIGNS THIS CONTRACT:

11 (1) YOU MAY LOSE YOUR ELIGIBILITY TO COMPETE AS A STUDENT ATHLETE IN  
12 YOUR SPORT.

13 (2) IF YOU HAVE AN ATHLETIC DIRECTOR, BOTH YOU AND YOUR ATHLETE AGENT  
14 MUST NOTIFY YOUR ATHLETIC DIRECTOR WITHIN 72 HOURS AFTER ENTERING INTO  
15 THIS CONTRACT, OR BEFORE YOU PARTICIPATE IN ANY INTERSCHOLASTIC OR  
16 INTERCOLLEGIATE SPORTS EVENT, WHICHEVER OCCURS FIRST, THAT YOU HAVE EN-  
17 TERED INTO THIS CONTRACT AND PROVIDE THE NAME AND CONTACT INFORMA-  
18 TION OF THE ATHLETE AGENT.

19 (3) YOU MAY CANCEL THIS CONTRACT WITHIN 14 DAYS AFTER SIGNING IT. CANCEL-  
20 LATION OF THIS CONTRACT MAY NOT REINSTATE YOUR ELIGIBILITY.

23 (4) A written agency contract that does not conform to this section is voidable by the student  
24 athlete or, if the athlete is a minor, the parent or guardian of the athlete. *[If a student athlete*  
25 *voids a written agency contract under this subsection, the student athlete is not required to pay any*
