

Senate Bill 50

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Kate Brown for Oregon Health Authority)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires certain health care professionals and persons holding certificate of certified alcohol drug counselor to complete pain management education once every four years.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 413.590 is amended to read:

5 413.590. (1)(a) A [*physician assistant licensed under ORS chapter 677, a nurse licensed under ORS*

11 *ORS 413.572.] **person authorized to practice one of the following professions must complete***
12 **the pain management education program described in ORS 413.572 once every four years:**

13 **(A) A physician assistant licensed under ORS chapter 677;**

14 **(B) A nurse licensed under ORS chapter 678;**

15 **(C) A psychologist licensed under ORS 675.010 to 675.150;**

16 **(D) A chiropractic physician licensed under ORS chapter 684;**

17 **(E) A naturopathic physician licensed under ORS chapter 685;**

18 **(F) An acupuncturist licensed under ORS 677.759;**

19 **(G) A pharmacist licensed under ORS chapter 689;**

20 **(H) A pharmacy technician licensed under ORS chapter 689;**

21 **(I) A dentist licensed under ORS chapter 679;**

22 **(J) An occupational therapist licensed under ORS 675.210 to 675.340;**

23 **(K) A physical therapist licensed under ORS 688.010 to 688.201;**

24 **(L) An optometrist licensed under ORS chapter 683;**

25 **(M) A clinical social worker licensed under ORS 675.530;**

26 **(N) A professional counselor licensed under ORS 675.715;**

27 **(O) A marriage and family therapist licensed under ORS 675.715;**

28 **(P) A massage therapist licensed under ORS 687.011 to 687.250;**

29 **(Q) An expanded practice dental hygienist who holds a permit issued under ORS 680.200;**

1 **(R) A speech-language pathologist licensed under ORS chapter 681.**

2 **(b) A person who holds a certificate of certified alcohol drug counselor from the Ad-**
3 **diction Counselor Certification Board of Oregon or its successor organization must complete**
4 **the pain management education program described in ORS 413.572 once every four years.**

5 (2) The Oregon Medical Board, in consultation with the Pain Management Commission, shall
6 identify by rule physicians licensed under ORS chapter 677 who, on an ongoing basis, treat patients
7 in chronic or terminal pain and who must complete *[one]* **the** pain management education program
8 established under ORS 413.572. The board may identify by rule circumstances under which the re-
9 quirement under this section may be waived.

10 **(3) Any state board that regulates a person authorized to practice one of the professions**
11 **listed in subsection (1)(a) of this section may impose any form of discipline on a person under**
12 **the laws of this state for violating this section.**
