

Senate Bill 510

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires insurance companies to enter into agreements with Department of Justice to provide information and financial records to department for claimants who are obligors of past due support.

2 Relating to automated data exchanges between the Department of Justice and financial institutions;
3 amending ORS 25.640, 25.643 and 25.646.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 25.640 is amended to read:

6 25.640. For purposes of ORS 25.643 and 25.646:

7 (1) "Account" means a demand deposit account, checking or negotiable withdrawal order ac-
8 count, savings account, share draft account, time deposit account, [*or*] money-market mutual fund
9 account **or a claim for insurance benefits or payments made by a claimant under an insur-**
10 **ance policy issued by an insurance company authorized to do business in this state.**

11 (2) "Claimant" means an obligor who is entitled to make or has made a claim for insur-
12 **ance benefits or payments under a policy of insurance issued by an insurance company that**
13 **is authorized to do business in this state.**

14 [(2)] (3) "Customer" has the meaning given that term in ORS 192.583.

15 [(3)] (4) "Financial institution" means:

16 (a) A depository institution, as defined in section 3(c) of the Federal Deposit Insurance Act (12
17 U.S.C. 1813(c));

18 (b) Any federal credit union or state credit union, as defined in section 101 of the Federal Credit
19 Union Act (12 U.S.C. 1752), including an institution-affiliated party of such a credit union, as de-
20 fined in section 206(r) of the Federal Credit Union Act (12 U.S.C. 1786(r)); and

21 (c) Any benefit association, insurance company, safe deposit company, money-market mutual
22 fund or similar entity authorized to do business in [*the*] **this** state.

23 [(4)] (5) "Financial records" [*has the meaning given that term in ORS 192.583*] **means any ori-**
24 **ginal written or electronic document or copy of the document, or any information contained**
25 **in the document, held by or in the custody of a financial institution, when the document,**
26 **copy or information is identifiable as pertaining to one or more customers or claimants of**
27 **the financial institution.**

28 **SECTION 2.** ORS 25.643 is amended to read:

29 25.643. (1) The Department of Justice and financial institutions doing business in this state shall
30 enter into agreements to develop and operate a data match system using automated data exchanges

1 to the maximum extent feasible.

2 (2) Pursuant to the agreements, financial institutions shall provide, for each calendar quarter,
 3 the name, address, Social Security number or other taxpayer identification number and other iden-
 4 tifying information for each obligor who:

5 (a) Maintains an account at, **or has a claim for insurance benefits or payments with**, the
 6 institution; and

7 (b) Owes past due support, as identified by the administrator by name and Social Security
 8 number or other taxpayer identification number.

9 (3) The administrator shall pay a reasonable fee to a financial institution for conducting the data
 10 match provided for in this section. The fee may not exceed the actual costs incurred by the financial
 11 institution.

12 (4) A financial institution, including an institution-affiliated party as defined in section 3(u) of
 13 the Federal Deposit Insurance Act (12 U.S.C. 1813(u)), is not liable under any state law to any per-
 14 son:

15 (a) For any disclosure of information to the administrator under this section;

16 (b) For encumbering or surrendering any assets held by the financial institution in response to
 17 a notice of lien or levy issued by the administrator; or

18 (c) For any other action taken in good faith to comply with the requirements of this section.

19 **(5) The department may adopt rules to implement and direct the provision of information**
 20 **pursuant to the agreements entered into for automated data exchanges performed by the**
 21 **data match system developed and operated under this section.**

22 **SECTION 3.** ORS 25.646 is amended to read:

23 25.646. (1) Upon request of the administrator and the receipt of the certification required under
 24 subsection (2) of this section, a financial institution shall provide financial records of a customer
 25 **or claimant.**

26 (2) In requesting information under subsection (1) of this section, the administrator shall provide
 27 the name and Social Security number of the person whose financial records are sought and shall
 28 state with reasonable specificity the financial records requested. The administrator shall provide to
 29 the financial institution a signed document in a form established by the Department of Justice cer-
 30 tifying that:

31 (a) The person whose financial records are sought is a party to a proceeding to establish, modify
 32 or enforce the child support obligation of the person; and

33 (b) The administrator has authorization from the person for release of the financial records, has
 34 given the person written notice of its request for financial records or will give the notice within five
 35 days after the financial institution responds to the request.

36 (3) The administrator shall reimburse a financial institution supplying financial records under
 37 this section for actual costs incurred.

38 (4) A financial institution, including an institution-affiliated party as defined in section 3(u) of
 39 the Federal Deposit Insurance Act (12 U.S.C. 1813(u)), that supplies financial records to the admin-
 40 istrator under this section is not liable to any person for any loss, damage or injury arising out of
 41 or in any way pertaining to the disclosure of the financial records.

42 (5) A financial institution that is requested to supply financial records under this section may
 43 enter into an agreement with the administrator concerning the method by which requests for fi-
 44 nancial records and responses from the financial institution shall be made.

45 (6) The administrator shall provide a reasonable time to the financial institution for responding

1 to a request for financial records.

2 (7) The administrator shall seek financial records under this section only:

3 (a) With respect to a person who is a party to a proceeding to establish, modify or enforce the
4 child support obligation of the person; or

5 (b) According to the provisions of ORS 25.083.
