8 **“SECTION 1. Section 2 of this 2017 Act is added to and made part of ORS chapter 109.**

9 **“SECTION 2. (1) Parentage may be established between a person and a child by:**

10 **“(a) The person having given birth to the child;**

11 **“(b) An un rebutted presumption of parentage under ORS 109.070;**

12 **“(c) An adjudication of the person’s maternity or paternity;**

13 **“(d) Adoption of the child by the person;**

14 **“(e) An effective acknowledgement of paternity by the man under ORS 109.070 or pursu-**
15 **ant to the laws of another state, unless the acknowledgement has been rescinded or suc-**
16 **cessfully challenged;**

17 **“(f) Establishment of paternity by an administrative order issued pursuant to ORS**
18 **chapter 416;**

19 **“(g) Filiation proceedings; or**

20 **“(h) Parentage being established or declared by another provision of law.**

21 **“(2) A person is the mother of a child to whom the person gives birth.**

22 **“SECTION 3. ORS 109.070, as amended by section 42, chapter 106, Oregon Laws 2016, is**
23 **amended to read:**

24 **“109.070. (1) The [*paternity*] **parentage** of a person [*may be established as follows*] **is rebuttably****
25 **presumed if:**

26 **“(a) [A man is rebuttably presumed to be the father of a child born to a woman if he and the**
27 **woman were married to each other] **The person is married to the birth mother** at the time of the**
28 **child’s birth, without a judgment of separation, regardless of whether the marriage is void.**

29 **“(b) [A man is rebuttably presumed to be the father of a child born to a woman if he and the**
30 **woman were married to each other] **The person is married to the birth mother** and the child is**
31 **born within 300 days after the marriage is terminated by death, annulment or dissolution or after**
32 **entry of a judgment of separation.**

33 **“[(c) *By the marriage of the parents of a child after the birth of the child, and the parents filing***
34 ***with the State Registrar of the Center for Health Statistics the voluntary acknowledgment of paternity***
35 ***form as provided for by ORS 432.098.*]**

1 “(d) *By filiation proceedings.*]

2 “(e) *By filing with the State Registrar of the Center for Health Statistics the voluntary acknowl-*
3 *edgment of paternity form as provided for by ORS 432.098. Except as otherwise provided in subsections*
4 *(4) to (7) of this section, this filing establishes paternity for all purposes.*]

5 “(f) *By having established paternity through a voluntary acknowledgment of paternity process in*
6 *another state.*]

7 “(g) *By paternity being established or declared by other provision of law.*]

8 “(2) The *[paternity]* **parentage** of a child established under subsection (1)(a) or [(c)] **(4)(a)** of this
9 section may be challenged in an action or proceeding by *[the husband or wife]* **either spouse**. The
10 *[paternity]* **parentage** may not be challenged by a person other than *[the husband or wife]* **a spouse**
11 as long as the *[husband and wife]* **spouses** are married and **are** cohabiting, unless *[the husband and*
12 *wife]* **both spouses** consent to the challenge.

13 “(3) If the court finds that it is just and equitable, giving consideration to the interests of the
14 parties and the child, the court shall admit evidence offered to rebut the presumption of *[paternity]*
15 **parentage** in subsection (1)[(a) or (b)] of this section.

16 “(4) **The paternity of a person may be established by a voluntary acknowledgement as**
17 **follows:**

18 “(a) **By the marriage of the parents of a child after the birth of the child, and the parents**
19 **filing with the State Registrar of the Center for Health Statistics the voluntary acknowl-**
20 **edgment of paternity form as provided by ORS 432.098.**

21 “(b) **By filing with the State Registrar of the Center for Health Statistics the voluntary**
22 **acknowledgement of paternity form as provided under ORS 432.098. Except as otherwise**
23 **provided in subsections (5) and (8) of this section, a filing under this paragraph establishes**
24 **paternity for all purposes.**

25 “(c) **By establishment of paternity through a voluntary acknowledgement of paternity in**
26 **another state.**

27 “[(4)(a)] **(5)(a)** A party to a voluntary acknowledgment of paternity may rescind the acknowl-
28 edgment within the earlier of:

29 “(A) Sixty days after filing the acknowledgment; or

30 “(B) The date of a proceeding relating to the child, including a proceeding to establish a support
31 order, in which the party wishing to rescind the acknowledgment is also a party. For the purposes
32 of this subparagraph, the date of a proceeding is the date on which an order is entered in the pro-
33 ceeding.

34 “(b) To rescind the acknowledgment, the party shall sign and file with the State Registrar of the
35 Center for Health Statistics a written document declaring the rescission.

36 “[(5)(a)] **(6)(a)** A signed voluntary acknowledgment of paternity filed in this state may be chal-
37 lenged and set aside in circuit court at any time after the 60-day period referred to in subsection
38 [(4)] **(5)** of this section on the basis of fraud, duress or a material mistake of fact.

39 “(b) The challenge may be brought by:

40 “(A) A party to the acknowledgment;

41 “(B) The child named in the acknowledgment; or

42 “(C) The Department of Human Services or the administrator, as defined in ORS 25.010, if the
43 child named in the acknowledgment is in the care and custody of the department under ORS chapter
44 419B and the department or the administrator reasonably believes that the acknowledgment was
45 signed because of fraud, duress or a material mistake of fact.

1 “(c) The challenge shall be initiated by filing a petition with the circuit court. Unless otherwise
2 specifically provided by law, the challenge shall be conducted pursuant to the Oregon Rules of Civil
3 Procedure.

4 “(d) The party bringing the challenge has the burden of proof.

5 “(e) Legal responsibilities arising from the acknowledgment, including child support obligations,
6 may not be suspended during the challenge, except for good cause.

7 “(f) If the court finds by a preponderance of the evidence that the acknowledgment was signed
8 because of fraud, duress or material mistake of fact, the court shall set aside the acknowledgment
9 unless, giving consideration to the interests of the parties and the child, the court finds that setting
10 aside the acknowledgment would be substantially inequitable.

11 “[6] (7) Within one year after a voluntary acknowledgment of paternity form is filed in this
12 state and if blood tests, as defined in ORS 109.251, have not been completed, a party to the ac-
13 knowledgment, or the department if the child named in the acknowledgment is in the care and cus-
14 tody of the department under ORS chapter 419B, may apply to the administrator for an order for
15 blood tests in accordance with ORS 416.443.

16 “[(7)(a)] (8)(a) A voluntary acknowledgment of paternity is not valid if, before the party signed
17 the acknowledgment:

18 “(A) The party signed a consent to the adoption of the child by another individual;

19 “(B) The party signed a document relinquishing the child to a child-caring agency as defined in
20 ORS 418.205;

21 “(C) The party’s parental rights were terminated by a court; or

22 “(D) In an adjudication, the party was determined not to be the biological parent of the child.

23 “(b) Notwithstanding any provision of subsection [(1)(c) or (e)] (4)(a) or (b) of this section or
24 ORS 432.098 to the contrary, an acknowledgment signed by a party described in this subsection and
25 filed with the State Registrar of the Center for Health Statistics does not establish paternity and is
26 void.

27 “**SECTION 4.** ORS 109.239 is amended to read:

28 “109.239. (1) **As used in ORS 109.239 to 109.247, ‘assisted reproduction’ means a method**
29 **of causing pregnancy other than sexual intercourse. ‘Assisted reproduction’ includes, but is**
30 **not limited to:**

31 “(a) **Artificial insemination as defined in ORS 677.355;**

32 “(b) **Donation of eggs;**

33 “(c) **Donation of embryos;**

34 “(d) **In vitro fertilization and transfer of embryos; or**

35 “(e) **Intracytoplasmic sperm injection.**

36 “(2) If the donor of [semen] **gametes** used in [artificial insemination] **assisted reproduction** is
37 not the mother’s [husband] **spouse:**

38 “[1] (a) [Such] **The** donor shall have no right, obligation or interest with respect to [a] **any**
39 child [born] **conceived** as a result of the [artificial insemination] **assisted reproduction;** and

40 “[2] (b) [A] **Any** child [born] **conceived** as a result of the [artificial insemination] **assisted**
41 **reproduction** shall have no right, obligation or interest with respect to [such] **the** donor.

42 “**SECTION 5.** ORS 109.243 is amended to read:

43 “109.243. The relationship, rights and obligation between a child [born] **conceived** as a result
44 of [artificial insemination] **assisted reproduction** and the mother’s [husband] **spouse** shall be the
45 same to all legal intents and purposes as if the child had been naturally and legitimately conceived

1 by the mother and the mother's [*husband*] **spouse** if the [*husband*] **spouse** consented to the per-
2 formance of [*artificial insemination*] **assisted reproduction**.

3 **"SECTION 6.** ORS 109.247 is amended to read:

4 "109.247. Except as may be otherwise provided by a judicial decree entered in any action filed
5 before October 4, 1977, the provisions of ORS 109.239 to 109.247, 677.355 to 677.365 and 677.990 (3)
6 apply to all persons conceived as a result of [*artificial insemination*] **assisted reproduction**.

7 **"SECTION 7.** ORS 416.400 is amended to read:

8 "416.400. As used in ORS 416.400 to 416.465, unless the context requires otherwise:

9 "(1) 'Administrator' has the meaning given that term in ORS 25.010.

10 "(2) 'Court' means any circuit court of this state and any court in another state having juris-
11 diction to determine the liability of persons for the support of another person.

12 "(3) 'Court order' means any judgment or order of any Oregon court that orders payment of a
13 set or determinable amount of support money by the subject parent and does not include an order
14 or judgment in any proceeding in which the court did not order support.

15 "(4) 'Department' means the Department of Justice of this state or its equivalent in any other
16 state from which a written request for establishment or enforcement of a support obligation is re-
17 ceived under ORS 416.415.

18 "(5) 'Dependent child' means any person under the age of 18 who is not otherwise emancipated,
19 self-supporting, married or a member of the Armed Forces of the United States. 'Dependent child'
20 also means a child attending school as defined in ORS 107.108.

21 "(6) 'Office' means the office of the Division of Child Support or the office of the district attor-
22 ney.

23 "(7) 'Parent' means:

24 **"(a)** The natural or adoptive father or mother of a dependent child or youth offender[.];

25 **"(b) A person whose parentage has been established under section 2 of this 2017 Act; or**

26 **"(c)** [*Parent* also means] **A** stepparent when the person has an obligation to support a depend-
27 ent child under ORS 108.045.

28 "(8) 'Past support' means the amount of child support that could have been ordered and accu-
29 mulated as arrears against a parent for the benefit of a child for any period of time during which
30 the child was not supported by the parent and for which period no support order was in effect.

31 "(9) 'Public assistance' means any money payments made by the state that are paid to or for the
32 benefit of any dependent child or youth offender, including but not limited to payments made so that
33 food, shelter, medical care, clothing, transportation or other necessary goods, services or items may
34 be provided, and payments made in compensation for the provision of the necessities. 'Public as-
35 sistance' does not include money payments made by the state to or for the benefit of a dependent
36 child as the result of the child's removal from the parent's home against the wishes of the parent,
37 if the Department of Human Services determines after completion of a child protective services as-
38 sessment that the report of abuse is unfounded according to rules adopted by the Department of
39 Human Services.

40 "(10) 'Youth offender' has the meaning given that term in ORS 419A.004.

41 **"SECTION 8.** ORS 25.020 is amended to read:

42 "25.020. (1) Support payments for or on behalf of any person that are ordered, registered or filed
43 under this chapter or ORS chapter 107, 108, 109, 110, 416, 419B or 419C, unless otherwise authorized
44 by ORS 25.030, shall be made to the Department of Justice as the state disbursement unit:

45 "(a) During periods for which support is assigned under ORS 412.024, 418.032, 419B.406 or

1 419C.597;

2 “(b) As provided by rules adopted under ORS 180.345, when public assistance is provided to a
3 person who receives or has a right to receive support payments on the person’s own behalf or on
4 behalf of another person;

5 “(c) After the assignment of support terminates for as long as amounts assigned remain owing;

6 “(d) For any period during which support enforcement services are provided under ORS 25.080;

7 “(e) When ordered by the court under ORS 419B.400;

8 “(f) When a support order that is entered or modified on or after January 1, 1994, includes a
9 provision requiring the obligor to pay support by income withholding; or

10 “(g) When ordered by the court under any other applicable provision of law.

11 “(2)(a) The Department of Justice shall disburse payments, after lawful deduction of fees and in
12 accordance with applicable statutes and rules, to those persons and entities that are lawfully enti-
13 tled to receive such payments.

14 “(b) During a period for which support is assigned under ORS 412.024, for an obligee described
15 in subsection (1)(b) of this section, the department shall disburse to the obligee, from child support
16 collected each month, \$50 for each child up to a maximum of \$200 per family.

17 “(3)(a) When the administrator is providing support enforcement services under ORS 25.080, the
18 obligee may enter into an agreement with a collection agency, as defined in ORS 697.005, for as-
19 sistance in collecting child support payments.

20 “(b) The Department of Justice:

21 “(A) Shall disburse support payments, to which the obligee is legally entitled, to the collection
22 agency if the obligee submits the completed form referred to in paragraph (c)(A) of this subsection
23 to the department;

24 “(B) May reinstate disbursements to the obligee if:

25 “(i) The obligee requests that disbursements be made directly to the obligee;

26 “(ii) The collection agency violates any provision of this subsection; or

27 “(iii) The Department of Consumer and Business Services notifies the Department of Justice that
28 the collection agency is in violation of the rules adopted under ORS 697.086;

29 “(C) Shall credit the obligor’s account for the full amount of each support payment received by
30 the department and disbursed to the collection agency; and

31 “(D) Shall develop the form referred to in paragraph (c)(A) of this subsection, which shall in-
32 clude a notice to the obligee printed in type size equal to at least 12-point type that the obligee may
33 be eligible for support enforcement services from the department or the district attorney without
34 paying the interest or fee that is typically charged by a collection agency.

35 “(c) The obligee shall:

36 “(A) Provide to the department, on a form approved by the department, information about the
37 agreement with the collection agency; and

38 “(B) Promptly notify the department when the agreement is terminated.

39 “(d) The collection agency:

40 “(A) May provide investigative and location services to the obligee and disclose relevant infor-
41 mation from those services to the administrator for purposes of providing support enforcement ser-
42 vices under ORS 25.080;

43 “(B) May not charge interest or a fee for its services exceeding 29 percent of each support
44 payment received unless the collection agency, if allowed by the terms of the agreement between
45 the collection agency and the obligee, hires an attorney to perform legal services on behalf of the

1 obligee;

2 “(C) May not initiate, without written authorization from the administrator, any enforcement
3 action relating to support payments on which support enforcement services are provided by the ad-
4 ministrator under ORS 25.080; and

5 “(D) Shall include in the agreement with the obligee a notice printed in type size equal to at
6 least 12-point type that provides information on the fees, penalties, termination and duration of the
7 agreement.

8 “(e) The administrator may use information disclosed by the collection agency to provide sup-
9 port enforcement services under ORS 25.080.

10 “(4) The Department of Justice may immediately transmit to the obligee payments received from
11 any obligor without waiting for payment or clearance of the check or instrument received if the
12 obligor has not previously tendered any payment by a check or instrument that was not paid or was
13 dishonored.

14 “(5) The Department of Justice shall notify each obligor and obligee by mail when support pay-
15 ments shall be made to the department and when the obligation to make payments in this manner
16 shall cease.

17 “(6)(a) The administrator shall provide information about a child support account directly to a
18 party to the support order regardless of whether the party is represented by an attorney. As used
19 in this subsection, ‘information about a child support account’ means the:

20 “(A) Date of issuance of the support order.
21 “(B) Amount of the support order.
22 “(C) Dates and amounts of payments.
23 “(D) Dates and amounts of disbursements.
24 “(E) Payee of any disbursements.
25 “(F) Amount of any arrearage.
26 “(G) Source of any collection, to the extent allowed by federal law.

27 “(b) Nothing in this subsection limits the information the administrator may provide by law to
28 a party who is not represented by an attorney.

29 “(7) Any pleading for the entry or modification of a support order must contain a statement that
30 payment of support under a new or modified order will be by income withholding unless an excep-
31 tion to payment by income withholding is granted under ORS 25.396.

32 “(8)(a) Except as provided in paragraphs (d) and (e) of this subsection, a judgment or order es-
33 tablishing [*paternity*] **parentage** or including a provision concerning support must contain:

34 “(A) The residence, mailing or contact address, final four digits of the Social Security number,
35 telephone number and final four digits of the driver license number of each party;
36 “(B) The name, address and telephone number of all employers of each party;
37 “(C) The names and dates of birth of the joint children of the parties; and
38 “(D) Any other information required by rule adopted by the Chief Justice of the Supreme Court
39 under ORS 1.002.

40 “(b) The judgment or order shall also include notice that the obligor and obligee:

41 “(A) Must inform the court and the administrator in writing of any change in the information
42 required by this subsection within 10 days after the change; and
43 “(B) May request that the administrator review the amount of support ordered after three years,
44 or such shorter cycle as determined by rule of the Department of Justice, or at any time upon a
45 substantial change of circumstances.

1 “(c) The administrator may require of the parties any additional information that is necessary
2 for the provision of support enforcement services under ORS 25.080.

3 “(d)(A) Upon a finding, which may be made ex parte, that the health, safety or liberty of a party
4 or child would unreasonably be put at risk by the disclosure of information specified in this sub-
5 section or by the disclosure of other information concerning a child or party to a [*paternity*] **par-**
6 **entage** or support proceeding or if an existing order so requires, a court or administrator or
7 administrative law judge, when the proceeding is administrative, shall order that the information
8 not be contained in any document provided to another party or otherwise disclosed to a party other
9 than the state.

10 “(B) The Department of Justice shall adopt rules providing for similar confidentiality for infor-
11 mation described in subparagraph (A) of this paragraph that is maintained by an entity providing
12 support enforcement services under ORS 25.080.

13 “(e) The Chief Justice of the Supreme Court may, in consultation with the Department of Jus-
14 tice, adopt rules under ORS 1.002 to designate information specified in this subsection as confiden-
15 tial and require that the information be submitted through an alternate procedure to ensure that the
16 information is exempt from public disclosure under ORS 192.502.

17 “(9)(a) Except as otherwise provided in paragraph (b) of this subsection, in any subsequent child
18 support enforcement action, the court or administrator, upon a showing of diligent effort made to
19 locate the obligor or obligee, may deem due process requirements to be met by mailing notice to the
20 last-known residential, mailing or employer address or contact address as provided in ORS 25.085.

21 “(b) Service of an order directing an obligor to appear in a contempt proceeding is subject to
22 ORS 33.015 to 33.155.

23 “(10) Subject to ORS 25.030, this section, to the extent it imposes any duty or function upon the
24 Department of Justice, shall be deemed to supersede any provisions of ORS chapters 107, 108, 109,
25 110, 416, 419A, 419B and 419C that would otherwise impose the same duties or functions upon the
26 county clerk or the Department of Human Services.

27 “(11) Except as provided for in subsections (12), (13) and (14) of this section, credit may not be
28 given for payments not made to the Department of Justice as required under subsection (1) of this
29 section.

30 “(12) The Department of Justice shall give credit for payments not made to the department:

31 “(a) When payments are not assigned to this or another state and the obligee and obligor agree
32 in writing that specific payments were made and should be credited;

33 “(b) When payments are assigned to the State of Oregon, the obligor and obligee make sworn
34 written statements that specific payments were made, canceled checks or other substantial evidence
35 is presented to corroborate their statements and the obligee has been given prior written notice of
36 any potential criminal or civil liability that may attach to an admission of the receipt of assigned
37 support;

38 “(c) When payments are assigned to another state and that state verifies that payments not paid
39 to the department were received by the other state; or

40 “(d) As provided by rule adopted under ORS 180.345.

41 “(13) An obligor may apply to the Department of Justice for credit for payments made other
42 than to the Department of Justice. If the obligee or other state does not provide the agreement,
43 sworn statement or verification required by subsection (12) of this section, credit may be given
44 pursuant to order of an administrative law judge assigned from the Office of Administrative
45 Hearings after notice and opportunity to object and be heard are given to both obligor and obligee.

1 Notice shall be served upon the obligee as provided by ORS 25.085. Notice to the obligor may be
2 by regular mail at the address provided in the application for credit. A hearing conducted under this
3 subsection is a contested case hearing and ORS 183.413 to 183.470 apply. Any party may seek a
4 hearing de novo in the circuit court.

5 “(14) Nothing in this section precludes the Department of Justice from giving credit for pay-
6 ments not made to the department when there has been a judicially determined credit or satisfaction
7 or when there has been a satisfaction of support executed by the person to whom support is owed.

8 “(15) The Department of Justice shall adopt rules that:

9 “(a) Direct how support payments that are made through the department are to be applied and
10 disbursed; and

11 “(b) Are consistent with federal regulations.

12 “**SECTION 9.** ORS 25.075 is amended to read:

13 “25.075. (1) Notwithstanding the provisions of ORS 25.080, the Department of Justice may enter
14 into cooperative agreements with Indian tribes or tribal organizations within the borders of this
15 state, if the Indian tribe or tribal organization demonstrates that the tribe or organization has an
16 established tribal court system or a Court of Indian Offenses with the authority to:

17 “(a) Establish [*paternity*] **parentage**;

18 “(b) Establish, modify and enforce support orders; and

19 “(c) Enter support orders in accordance with child support guidelines established by the tribe
20 or organization.

21 “(2) The agreements must provide for the cooperative delivery of child support enforcement
22 services and for the forwarding of all child support collections pursuant to the functions performed
23 by the tribe or organization to the department, or conversely, by the department to the tribe or
24 organization, which shall distribute the child support collections in accordance with the agreement.

25 “**SECTION 10.** ORS 25.082 is amended to read:

26 “25.082. (1) When services are being provided under Title IV-D of the Social Security Act, the
27 enforcing agency of this or any other state may subpoena financial records and other information
28 needed to establish [*paternity*] **parentage** or to establish, modify or enforce a support order. The
29 subpoena may be served on a party or on a public or private entity. Service of the subpoena may
30 be by certified mail.

31 “(2) A party or public or private entity that discloses information to the enforcing agency in
32 compliance with a subpoena served under subsection (1) of this section is not liable to any person
33 for any loss, damage or injury arising out of the disclosure.

34 “(3) Upon request of an enforcing agency of another state, only a court or enforcing agency of
35 Oregon may enforce a subpoena issued by the enforcing agency of the other state.

36 “(4) Notwithstanding ORS 192.600, a party or public or private entity that fails without good
37 cause to comply with a subpoena issued under this section is subject to a civil penalty not to exceed
38 \$250. A civil penalty under this section must be imposed in the manner provided by ORS 183.745.

39 “(5) The Department of Justice shall adopt rules to implement the provisions of this section.

40 “**SECTION 11.** ORS 25.650 is amended to read:

41 “25.650. (1) As used in this section, ‘consumer reporting agency’ means any person that, for
42 monetary fees or dues or on a cooperative nonprofit basis, regularly engages in whole or in part in
43 the practice of assembling or evaluating consumer credit information or other information on con-
44 sumers for the purpose of furnishing consumer reports to third parties, and that uses any means or
45 facility of interstate commerce for the purpose of preparing or furnishing consumer reports.

1 “(2)(a) Notwithstanding any other law, and subject to rules established by the Department of
2 Justice, for cases in which there is past due support, the department shall:

3 “(A) Report periodically to consumer reporting agencies the name of any obligor who is delin-
4 quent in the payment of support and the amount owed by the obligor; and

5 “(B) Otherwise make available to a consumer reporting agency upon its request information
6 regarding the amount of past due support owed by an obligor.

7 “(b) The department shall provide advance notice to both the obligor and the obligee concerning
8 the proposed reporting of information to the consumer reporting agencies. The notice must inform
9 both parties:

10 “(A) Of the amount of the past due support the department will report to the consumer reporting
11 agencies;

12 “(B) That the department will continue to report the past due support amount owed without

14 “(C) Of the obligor’s right to request an administrative review within 30 days after the date of
15 the notice; and

16 “(D) Of the issues that may be considered on review.

17 “(c) If an obligor requests an administrative review, the department may not report the past due
18 support amount until the review is complete.

19 “(d) A party may appeal a decision from the administrative review under ORS 183.484. An appeal
20 of the decision does not stay the department from making reports to consumer reporting agencies.

21 “(3)(a) If [*paternity*] **parentage** has been established and a consumer report is needed for the
22 purpose of establishing or modifying a child support order, the administrator may request that a
23 consumer reporting agency provide a report.

24 “(b) At least 10 days prior to making a request under paragraph (a) of this subsection, the ad-
25 ministrator shall notify the obligor or obligee whose report is requested, by certified or registered

41 is being enforced by the administrator under the provisions of ORS 25.080 and that one or both of
42 the following conditions apply:

43 “(a) That the party holding the license, certificate, permit or registration is in arrears under any
44 child support judgment or order, in an amount equal to the greater of three months of support or
45 \$2,500, and:

1 “(A) Has not entered into an agreement with the administrator with respect to the child support
2 obligation; or

3 “(B) Is not in compliance with an agreement entered into with the administrator; or

4 “(b) That the party holding the license, certificate, permit or registration has failed, after re-
5 ceiving appropriate notice, to comply with a subpoena or other procedural order relating to a
6 [*paternity*] **parentage** or child support proceeding and:

7 “(A) Has not entered into an agreement with the administrator with respect to compliance; or

8 “(B) Is not in compliance with such an agreement.

9 “(2) The Department of Justice by rule shall specify the conditions and terms of agreements,
10 compliance with which precludes the suspension of the license, certificate, permit or registration.

11 “**SECTION 13.** ORS 107.179 is amended to read:

12 “107.179. (1) When either party to a child custody issue, other than one involving temporary
13 custody, whether the issue arises from a case of marital annulment, dissolution or separation, or
14 from a determination of [*paternity*] **parentage**, requests the court to grant joint custody of the minor
15 children of the parties under ORS 107.105, the court, if the other party objects to the request for
16 joint custody, shall proceed under this section. The request under this subsection must be made, in
17 the petition or the response, or otherwise not less than 30 days before the date of trial in the case,
18 except for good cause shown. The court in such circumstances, except as provided in subsection (3)
19 of this section, shall direct the parties to participate in mediation in an effort to resolve their dif-
20 ferences concerning custody. The court may order such participation in mediation within a medi-

40 “(3) If either party objects to mediation on the grounds that to participate in mediation would
41 subject the party to severe emotional distress and moves the court to waive mediation, the court
42 shall hold a hearing on the motion. If the court finds it likely that participation in mediation will
43 subject the party to severe emotional distress, the court may waive the requirement of mediation.

44 “(4) Communications made by or to a mediator or between parties as a part of mediation ordered
45 under this section are privileged and are not admissible as evidence in any civil or criminal pro-

1 ceeding.

2 “**SECTION 14.** ORS 107.425 is amended to read:

3 “107.425. (1) In suits or proceedings described in subsection (4) of this section in which there
4 are minor children involved, the court may cause an investigation to be made as to the character,
5 family relations, past conduct, earning ability and financial worth of the parties for the purpose of
6 protecting the children’s future interest. The court may defer the entry of a general judgment until
7 the court is satisfied that its judgment in such suit or proceeding will properly protect the welfare
8 of such children. The investigative findings shall be offered as and subject to all rules of evidence.
9 Costs of the investigation may be charged against one or more of the parties or as a cost in the
10 proceedings but shall not be charged against funds appropriated for public defense services.

11 “(2) The court, on its own motion or on the motion of a party, may order an independent phys-

13 children. However, if requested to do so by one or more of the children, the court shall appoint

6 “(b)(A) ‘*[Paternity]* **Parentage** judgment’ means a judgment or administrative order that:

7 “[A] (i) Expressly or by inference determines the *[paternity]* **parentage** of a child, or that im-
8 poses a child support obligation based on the *[paternity]* **parentage** of a child; and

9 “[B] (ii) Resulted from a proceeding in which blood tests were not performed and the issue of
10 *[paternity]* **parentage** was not challenged.

11 “(B) ‘**Parentage judgment**’ does not include a judgment or administrative order that de-

18 gations established in the *[paternity]* **parentage** judgment, and for a judgment of *[nonpaternity]*
19 **nonparentage**:

20 “(A) A party to the *[paternity]* **parentage** judgment.

21 “(B) The Department of Human Services if the child is in the care and custody of the Depart-
22 ment of Human Services under ORS chapter 419B.

23 “(C) The Division of Child Support of the Department of Justice if the child support rights of
24 the child or of one of the parties to the *[paternity]* **parentage** judgment have been assigned to the

26 “(b) The petitioner may file the petition in the circuit court proceeding in which the *[paternity]*
27 **parentage** judgment was entered, in a related proceeding or in a separate action. The petitioner

27 [109.070 (1)(d), (e), (f) or (g) or] 416.400 to 416.465 **or section 2 (1)(e) or (g) of this 2017 Act** shall
28 be included in the order, judgment or other declaration establishing paternity.

29 “**SECTION 18.** ORS 109.092 is amended to read:

30 “109.092. When it is determined that a woman is pregnant with a child, the woman and any man
31 to whom she is not married and with whom she engaged in sexual intercourse at approximately the
32 time of conception have an obligation to recognize that the man may be the other person responsible
33 for the conception. During the months of pregnancy, the man may join the woman in acknowledging
34 paternity and assuming the rights and duties of expectant parenthood. If the man acknowledges
35 paternity of the expected child and the woman denies that he is the father or refuses to join him in
36 acknowledging paternity, the man may seek relief under ORS 109.125. If the woman wants the man

2 of the child. The clerk of the court shall certify the fact of [*paternity*] **parentage** to the Center for

7 “109.096. (1) When the [*paternity*] **parentage** of a child has not been established under [*ORS*

9 or other court proceedings concerning the custody of the child, except for juvenile court pro-
10 ceedings, if the petitioner knows, or by the exercise of ordinary diligence should have known:

11 “(a) That the child resided with the putative father at any time during the 60 days immediately
12 preceding the initiation of the proceeding, or at any time since the child’s birth if the child is less
13 than 60 days old when the proceeding is initiated; or

5 “(b) Shall, if filiation proceedings are not pending, inquire as to the paternity of the child, the
6 putative father’s past endeavors to fulfill his obligation to support the child and to contribute to the
7 pregnancy-related medical expenses, the period that the child has lived with the putative father, the
8 putative father’s fitness to care for and rear the child and whether the putative father is willing to
9 be declared the father of the child and to assume the responsibilities of a father.

10 “(2) If after inquiry under subsection (1)(b) of this section the court finds:

11 “(a) That the putative father is the father of the child and is fit and willing to assume the re-
12 sponsibilities of a father, it shall have the power:

13 “(A) Upon the request of the putative father, to declare his paternity and to certify the fact of
14 paternity in the manner provided in ORS 109.094; and

15 “(B) To award custody of the child to [*the mother or the father*] **either parent** as may be in the
16 best interests of the child, or to take any other action which the court may take if the parents are
17 or were married to each other.

18 “(b) That the putative father is not the father of the child, it may grant the relief sought in the

27 “109.103. (1) If a child is born to an unmarried [*woman and paternity*] **person and parentage**
28 has been established under [*ORS 109.070*] **section 2 of this 2017 Act**, or if a child is born to a
29 married [*woman by a man*] **person by a person** other than [*her husband*] **the birth mother’s**
30 **spouse** and [*the man’s paternity*] **parentage between the person and the child** has been estab-

43 “(a) Whether there is pending in this state or any other jurisdiction any type of support pro-
44 ceeding involving the child, including one brought under ORS 109.100, 109.165, 125.025, 416.400 to
45 416.465, 419B.400 or 419C.590 or ORS chapter 110; and

1 “(b) Whether there exists in this state or any other jurisdiction a support order, as defined in
2 ORS 110.503, involving the child.

3 “(3) The parent shall include with the petition a certificate regarding any pending support pro-
4 ceeding and any existing support order. The parent shall use a certificate that is in a form estab-
5 lished by court rule and include information required by court rule and subsection (2) of this section.

6 “(4) When a parent initiates a proceeding under this section and the child support rights of one
7 of the parents or of the child have been assigned to the state, the parent initiating the proceeding
8 shall serve, by mail or personal delivery, a copy of the petition on the Administrator of the Division
9 of Child Support or on the branch office providing support services to the county in which the suit
10 is filed.

11 “(5)(a) After a petition is filed under this section and upon service of summons and petition upon
12 the respondent as provided in ORCP 7, a restraining order is issued and in effect against the

32 “109.145. If a respondent fails to answer or fails to appear at trial, the court shall have the
33 power to proceed accordingly. In such case, the court may make a determination of [*paternity*]
34 **parentage** and may impose such obligations on the respondent as it deems reasonable. In all such
35 cases corroborating evidence in addition to the testimony of the parent or expectant parent shall
36 be required to establish [*paternity*] **parentage** and the court may, in its discretion, order such in-
37 vestigation or the production of such evidence as it deems appropriate to establish a proper basis
38 for relief. The testimony of the parent or expectant parent and the corroborating evidence may be
39 presented by affidavit.

18 “(16) ‘Indian child’ means any unmarried person less than 18 years of age who is:

19 “(a) A member of an Indian tribe; or

20 “(b) Eligible for membership in an Indian tribe and is the biological child of a member of an
21 Indian tribe.

22 “(17) ‘Juvenile court’ means the court having jurisdiction of juvenile matters in the several
23 counties of this state.

24 “(18) ‘Local citizen review board’ means the board specified by ORS 419A.090 and 419A.092.

25 “(19) ‘Parent’ means the biological or adoptive mother and the legal [*father*] **parent** of the child,
26 ward, youth or youth offender. As used in this subsection, ‘legal [*father*] **parent**’ means:

27 “(a) A [*man*] **person** who has adopted the child, ward, youth or youth offender or whose
28 [*paternity*] **parentage** has been established or declared under ORS [*109.070 or*] 416.400 to 416.465 or
29 **section 2 of this 2017 Act or** by a juvenile court; and

30 “(b) In cases in which the Indian Child Welfare Act applies, a man who is a father under ap-
31 plicable tribal law.

32 “(20) ‘Permanent foster care’ means an out-of-home placement in which there is a long-term
33 contractual foster care agreement between the foster parents and the department that is approved
34 by the juvenile court and in which the foster parents commit to raise a ward in substitute care or
35 youth offender until the age of majority.

36 “(21) ‘Public building’ has the meaning given that term in ORS 166.360.

37 “(22) ‘Reasonable and prudent parent standard’ means the standard, characterized by careful and
38 sensible parental decisions that maintain the health, safety and best interests of a child or ward
39 while encouraging the emotional and developmental growth of the child or ward, that a substitute
40 care provider shall use when determining whether to allow a child or ward in substitute care to
41 participate in extracurricular, enrichment, cultural and social activities.

42 “(23) ‘Reasonable time’ means a period of time that is reasonable given a child or ward’s emo-
43 tional and developmental needs and ability to form and maintain lasting attachments.

44 “(24) ‘Records’ means any information in written form, pictures, photographs, charts, graphs,
45 recordings or documents pertaining to a case.

1 “(25) ‘Resides’ or ‘residence,’ when used in reference to the residence of a child, ward, youth or
2 youth offender, means the place where the child, ward, youth or youth offender is actually living
3 or the jurisdiction in which wardship or jurisdiction has been established.

4 “(26) ‘Restitution’ has the meaning given that term in ORS 137.103.

5 “(27) ‘Serious physical injury’ means:

6 “(a) A serious physical injury as defined in ORS 161.015; or

7 “(b) A physical injury that:

8 “(A) Has a permanent or protracted significant effect on a child’s daily activities;

9 “(B) Results in substantial and recurring pain; or

10 “(C) In the case of a child under 10 years of age, is a broken bone.

11 “(28) ‘Shelter care’ means a home or other facility suitable for the safekeeping of a child, ward,
12 youth or youth offender who is taken into temporary custody pending investigation and disposition.

13 “(29) ‘Short-term detention facility’ means a facility established under ORS 419A.050 (3) for
14 holding children, youths and youth offenders pending further placement.

15 “(30) ‘Sibling’ means one of two or more children or wards related:

16 “(a) By blood or adoption through a common legal parent; or

17 “(b) Through the marriage of the children’s or wards’ legal or biological parents.

18 “(31) ‘Substitute care’ means an out-of-home placement directly supervised by the department
19 or other agency, including placement in a foster family home, group home, child-caring agency as
20 defined in ORS 418.205 or other child caring institution or facility. ‘Substitute care’ does not include
21 care in:

22 “(a) A detention facility, forestry camp or youth correction facility;

23 “(b) A family home that the court has approved as a ward’s permanent placement, when a
24 child-caring agency as defined in ORS 418.205 has been appointed guardian of the ward and when
25 the ward’s care is entirely privately financed; or

26 “(c) In-home placement subject to conditions or limitations.

27 “(32) ‘Surrogate’ means a person appointed by the court to protect the right of the child, ward,
28 youth or youth offender to receive procedural safeguards with respect to the provision of free ap-
29 propriate public education.

30 “(33) ‘Tribal court’ means a court with jurisdiction over child custody proceedings and that is
31 either a Court of Indian Offenses, a court established and operated under the code of custom of an
32 Indian tribe or any other administrative body of a tribe that is vested with authority over child
33 custody proceedings.

34 “(34) ‘Victim’ means any person determined by the district attorney, the juvenile department or
35 the court to have suffered direct financial, psychological or physical harm as a result of the act that
36 has brought the youth or youth offender before the juvenile court. When the victim is a minor,
37 ‘victim’ includes the legal guardian of the minor. The youth or youth offender may not be considered
38 the victim. When the victim of the crime cannot be determined, the people of Oregon, as represented
39 by the district attorney, are considered the victims.

40 “(35) ‘Violent felony’ means any offense that, if committed by an adult, would constitute a felony

42 “(a) Involves actual or threatened serious physical injury to a victim; or

43 “(b) Is a sexual offense. As used in this paragraph, ‘sexual offense’ has the meaning given the
44 term ‘sex crime’ in ORS 163A.005.

45 “(36) ‘Ward’ means a person within the jurisdiction of the juvenile court under ORS 419B.100.

1 “(37) ‘Young person’ means a person who has been found responsible except for insanity under
2 ORS 419C.411 and placed under the jurisdiction of the Psychiatric Security Review Board.

3 “(38) ‘Youth’ means a person under 18 years of age who is alleged to have committed an act that
4 is a violation, or, if done by an adult would constitute a violation, of a law or ordinance of the
5 United States or a state, county or city.

6 “(39) ‘Youth care center’ has the meaning given that term in ORS 420.855.

7 “(40) ‘Youth offender’ means a person who has been found to be within the jurisdiction of the
8 juvenile court under ORS 419C.005 for an act committed when the person was under 18 years of age.

9 “**SECTION 42.** ORS 419B.395 is amended to read:

10 “419B.395. (1) If in any proceeding under ORS 419B.100 or 419B.500 the juvenile court deter-
11 mines that the child or ward has [*no legal father*] **fewer than two legal parents** or that
12 [*paternity*] **parentage** is disputed as allowed in ORS 109.070, the court may enter a judgment of
13 [*paternity*] **parentage** or a judgment of [*nonpaternity*] **nonparentage** in compliance with the pro-
14 visions of ORS 109.070, 109.124 to 109.230, 109.250 to 109.262 and 109.326 **and section 2 of this 2017**

16 “(2) Before entering a judgment under subsection (1) of this section, the court must find that
17 adequate notice and an opportunity to be heard was provided to:

20 “(c) The Administrator of the Division of Child Support of the Department of Justice or the

29 “(a) ‘Administrator’ has the meaning given that term in ORS 25.010.

30 “(b) ‘Child born out of wedlock’ has the meaning given that term in ORS 109.124.

31 “(c) ‘Legal [*father*] **parent**’ has the meaning given that term in ORS 419A.004 (19).

32 “**SECTION 43.** ORS 419B.839 is amended to read:

33 “419B.839. (1) Summons in proceedings to establish jurisdiction under ORS 419B.100 must be
34 served on:

35 “(a) The parents of the child without regard to who has legal or physical custody of the child;

36 “(b) The legal guardian of the child;

37 “(c) A putative father of the child who satisfies the criteria set out in ORS 419B.875 (1)(a)(C),
38 except as provided in subsection (4) of this section;

39 “(d) A putative father of the child if notice of the initiation of filiation or [*paternity*] **parentage**
40 proceedings was on file with the Center for Health Statistics of the Oregon Health Authority prior

18 mitment to the child or ward by assuming, or attempting to assume, responsibilities normally asso-

39 “432.088. (1) A report of live birth for each live birth that occurs in this state shall be submitted
40 to the Center for Health Statistics, or as otherwise directed by the State Registrar of the Center for
41 Health Statistics, within five calendar days after the live birth and shall be registered if the report
42 has been completed and filed in accordance with this section.

43 “(2) The physician, institution or other person providing prenatal care related to a live birth
44 shall provide prenatal care information as required by the state registrar by rule to the institution
45 where the delivery is expected to occur not less than 30 calendar days prior to the expected delivery

1 date.

2 “(3) When a live birth occurs in an institution or en route to an institution, the person in charge

27 “(b) The state registrar may establish by rule the manner of submitting the information for the

29 licensed direct entry midwife who attends the birth of his or her own child, grandchild, niece or
30 nephew.

31 “(6) When a report of live birth is submitted that does not include the minimum acceptable
32 documentation required by this section or any rules adopted under this section, or when the state

16 mother’s partner shall be entered on the report of live birth as a parent of the child, unless par-
17 entage has been determined otherwise by a court of competent jurisdiction.

18 “(d) In any case in which paternity **or parentage** of a child is determined by a court of com-
19 petent jurisdiction, or by an administrative determination of paternity **or parentage**, the Center for
20 Health Statistics shall enter the name of *[the]* **each** parent on the new record of live birth. The

6 “(a) A statement of rights and responsibilities including any rights afforded to a minor parent;

7 “(b) A statement of the alternatives to and consequences of signing the acknowledgment;

8 “(c) Instructions on how to file the form with the state registrar and information about any fee

10 “(d) Lines for the Social Security numbers and addresses of the parents; and

23 tistics shall amend a record of live birth and establish a replacement for the record if the state
24 registrar receives one of the following:

25 “(a) A report of adoption as provided in ORS 432.223 or a certified copy of the judgment of
26 adoption, with the information necessary to identify the original record of live birth and to establish
27 a replacement for the record, unless the court ordering the adoption requests that a replacement for
28 the record not be established;

29 “(b) A request that a replacement record of live birth be prepared to establish parentage, as
30 prescribed by the state registrar by rule or ordered by a court of competent jurisdiction in this state
31 that has determined the [*paternity*] **parentage** of a person;

6 the original record of live birth must be restored. The replacement for the record of live birth is
7 not subject to inspection, except upon the order of a court of competent jurisdiction in this state

10 sought under this section and the court issues an order indicating a date of live birth more than

13 “(8) The state registrar shall prepare and register a record of foreign live birth for a person
