### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes requirement that Higher Education Coordinating Commission's annual evaluation of public universities include annual evaluation of each university. Requires that each university be evaluated by commission once every two years.

Removes April 1 deadline for public universities to submit biennial funding request to commission.

Requires commission to submit budget request including funding for any activities public universities are allowed or required by law to perform.

Permits public universities to disclose student Social Security number if required by law to do so.

Requires public university governing boards to meet four times per year rather than quarterly.

Permits Governor to stagger terms of members of public university governing boards.

Removes statutory references to both universities with governing boards and universities without governing boards.

 44 bequests or revenues of the university from any source in accordance with an agreement entered  
 45 into between the State Treasurer and the university and with the policies and procedures estab-

1 lished by the State Treasurer, including the recoupment of costs incurred by the State Treasurer in  
2 carrying out these tasks.

3 (4) As used in this section, “depository” has the meaning given that term in ORS 295.001.

4 **SECTION 23.** ORS 352.138, as amended by section 8, chapter 31, Oregon Laws 2016, is amended  
5 to read:

6 352.138. (1) The following entities are not subject to any provision of law enacted after January  
7 1, 2013, that is unique to governmental entities unless the following entities are expressly named:

8 (a) A **public** university **listed in ORS 352.002** [*with a governing board*]; and

9 (b) Any not-for-profit organization or other entity if the equity of the entity is owned or con-  
10 trolled exclusively by a **public** university [*with a governing board*] and if the organization or entity  
11 is created by the university to advance any of the university’s statutory missions.

19 and ORS chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291, 292, 293, 294, 295  
20 and 297 do not apply to a **public** university **listed in ORS 352.002** [*with a governing board*].

21 (4)(a) Notwithstanding subsections (1) and (3) of this section and ORS 352.033, ORS 240.167,  
22 279C.600 to 279C.625, 279C.800, 279C.810, 279C.825, 279C.827, 279C.830, 279C.835, 279C.836, 279C.838,  
23 279C.840, 279C.845, 279C.850, 279C.855, 279C.860, 279C.865, 279C.870 and 292.043 apply to a **public**  
24 university **listed in ORS 352.002** [*with a governing board*] under the same terms as they apply to  
25 public bodies other than the state.

26 (b) Notwithstanding subsections (1) and (3) of this section, ORS 279C.800 to 279C.870 apply to  
27 an agreement under the terms of which a private entity constructs, reconstructs, renovates or paints  
28 an improvement on real property owned by a **public** university **listed in ORS 352.002** [*with a gov-*  
29 *erning board*] or by a not-for-profit organization or other entity that a **public** university [*with a*  
30 *governing board*] owns or controls exclusively.

41 state that create rights, benefits or protections in favor of military veterans, service members and  
42 families of service members to the same extent as an agency of this state would be subject to such  
43 statutes and administrative rules.

5 (13) As used in this section, "personnel records" means records containing information kept by  
6 the public university, office, department or activity concerning a faculty member and furnished by  
7 the faculty member or by others about the faculty member at the request of the faculty member or  
8 the public university, office, department or activity, including, but not limited to, information con-  
9 cerning discipline, membership activity, employment performance or other personal records of indi-  
10 vidual persons.

11 **SECTION 27.** ORS 352.388 is amended to read:

12 352.388. As used in ORS 352.388 to 352.415:

13 (1) "Bond-related costs" means:

14 (a) The costs of paying the principal of, the interest on and the premium, if any, on revenue  
15 bonds.

16 (b) The costs and expenses of issuing, administering and maintaining revenue bonds, including,  
17 but not limited to, the costs and expenses of:

18 (A) Redeeming revenue bonds.

19 (B) Paying amounts due in connection with credit enhancement devices or agreements for ex-

18 **SECTION 32.** ORS 352.450 is amended to read:

19 352.450. (1) The Public University Fund is established in the State Treasury, separate and dis-  
20 tinct from the General Fund. Any interest or other investment income derived from moneys in the  
21 Public University Fund is credited to the fund.

22 (2) Except for moneys otherwise designated by statute or federal law, the governing board of  
23 any public university listed in ORS 352.002 may place any or all moneys received by it into the  
24 Public University Fund. Once deposited in the fund, the moneys of a public university shall be  
25 commingled with other moneys in the fund and are fungible, except to the extent they may be sep-  
26 arately accounted for by the public university designated under subsection (3)(a) of this section.

27 (3)(a) Public universities listed in ORS 352.002 that choose to participate in the Public Univer-  
28 sity Fund shall, by agreement or other structure authorized by law, designate the participating  
29 public university responsible for the Public University Fund and identify any and all obligations  
30 necessary for a participating public university listed in ORS 352.002 to serve as the designated re-  
31 sponsible party under this subsection.

32 (b) The participating public universities shall inform the State Treasurer of the designated pub-  
33 lic university responsible for the Public University Fund. The participating public universities may  
34 change which participating public university is responsible for the Public University Fund.

35 (c) The State Treasurer may conclusively rely on a written instruction from the public univer-  
36 sities as to the designated public university responsible for the fund.

37 (d) The designated public university shall inform the State Treasurer of the personnel authorized  
38 to provide instructions to the State Treasurer with respect to moneys in the fund. The State  
39 Treasurer may rely on instructions from the authorized personnel of the designated public university  
40 related to the deposit, withdrawal, investment, transfer, borrowing or lending of moneys in the fund.  
41 The State Treasurer is not responsible for or liable to the public universities for any error or  
42 omission in the instructions the State Treasurer receives from the designated public university.

43 (4) All moneys in the Public University Fund are continuously appropriated to the public uni-  
44 versity responsible for the Public University Fund, to be used only in a manner consistent with the  
45 agreement or other structure authorized by law as described in subsection (3) of this section.

1 (5) The moneys in the Public University Fund may be invested as provided in ORS 293.701 to  
2 293.857.

3 (6) Public universities that participate in the Public University Fund may, by agreement or other  
4 structure authorized by law, direct the public university designated under subsection (3)(a) of this  
5 section to establish accounts and subaccounts within the fund when the participating public uni-  
6 versities determine that accounts or subaccounts are necessary or desirable. Except when otherwise  
7 specified by a statute establishing an account, the participating public universities or, as appropri-  
8 ate, the designated public university, may credit any interest or income derived from moneys in the  
9 fund to any account or subaccount within the fund.

10 (7) Public universities that participate in the Public University Fund or, as appropriate, the  
11 public university designated under subsection (3)(a) of this section, shall keep a record of all moneys  
12 deposited into the fund. The record shall indicate by separate cumulative accounts and subaccounts  
13 the sources from which the moneys are derived and the individual activity or program against which  
14 each withdrawal is charged.

15 (8) Notwithstanding any other provision of law, public universities that participate in the Public  
16 University Fund or, as appropriate, the public university designated under subsection (3)(a) of this  
17 section, may transfer or lend the moneys in the fund to other participating public universities listed  
18 in ORS 352.002. The Public University Fund may be a borrowing fund for purposes of ORS 293.205  
19 to 293.225 and may borrow from the Oregon Short Term Fund established in ORS 293.728 or other  
20 state funds. Subject to the limitations of Article XI, section 7, of the Oregon Constitution, the  
21 Public University Fund may be a lending fund for purposes of ORS 293.205 to 293.225 and may lend  
22 moneys to other state funds. The public university designated under subsection (3)(a) of this section  
23 shall be the relevant state agency or department for whom the State Treasurer may transfer funds  
24 or with whom the State Treasurer may enter into an agreement pursuant to ORS 293.205 to 293.225.

25 (9) Notwithstanding any other provision of law, ORS 293.169, 293.171, 293.353, 293.406, 293.450,  
26 293.455, 293.460 and 293.465 to 293.485 apply to moneys in the Public University Fund and to checks,  
27 warrants or electronic funds transfers from or to the fund. For purposes of ORS 293.169, 293.171,  
28 293.353, 293.406, 293.450, 293.455, 293.460 and 293.465 to 293.485:

29 (a) The public university designated under subsection (3)(a) of this section is the relevant state  
30 agency or department; and

31 (b) The personnel of the designated public university authorized to provide instructions to the  
32 State Treasurer are the relevant state officers.

33 (10)(a) The State Treasurer may establish separate or commingled funds, or establish separate  
34 or commingled accounts within funds established under this subsection. The State Treasurer may  
35 establish separate or commingled accounts within other funds in the State Treasury to receive, hold,  
36 keep, manage or invest moneys of a **public university listed in ORS 352.002** [*with a governing*  
37 *board*] pursuant to any agreements entered into by the State Treasurer and the university under  
38 ORS 352.135. The moneys in a fund or account established under this subsection may be invested  
39 as provided in ORS 293.701 to 293.857 and any interest or other investment income derived from the  
40 fund or account shall be credited to the fund or account. All moneys held in a fund or account es-  
41 tablished under this subsection are continuously appropriated to the relevant **public** university [*with*  
42 *a governing board*] that has entered into an agreement with the State Treasurer under ORS 352.135  
43 for the purpose of carrying out the powers and duties of the **public** university [*with a governing*  
44 *board*] or the purposes for which the moneys were donated.

45 (b) Except for moneys held to provide for the payment of state bonds and other state obligations

1 described in ORS 352.089 (4), a **public** university **listed in ORS 352.002** [*with a governing board*]  
2 may transfer or lend the moneys held in the State Treasury pursuant to any agreements entered into  
3 under ORS 352.135 to other public universities listed in ORS 352.002. A fund or account in the State  
4 Treasury that holds moneys of a **public** university [*with a governing board*] pursuant to an agree-  
5 ment entered into under ORS 352.135 may be a borrowing fund for purposes of ORS 293.205 to  
6 293.225 and may borrow from the Oregon Short Term Fund established in ORS 293.728 or other state  
7 funds. Subject to the limitations of Article XI, section 7, of the Oregon Constitution, a fund or ac-  
8 count in the State Treasury that holds moneys of a **public** university [*with a governing board*] pur-  
9 suant to an agreement entered into under ORS 352.135 may be a lending fund for purposes of ORS  
10 293.205 to 293.225 and may lend moneys to other state funds. The **public** university [*with a governing*  
11 *board*] that has entered into an agreement with the State Treasurer under ORS 352.135 is the rele-  
12 vant state agency or department for whom the State Treasurer may transfer funds or with whom the  
13 State Treasurer may enter into an agreement pursuant to ORS 293.205 to 293.225.

14 (c) Notwithstanding any other provision of law, ORS 293.169, 293.171, 293.353, 293.406, 293.450,  
15 293.455, 293.460 and 293.465 to 293.485 apply to moneys received, held, kept, managed or invested  
16 by the State Treasurer for a **public** university **listed in ORS 352.002** [*with a governing board*] pur-  
17 suant to an agreement entered into under ORS 352.135 and to checks, warrants or electronic funds  
18 transfers from or to any funds or accounts established pursuant to this subsection. For purposes of  
19 ORS 293.169, 293.171, 293.353, 293.406, 293.450, 293.455, 293.460 and 293.465 to 293.485:

20 (A) The **public** university [*with a governing board*] that has entered into an agreement with the  
21 State Treasurer under ORS 352.135 is the relevant state agency or department; and

22 (B) The personnel of the **public** university [*with a governing board*] authorized to provide in-  
23 structions to the State Treasurer are the relevant state officers.
