**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Office of Governor for biennial expenses.  
Limits biennial expenditures from lottery moneys for Regional Solutions Program.  
Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Office of Governor.  
**Appropriates moneys from General Fund to Office of Governor for Oregon Volunteers Commission for Voluntary Action and Service program.**  
**Limits biennial expenditures from federal funds for program.**  
Declares emergency, effective July 1, 2017.

**A BILL FOR AN ACT**

Relating to the financial administration of the Office of the Governor; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. There is appropriated to the Office of the Governor, for the biennium beginning July 1, 2017, out of the General Fund, the amount of \$13,223,027.**

**SECTION 2. In addition to and not in lieu of any other appropriation, there is appropriated to the Office of the Governor, for the biennium beginning July 1, 2017, out of the General Fund, the amount of \$50,000 for the necessary expenses of the Governor in connection with the duties imposed by law and for such other expenses as may be incumbent upon or requested by the Governor.**

**SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$3,827,547 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the Office of the Governor for the Regional Solutions Program.**

**SECTION 4. Notwithstanding any other law limiting expenditures, the amount of \$3,432,918 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Office of the Governor.**

**SECTION 5. In addition to and not in lieu of any other appropriation, there is appropriated to the Office of the Governor, for the biennium beginning July 1, 2017, out of the General Fund, the amount of \$200,000 for the Oregon Volunteers Commission for Voluntary Action and Service program.**

1        **SECTION 6.** Notwithstanding any other law limiting expenditures, the amount of  
2        **\$6,907,780** is established for the biennium beginning July 1, 2017, as the maximum limit for  
3        **payment of expenses from federal funds collected or received by the Office of the Governor**  
4        **for the Oregon Volunteers Commission for Voluntary Action and Service program.**

5        **SECTION 7.** This 2017 Act being necessary for the immediate preservation of the public  
6        **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**  
7        **July 1, 2017.**
