

# A-Engrossed Senate Bill 5536

Ordered by the Senate July 3  
Including Senate Amendments dated July 3

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

- Appropriates moneys from General Fund to Secretary of State for certain biennial expenses.
- Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Secretary of State.
- Limits certain biennial expenditures by Secretary of State from federal funds.
- Declares emergency, effective July 1, 2017.

## A BILL FOR AN ACT

Relating to the financial administration of the Secretary of State; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. There are appropriated to the Secretary of State, for the biennium beginning July 1, 2017, out of the General Fund, the following amounts, for the following purposes:**

- (1) **Administrative Services**
  - Division ..... \$ 2,662,569
- (2) **Elections Division** ..... \$ 7,404,696
- (3) **Elections Division, distributions to counties**..... \$ 706,000

**SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2017, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Secretary of State, for the following purposes:**

- (1) **Administrative Services**
  - Division ..... \$ 17,662,953
- (2) **Elections Division** ..... \$ 1,136,593
- (3) **Audits Division**..... \$ 21,468,989
- (4) **Archives Division**..... \$ 7,584,077
- (5) **Corporation Division**..... \$ 10,018,899

**SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$5,194,107 is established for the biennium beginning July 1, 2017, as the maximum limit for payment of expenses from federal funds collected or received by the Secretary of State.**

**SECTION 4. This 2017 Act being necessary for the immediate preservation of the public**
