**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Modifies duties and authority]* **Directs Long Term Care Ombudsman to appoint Residential Facilities Ombudsman within office** of Long Term Care Ombudsman. **Specifies duties of Residential Facilities Ombudsman.** Renames Residential Facilities Advisory Committee as Residential Ombudsman and Public Guardianship Advisory Board.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

Relating to the Long Term Care Ombudsman; creating new provisions; amending ORS 125.678, 410.550, 441.402, 441.403, 441.406, 441.407, 441.408, 441.409, 441.411, 441.412, 441.413, 441.414, 441.416, 441.417, 441.418, 441.419, 443.738, 443.767 and 476.030; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**RESIDENTIAL FACILITIES OMBUDSMAN**

**SECTION 1. As used in sections 1 to 8 of this 2017 Act:**

(1) **“Administrative action” means an action, inaction or decision by an owner, employee or agent of a residential facility or by a state, local, social service or health agency that could affect the health, safety, welfare or legal rights of residents of the facility.**

(2) **“Designee” means an individual appointed by the Residential Facilities Ombudsman in accordance with section 4 of this 2017 Act.**

(3) **“Legal representative” means a person to whom a resident or a court has granted legal authority to permit access to the resident’s personal information and medical records.**

(4) **“Long Term Care Ombudsman” means the individual appointed by the Governor under ORS 441.403.**

(5) **“Resident” means an individual who resides in a residential facility.**

(6)(a) **“Residential facility” means one of the following:**

(A) **A residential training facility, as defined in ORS 443.400.**

(B) **A residential training home, as defined in ORS 443.400.**

(C) **A licensed adult foster home as defined in ORS 443.705 that serves persons with mental illness or developmental disabilities.**

(D) **A developmental disability child foster home, as defined in ORS 443.830.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (b) "Residential facility" does not include a:

2 (A) Facility housing persons committed under ORS 161.327; or

3 (B) Facility licensed by the Oregon Health Authority to provide alcohol and drug treat-  
4 ment.

5 (7) "Residential Facilities Ombudsman Program" means the services provided by the  
6 Residential Facilities Ombudsman.

7 **SECTION 2.** (1) The Long Term Care Ombudsman, in consultation with the Residential  
8 Ombudsman and Public Guardianship Advisory Board established under ORS 441.416, shall  
9 appoint a Residential Facilities Ombudsman for a four-year term. The Residential Facilities  
10 Ombudsman serves at the pleasure of the Long Term Care Ombudsman and may be removed  
11 by the Long Term Care Ombudsman for cause. The salary of the Residential Facilities Om-  
12 budsman shall be determined by the Long Term Care Ombudsman. The Residential Facilities  
13 Ombudsman shall be reimbursed for all reasonable travel and other expenses incurred in the  
14 performance of the ombudsman's official duties.

15 (2) The Residential Facilities Ombudsman may, subject to the approval of the Long Term  
16 Care Ombudsman, hire or contract with volunteers, staff, deputy ombudsmen and other  
17 qualified individuals as necessary to perform the duties of the ombudsman.

18 (3) The Residential Facilities Ombudsman shall:

19 (a) Identify, investigate and resolve complaints made by or on behalf of residents about  
20 administrative actions.

21 (b) Provide residents, families of residents, guardians, community members and admin-  
22 istrators and staff of residential facilities with information regarding the rights of residents  
23 as set forth in ORS 427.107 and 430.210 and any other applicable rights of residents.

24 (c) Widely publicize the Residential Facilities Ombudsman's services, purpose and mode  
25 of operation.

26 (d) Undertake, participate in or cooperate with persons and agencies in conferences, in-  
27 quiries, meetings or studies that may lead to improvements in the functioning of residential  
28 facilities.

29 (e) Work closely with associations and citizen groups in this state and the state pro-  
30 tection and advocacy system under ORS 192.517.

31 (f) Provide services to residents to assist them in protecting their health, safety, welfare  
32 and rights.

33 (g) Ensure that residents have regular, timely, private and unimpeded access to the  
34 Residential Facilities Ombudsman's services and that a resident or an individual acting on  
35 behalf of a resident who files a complaint receives a timely response to the complaint from  
36 the ombudsman or a designee.

37 (h) Represent the interests of residents before government agencies and seek adminis-  
38 trative, legal or other appropriate remedies to protect the health, safety, welfare and rights  
39 of residents.

40 (i) Analyze, comment on and monitor the development and implementation of federal,  
41 state and local laws and other governmental policies pertaining to the health, safety, welfare  
42 and rights of residents.

43 (j) Recommend any changes to state or local laws to improve the health, safety, welfare  
44 and rights of residents.

45 (k) Facilitate public comment on laws and policies that affect the health, safety, welfare

1 **and rights of residents.**

2 **(L) Train designees.**

3 **(m) Promote the development of organizations to advocate on behalf of residents of res-**  
4 **idential facilities.**

5 **(n) To the extent practicable, assist residents who move from a residential facility to a**  
6 **home care setting.**

7 **(o) Assist residents and individuals acting on their behalf in locating and accessing re-**  
8 **sources in the community and in connecting with local service providers.**

9 **(p) Engage the participation of residents in general studies, conferences, inquiries or**  
10 **meetings related to residential care in this state.**

11 **(q) Make recommendations for improvements in the functioning of the residential facility**  
12 **system in this state.**

13 **(r) Collaborate with the Oregon Health Authority, the Department of Human Services,**  
14 **and any other appropriate agencies and organizations to establish a statewide system to**  
15 **collect and analyze information on complaints about and conditions in residential facilities**  
16 **for the purpose of publicizing improvements and resolving significant problems for residents.**

17 **(s) Work with residents to identify and recommend processes for making complaints**  
18 **about service providers and entities.**

19 **(t) Provide information to public agencies about the problems of residents.**

20 **(u) Collect and compile data necessary to prepare the report submitted to the Governor**  
21 **under ORS 182.500.**

22 **(v) Adopt rules necessary for carrying out sections 1 to 8 of this 2017 Act, in accordance**  
23 **with ORS chapter 183, in consultation with the Long Term Care Ombudsman and the Resi-**  
24 **dential Ombudsman and Public Guardianship Advisory Board.**

25 **SECTION 3. (1) The Oregon Health Authority and the Department of Human Services**  
26 **shall provide to the Residential Facilities Ombudsman and the designees monthly, in a format**  
27 **specified by the ombudsman, updated demographic and licensing information regarding each**  
28 **residential facility for which the Residential Facilities Ombudsman has responsibilities under**  
29 **this section.**

30 **(2) All state agencies, their representatives and service providers shall cooperate with**  
31 **and assist the Residential Facilities Ombudsman and designees in the performance of the**  
32 **ombudsman's duties and functions.**

33 **SECTION 4. (1) The Residential Facilities Ombudsman shall, in consultation with the**  
34 **Long Term Care Ombudsman, appoint designees to serve as representatives of the ombuds-**  
35 **man in local communities. The ombudsman shall regularly monitor the functions of**  
36 **designees.**

37 **(2) The Residential Facilities Ombudsman shall prescribe the qualifications of designees**  
38 **by rule.**

39 **(3) To be appointed as a designee, a person must complete an initial training prescribed**  
40 **by the Residential Facilities Ombudsman by rule and attend required continuing educational**  
41 **training sessions that are approved by the ombudsman.**

42 **(4) Designees must sign a contract with the Residential Facilities Ombudsman that out-**  
43 **lines the scope of their duties. Violation of the contract is cause for terminating the ap-**  
44 **pointment of a designee.**

45 **SECTION 5. (1) The Residential Facilities Ombudsman and each designee shall:**

1 (a) Have private and unimpeded access to residential facilities and residents at any time  
2 considered necessary and reasonable by the ombudsman or the designee for the purpose of:

3 (A) Investigating and resolving complaints made by or on behalf of residents, including  
4 by subpoenaing any person to appear and give sworn testimony or to produce documentary  
5 or other evidence that is reasonably material to the matter under investigation;

6 (B) Offering the services of the ombudsman or the designee to any resident, in private;

7 (C) Interviewing residents, with their consent, in private;

8 (D) Interviewing employees or agents of the facility;

9 (E) Consulting regularly with the facility administration; and

10 (F) Providing other services authorized by law or by rule.

11 (b) Notwithstanding ORS 192.553 to 192.581, have access to all of the following if neces-  
12 sary to investigate a complaint:

13 (A) Residents' records, including medical records with the consent of a resident or a  
14 resident's representative.

15 (B) For a resident who is unable to communicate consent and the resident's legal repre-  
16 sentative denies consent, access to the resident's records without consent if the ombudsman  
17 has reasonable cause to believe that the legal representative is not acting in the resident's  
18 best interests.

19 (C) Records of any public agency, including abuse reports maintained under ORS 430.757.

20 (c) Have access to, upon request, copies of all licensing and certification records, in-  
21 cluding records of corrective actions, maintained by the Department of Human Services or  
22 the Oregon Health Authority with respect to residential facilities.

23 (d) Have access to the administrative records, policies and documents of residential fa-  
24 cilities to which residents or the general public has access.

25 (e) Conduct each investigation in a manner that does not significantly disrupt the pro-  
26 vision of residential care or treatment to residents.

27 (f) Show identification to the person in charge of a facility prior to entering the facility.

28 (2) The Residential Facilities Ombudsman shall enter into confidentiality agreements with  
29 the department and with the authority permitting the ombudsman and each designee to have  
30 access to electronic records of the department and the authority that are necessary to carry  
31 out the duties of the ombudsman. The agreement must ensure that records obtained by the  
32 ombudsman from the department or the authority that are confidential, privileged or other-  
33 wise protected from disclosure are not further disclosed, except as permitted by state and  
34 federal law.

35 **SECTION 6.** (1) If a complaint is made on behalf of a resident who has limited or no  
36 decision-making capacity and is unable to communicate consent for the Residential Facilities  
37 Ombudsman to investigate the complaint, and:

38 (a) The resident has no known legal representative:

39 (A) The ombudsman shall seek to discern the outcome that the resident desires and shall  
40 work to accomplish that outcome; or

41 (B) If the ombudsman is unable to discern the resident's desired outcome, it shall be  
42 assumed that the resident desires to have the resident's health, safety, welfare and rights  
43 protected; or

44 (b) The resident has a legal representative who refuses to provide consent to the inves-  
45 tigation, the ombudsman may proceed without consent if the ombudsman has reasonable

1 cause to believe that it is in the resident's best interests.

2 (2) A resident shall have the right to refuse to communicate with the ombudsman or the  
3 designee. The refusal shall be made directly to the ombudsman or the designee and not  
4 through an intermediary.

5 (3) Following an investigation of a complaint, the Residential Facilities Ombudsman or a  
6 designee shall report the ombudsman's findings and conclusions to the resident who made  
7 the complaint and to a complainant acting on behalf of a resident. If the ombudsman or  
8 designee finds conditions threatening the health, safety or welfare of a resident that cannot  
9 be resolved informally, the ombudsman or designee shall refer the findings to the Depart-  
10 ment of Human Services, the Oregon Health Authority or law enforcement officials.

11 (4) A resident shall have the right to participate in planning any course of action to be  
12 taken on behalf of the resident by the ombudsman or the designee.

13 (5) A resident or an individual who makes a complaint to the Residential Facilities Om-  
14 budsman under this section, or who participates in an investigation of a complaint, may not  
15 be subjected to a penalty, sanction or restriction or be denied any right, privilege or benefit  
16 on account of making the complaint or participating in the investigation of the complaint.

17 (6) The Department of Human Services shall prohibit retaliation or reprisals by a resi-  
18 dential facility or other entity with respect to any resident, employee or other person who  
19 files a complaint, provides information or otherwise cooperates with the Residential Facilities  
20 Ombudsman or a designee and shall provide by rule for appropriate sanctions with respect  
21 to the retaliation and reprisals.

22 (7) In order to encourage residents and individuals acting on behalf of residents to com-  
23 municate with the Residential Facilities Ombudsman or designee, any resident or individual  
24 acting on behalf of a resident who makes a complaint to the Residential Facilities Ombuds-  
25 man in good faith under this section or who participates in an investigation of a complaint  
26 shall have immunity from any civil or criminal liability that might otherwise be incurred or  
27 imposed with respect to the communication.

28 **SECTION 7.** (1) The Residential Facilities Ombudsman shall prepare and distribute to  
29 each residential facility in this state a written notice describing the procedures to follow in  
30 making a complaint, including the address and telephone number of the ombudsman and  
31 designee, if any, and a poster describing the Residential Facilities Ombudsman Program and  
32 providing contact information. The Department of Human Services shall facilitate the dis-  
33 tribution of information regarding the Residential Facilities Ombudsman Program to resi-  
34 dents, providers and the public.

35 (2) The administrator of each residential facility shall post the written notice and poster  
36 required by this section in conspicuous places in the facility in accordance with procedures  
37 provided by the ombudsman and shall give the written notice to each resident and legal  
38 representative, if any, at least annually during the care planning process.

39 **SECTION 8.** The Residential Facilities Ombudsman shall establish procedures to maintain  
40 the confidentiality of the records and files of residents. The procedures must meet the fol-  
41 lowing requirements:

42 (1) The ombudsman or a designee may not disclose, except to state agencies or law  
43 enforcement, the identity of any resident or individual acting on behalf of a resident without  
44 the consent of the resident or the legal representative of the resident.

45 (2) The identity of any resident or individual providing information on behalf of the resi-

1 **dent shall be confidential. If a complaint becomes the subject of judicial proceedings, the in-**  
2 **vestigative information held by the ombudsman or the designee shall be disclosed for the**  
3 **purpose of the proceedings if requested by the court.**

4 **SECTION 9. The Residential Facilities Ombudsman appointed under section 2 of this 2017**  
5 **Act may solicit and accept, gifts, grants and donations from public and private sources for**  
6 **the purpose of carrying out sections 1 to 8 of this 2017 Act and the moneys shall be deposited**  
7 **in the Long Term Care Ombudsman Account established under ORS 441.419.**

9 **OFFICE OF THE LONG TERM CARE OMBUDSMAN**

10  
11 **SECTION 10.** ORS 441.402 is amended to read:

12 441.402. As used in ORS 441.402 to 441.419:

13 (1) **“Administrative action” means any action, inaction or decision made by an owner,**  
14 **employee or agent of a long term care facility or by a public agency that affects the services**  
15 **to residents of long term care facilities.**

16 [(1)] (2) **“Designee” means an individual appointed by the Long Term Care Ombudsman under**  
17 **ORS 441.413 to serve as a representative in a local community in order to carry out the purpose**  
18 **of ORS 441.402 to 441.419.**

19 [(2) “Residential facility” includes a:]

20 [(a) Long term care facility;]

21 [(b) Residential facility as defined in ORS 443.400, excluding a:]

22 [(A) Facility housing persons committed under ORS 161.327; and]

23 [(B) Facility licensed by the Oregon Health Authority to provide alcohol and drug treatment;]

24 [(c) Licensed adult foster home as defined in ORS 443.705;]

25 [(d) Developmental disability child foster home, as defined in ORS 443.830, that is certified by the  
26 Department of Human Services; and]

27 [(e) Continuing care retirement community as defined in ORS 101.020.]

28 (3) **“Long term care facility” means:**

29 (a) **Any licensed skilled nursing facility or intermediate care facility, as defined in rules**  
30 **adopted under ORS 442.015;**

31 (b) **Adult foster homes, as defined in ORS 443.705, with residents over 60 years of age;**

32 (c) **Residential care facilities, as defined in ORS 443.400; and**

33 (d) **Continuing care retirement communities, as defined in ORS 101.020.**

34 (4) **“Long Term Care Ombudsman Program” means the services provided by the Long**  
35 **Term Care Ombudsman.**

36 **SECTION 11.** ORS 441.403 is amended to read:

37 441.403. (1) The office of the Long Term Care Ombudsman is established. The Long Term Care  
38 Ombudsman shall function separately and independently from any other state agency. The Governor  
39 shall appoint the Long Term Care Ombudsman for a four-year term from a list of three nominees  
40 nominated by the [Residential Facilities Advisory Committee] **Residential Ombudsman and Public**  
41 **Guardianship Advisory Board** established under ORS 441.416. The appointment of the Long Term  
42 Care Ombudsman is subject to Senate confirmation under ORS 171.562 and 171.565. A vacancy shall  
43 be filled within 60 days in the same manner as an appointment is made.

44 (2) The Long Term Care Ombudsman may be removed for just cause, upon recommendation to  
45 the Governor by the [Residential Facilities Advisory Committee] **Residential Ombudsman and**

1 **Public Guardianship Advisory Board.**

2 (3) The Long Term Care Ombudsman shall have background and experience in the following  
3 areas:

- 4 (a) The fields of aging, mental health or developmental disabilities;
- 5 (b) Physical or behavioral health care;
- 6 (c) Working with community programs;
- 7 (d) Strong understanding of long term care issues, both regulatory and policy;
- 8 (e) Working with health care providers;
- 9 (f) Working with and involvement in volunteer programs; and
- 10 (g) Administrative and managerial experience.

11 **SECTION 12.** ORS 441.406 is amended to read:

12 441.406. (1) The *[office of the]* Long Term Care Ombudsman shall carry out the following duties:

13 (a) Investigate and resolve complaints made by or for residents of *[residential]* **long term care**  
14 facilities about administrative actions that may adversely affect their health, safety, welfare or  
15 rights, including subpoenaing any person to appear, **to** give sworn testimony or to produce docu-  
16 mentary or other evidence that is reasonably material to any matter under investigation.

17 (b) Undertake, participate in or cooperate with persons and agencies in such conferences, in-  
18 quiries, meetings or studies as may lead to improvements in the functioning of *[residential]* **long**  
19 **term care** facilities.

20 (c) Monitor the development and implementation of federal, state and local laws, regulations and  
21 policies that relate to *[residential]* **long term care** facilities in this state.

22 (d) Provide information to public agencies about the problems of residents of *[residential]* **long**  
23 **term care** facilities.

24 (e) Work closely with cooperative associations and citizen groups in this state and the state  
25 protection and advocacy system under ORS 192.517.

26 (f) Widely publicize the Long Term Care Ombudsman's *[service]* **services**, purpose and mode of  
27 operation.

28 (g) Collaborate with the Oregon Health Authority, the Department of Human Services, the  
29 Nursing Home Administrators Board and any other appropriate agencies and organizations to es-  
30 tablish a statewide system to collect and analyze information on complaints and conditions in *[resi-*  
31 *dential]* **long term care** facilities for the purpose of publicizing improvements and resolving  
32 significant problems.

33 *[(h)(A) Identify and coordinate programs, services and other assistance for persons receiving public*  
34 *guardian and conservator services under ORS 125.675 to 125.687, that are available statewide;]*

35 *[(B) Contract with qualified individuals and entities to provide programs, services and assistance*  
36 *to persons receiving public guardian and conservator services under ORS 125.675 to 125.687 who are*  
37 *located in areas of this state where such programs, services and other assistance are inadequate or*  
38 *nonexistent; and]*

39 *[(C)]* **(h)** Contract with the state protection and advocacy system described in ORS 192.517 (1)  
40 to provide services and assistance to persons who are prospective or current residents of a mental  
41 health treatment facility or of a residential facility for individuals with developmental disabilities  
42 when the system has received a notice regarding the person pursuant to ORS 125.060 (7)(c) or (8)(c).

43 (i) Appoint designees to serve as local representatives of the office **of the Long Term Care**  
44 **Ombudsman** in various districts of the state and regularly monitor their functions.

45 (j) Specify qualifications and duties of designees.

1 (k) Adopt rules necessary for carrying out ORS 441.402 to 441.414, after consultation with the  
2 [*Residential Facilities Advisory Committee*] **Residential Ombudsman and Public Guardianship**  
3 **Advisory Board.**

4 (L) Provide periodically, or at least annually, a report to the Governor, authority, department  
5 and Legislative Assembly.

6 (m) Prepare necessary reports with the assistance of the authority and the department.

7 (n) Supervise, monitor, advise and support the Oregon Public Guardian and Conservator ap-  
8 pointed under ORS 125.678 **and the Residential Facilities Ombudsman appointed under section**  
9 **2 of this 2017 Act.**

10 (2) At least quarterly, [*the Oregon Health Authority and*] the Department of Human Services  
11 shall provide the Long Term Care Ombudsman with a list of the number of licensed or certified beds  
12 in each [*residential*] **long term care** facility for which the ombudsman has responsibilities under this  
13 section.

14 [(3) *As used in this section, "administrative action" means any action or decision made by an*  
15 *owner, employee or agent of a residential facility or by a public agency that affects the services to*  
16 *residents of the facility.*]

17 **SECTION 13.** ORS 441.407 is amended to read:

18 441.407. The Long Term Care Ombudsman shall establish procedures to maintain the  
19 confidentiality of the records and files of residents of [*residential*] **long term care** facilities. These  
20 procedures must meet the following requirements:

21 (1) The ombudsman or a designee may not disclose[, *except to state agencies,*] the identity of any  
22 resident unless the complainant or the resident, or the legal representative of either, consents in  
23 writing to the disclosure and specifies to whom the disclosure may be made.

24 (2) The identity of any complainant or resident on whose behalf a complaint is made, or indi-  
25 vidual providing information on behalf of the complainant or the resident, shall be confidential. If  
26 the complaint becomes the subject of judicial proceedings, the investigative information held by the  
27 ombudsman or **the** designee shall be disclosed for the purpose of the proceedings if requested by the  
28 court.

29 **SECTION 14.** ORS 441.408 is amended to read:

30 441.408. (1) The Long Term Care Ombudsman and each designee shall have the right of entry  
31 into [*residential*] **long term care** facilities at any time considered necessary and reasonable by the  
32 ombudsman or the designee for the purpose of:

- 33 (a) Investigating and resolving complaints made by residents or made on their behalf;
- 34 (b) Interviewing residents, with their consent, in private;
- 35 (c) Offering the services of the ombudsman or the designee to any resident, in private;
- 36 (d) Interviewing employees or agents of the facility;
- 37 (e) Consulting regularly with the facility administration; and
- 38 (f) Providing services authorized by law or by rule.

39 (2)(a) The [*Long Term Care*] ombudsman shall have access to any resident's records, and to re-  
40 cords of any public agency necessary to the duties of the ombudsman, including records on [*patient*  
41 *abuse complaints*] **reports of resident abuse** made pursuant to ORS [*430.735 to 430.765,*] **124.050 to**  
42 **124.095**, 441.630 to 441.680 and 441.995. The provisions of ORS 192.553 to 192.581 are not intended  
43 to limit the access of the [*Long Term Care*] ombudsman to medical records of residents of  
44 [*residential*] **long term care** facilities. **If necessary to investigate a complaint,** designees [*may*]  
45 **shall** have access to individual resident's records, including medical records as authorized by the



1 resident or **the** resident's legal representative[, *if needed to investigate a complaint*].

2 **(b) If a resident's legal representative denies access to the resident's records by the**  
3 **ombudsman or a designee, the ombudsman shall have access to the records if the ombuds-**  
4 **man has reasonable cause to believe that the legal representative is not acting in the best**  
5 **interests of the resident.**

6 **(3) The ombudsman shall enter into confidentiality agreements with the Department of**  
7 **Human Services and with the Oregon Health Authority permitting the ombudsman and each**  
8 **designee to have access to electronic records of the department and the authority that are**  
9 **necessary to carry out the duties of the ombudsman. The agreement must ensure that re-**  
10 **ords obtained by the ombudsman from the department or the authority that are confiden-**  
11 **tial, privileged or otherwise protected from disclosure are not further disclosed, except as**  
12 **permitted by state and federal law.**

13 [(3)] (4) Entry and investigation authorized by this section shall be done in a manner that does  
14 not disrupt significantly the providing of nursing, residential or other personal care or treatment to  
15 residents.

16 [(4)] (5) The ombudsman or the designee must show identification to the person in charge of the  
17 facility. The resident shall have the right to refuse to communicate with the ombudsman or the  
18 designee. The refusal shall be made directly to the ombudsman or the designee and not through an  
19 intermediary.

 13 situations, changes in medical conditions, physicians' orders and professional instructions, nutri-  
 14 tional needs, residents' preferences and conflicts; and

15 (c) A requirement that, after being licensed, a provider or resident manager successfully com-  
 16 pletes continuing education as described in ORS 443.742.

17 (3) After consultation with representatives of providers, educators, residents' advocates, [and]  
 18 the Long Term Care Ombudsman **and the Residential Facilities Ombudsman**, the licensing agency  
 19 may adopt by rule exceptions to the training requirements of subsections (1) and (2) of this section  
 20 for persons who are appropriately licensed medical care professionals in Oregon or who possess  
 21 sufficient education, training or experience to warrant an exception. The licensing agency may not  
 22 make any exceptions to the testing requirements.

 7 functioning. Restraints may not be used for discipline of a resident or for the convenience of the  
 8 adult foster home. Restraints may be used only as follows:

9 (a) Psychoactive medications may be used only pursuant to a prescription that specifies the  
 10 circumstances, dosage and duration of use.

11 (b) Physical restraints may be used only pursuant to a qualified practitioner's order that speci-  
 12 fies the type, circumstances and duration of use in accordance with rules adopted by the licensing  
 13 agency. The rules adopted by the licensing agency relating to physical restraints shall include

11 stances alleged in the complaint. In no event shall the investigation exceed a duration of 60 days,  
12 unless there is an ongoing concurrent criminal investigation, in which case the licensing agency  
13 may take a reasonable amount of additional time in which to complete the investigation.

14 (4) The licensing agency shall take no longer than 60 days from the completion of the investi-  
15 gation report to take appropriate corrective action in the case of any complaint that the investi-  
16 gator determines to be substantiated.

17 (5)(a) The licensing agency shall mail a copy of the investigation report within seven days of the  
18 completion of the report to:

19 (A) The complainant, unless the complainant requests anonymity;

20 (B) The resident, and any person designated by the resident to receive information concerning  
21 the resident;

22 (C) The facility; and

23 (D) The Long Term Care Ombudsman **and the Residential Facilities Ombudsman.**

24 (b) The copy of the report shall be accompanied by a notice that informs the recipient of the  
25 right to submit additional evidence.

26 (6)(a) The complaint and the investigation report shall be available to the public at the local  
27 office of the licensing agency or the type B area agency [*on aging*], if appropriate. When the li-  
28 censing agency or type B area agency [*on aging*] concludes the investigation of a complaint, the li-  
29 censing agency or type B area agency [*on aging*] shall clearly designate the outcome of the  
30 complaint investigation and make the designation available to the public together with the com-  
31 plaint and the investigation report.

32 **(b) As used in this subsection, "area agency" has the meaning given that term in ORS**  
33 **410.040.**

34 (7) A copy of the report shall be forwarded to the licensing agency whether or not the investi-  
35 gation report concludes that the complaint is substantiated.

36 **SECTION 29.** ORS 476.030 is amended to read:

37 476.030. (1) The State Fire Marshal shall enforce all statutes, and make rules relating to:

38 (a) The prevention of fires.

39 (b) The storage and use of combustibles and explosives.

40 (c) The maintenance and regulation of structural fire safety features in occupied structures and  
41 overseeing the safety of and directing the means and adequacy of exit in case of fire from factories,  
42 asylums, hospitals, churches, schools, halls, theaters, amphitheaters, all buildings, except private  
43 residences, which are occupied for sleeping purposes, and all other places where large numbers of  
44 persons work, live or congregate from time to time for any purpose except that structural changes  
45 shall not be required in buildings built, occupied and maintained in conformity with state building

1 code regulations applicable at the time of construction.

2 (d) Standards for equipment used for fire protection purposes within this state including stand-  
3 ard thread for fire hose couplings and hydrant fittings.

4 (2) The State Fire Marshal and deputies shall have such powers and perform such other duties  
5 as are prescribed by law.

6 (3) If, in the opinion of the State Fire Marshal, a governmental subdivision of the state has en-  
7 acted adequate regulations generally conforming to state and national standards concerning fire  
8 prevention, fire safety measures and building construction requirements for safety, and if the gov-  
9 ernmental subdivision provides reasonable enforcement of its regulations, the State Fire Marshal  
10 may exempt the area subject to such regulation either partially or fully from the statutes, rules and  
11 regulations administered by the State Fire Marshal. Prior to adoption of any such exemption, the  
12 State Fire Marshal may request from the Department of Public Safety Standards and Training con-  
13 sideration of and recommendations regarding the exemption. The exemption may extend for a two-  
14 year period, and may be renewed from time to time, but may be canceled by the State Fire Marshal  
15 following 30 days' written notice if the State Fire Marshal finds that the governmental subdivision's  
16 regulations or enforcement thereof are not reasonably sufficient. The governmental subdivision shall  
17 furnish a copy of such regulations to the State Fire Marshal and shall file with the State Fire  
18 Marshal any amendment thereto within 30 days before the effective date of such amendment. The  
19 State Fire Marshal shall designate a person or division within such governmental subdivision as an  
20 approved authority for exercising functions relating to fire prevention, fire safety measures and  
21 building construction. Upon request of a local official having enforcement responsibility and a  
22 showing of unusual fire hazard or other special circumstances, the State Fire Marshal shall make  
23 investigation and appropriate recommendations.

24 (4) The State Fire Marshal may investigate or cause an investigation to be made to determine  
25 the probable cause, origin and circumstances of any fire and shall classify such findings as the State  
26 Fire Marshal may find appropriate to promote fire protection and prevention.

27 (5) The State Fire Marshal shall provide training in fire safety inspection to the Department of  
28 Human Services, area agencies, the Oregon Health Authority, community mental health programs,  
29 developmental disabilities programs and designees of the Long Term Care Ombudsman **and the**  
30 **Residential Facilities Ombudsman**. If an adult foster home has been inspected by the Department  
31 of Human Services, the Oregon Health Authority, an area agency, a community mental health pro-  
32 gram or a developmental disabilities program and the agency conducting the inspection reasonably  
33 believes that the adult foster home is not in compliance with applicable fire safety rules, the agency  
34 conducting the inspection may request the State Fire Marshal to inspect or cause an inspection to  
35 be made. If a designee of the Long Term Care Ombudsman **or the Residential Facilities Om-**  
36 **busdman**, in the course of visiting an adult foster home, believes that the adult foster home is not  
37 in compliance with applicable fire safety rules, the designee shall report the problem to the appro-  
38 priate agency to request a fire safety inspection by the office of the State Fire Marshal or by a  
39 designated representative of the office of the State Fire Marshal.

40 (6) Upon the request of the Department of Human Services, the Oregon Health Authority, an  
41 area agency, a community mental health program or a developmental disabilities program, the State  
42 Fire Marshal shall inspect or cause an inspection to be made to determine if the adult foster home  
43 is in compliance with rules jointly adopted by the Department of Human Services and the State Fire  
44 Marshal establishing fire safety standards for adult foster homes.

45 (7) As used in subsections (5) and (6) of this section:

1 (a) "Adult foster home" has the meaning given that term in ORS 443.705.

2 (b) "Area agency" has the meaning given that term in ORS 410.040.

3 (c) "Community mental health program" means a program established under ORS 430.620 (1)(b).

4 (d) "Developmental disabilities program" means a program established under ORS 430.620 (1)(a).
