CHAPTER

AN ACT

Relating to designation of liaisons with the Office of Emergency Management; amending ORS 401.054.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 401.054 is amended to read:

401.054. (1) Each of the following [*state*] agencies, **entities and officials** shall designate an individual [*within the agency*] to act as a liaison with the Office of Emergency Management:

- (a) The Department of Consumer and Business Services;
- (b) The Department of Corrections;
- (c) The Department of Education;**
- [(c)] **(d) The Department of Environmental Quality;**
- [(d)] **(e) The Department of Human Services;**
- [(e)] **(f) The Department of Justice;**
- [(f)] **(g) The Department of Land Conservation and Development;**
- (h) The Department of Public Safety Standards and Training;**
- (i) The Department of State Lands;**
- [(g)] **(j) The Department of State Police;**
- [(h)] **(k) The Department of Transportation;**
- (L) The Department of Veterans' Affairs;**
- (m) The Employment Department;**
- (n) The Housing and Community Services Department;**
- [(i)] **(o) The Judicial Department;**
- (p) The Oregon Business Development Department;**
- [(j)] **(q) The Oregon Department of Administrative Services;**
- [(k)] **(r) The Oregon Department of Aviation;**
- [(L)] **(s) The Oregon Health Authority;**
- (t) The Oregon Military Department;**
- (u) The Oregon Tourism Commission;**
- [(m)] **(v) The Public Utility Commission of Oregon;**
- (w) The Secretary of State;**
- [(n)] **(x) The State Department of Agriculture;**
- [(o)] **(y) The State Department of Energy;**
- [(p)] **(z) The State Department of Fish and Wildlife;**

- [(q)] (aa) The State Department of Geology and Mineral Industries;
- [(r)] (bb) The State Fire Marshal;
- [(s)] (cc) The State Forestry Department;
- [(t)] (dd) The State Marine Board;
- [(u)] (ee) The State Parks and Recreation Department; [and]
- [(ff) The Travel Information Council; and**
- [(v)] (gg) The Water Resources Department.

(2) Each [state] agency, **entity and official** required to designate a liaison under this section shall designate an individual who has authority during an emergency to allocate resources and assets of the agency, **entity or official**.

(3) Each individual designated as a liaison under subsection (1) of this section shall assist in the coordination of the functions of the [individual's] agency, **entity or official that designated the individual** that relate to emergency preparedness and response with similar functions of the Office of Emergency Management.
