SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes Psychiatric Security Review Board to establish restorative justice program. Provides that documents or oral communications related to program are confidential, not admissible in subsequent proceeding and [not] exempt from disclosure to public [records] or to board members. Transfers from Oregon Health Authority to Psychiatric Security Review Board jurisdiction over persons found guilty except for insanity of certain crimes who are committed to state hospital or secure intensive inpatient facility. Becomes operative on July 1, 2018.

Declares emergency, effective on passage.

(1)(a) The Psychiatric Security Review Board may develop a restorative 9 justice program to assist the recovery of crime victims when a person is found guilty except 10 for insanity of a crime or responsible except for insanity for an act. 11 (b) The board may enter into a contract with a nonprofit educational institution or other 12nonprofit organization that provides for the administration of the restorative justice pro-13 gram by the institution or organization. (2) Any documents or oral communications created, submitted or provided for use in the 14 15 restorative justice program are confidential, exempt from public disclosure and: 16 (a) May not be disclosed to or used by board members. 17 (b) May not be used or disclosed by restorative justice program staff, volunteers or par-18 ticipants for any purpose unrelated to the program. 19 (c) Are not admissible as evidence in any subsequent administrative or judicial proceed-20 ing, including board proceedings and deliberations. 21(3) The board may adopt rules to carry out the provisions of this section. 22SECTION 2.  regular basis concerning the progress of the person.

(d) Copies of all reports submitted to the board pursuant to this section shall be furnished to the
person and the person's counsel. The confidentiality of these reports is determined pursuant to ORS
192.501 to 192.505.

(e) The facility shall comply with the conditional release order and any modifications of theconditions ordered by the board.

32(4)(a) If at any time while the person is under the jurisdiction of the board it appears to the board or its chairperson that the person has violated the terms of the conditional release or that 33 34 the mental health of the individual has changed, the board or its chairperson may order the person returned for evaluation or treatment to a state hospital or, if the person is under 18 years of age, 35to a secure intensive community inpatient facility. A written order of the board, or its chairperson 36 37 on behalf of the board, is sufficient warrant for any law enforcement officer to take into custody 38 such person and transport the person accordingly.
