"<u>SECTION 1.</u> ORS 31.710 is amended to read:

6 "31.710. (1) Except for claims subject to ORS 30.260 to 30.300 and ORS chapter 656, in any civil 7 action [seeking damages arising out of bodily injury, including emotional injury or distress, death or 8 property damage] for the wrongful death of any one person including claims for loss of care, com-9 fort, companionship and society and loss of consortium, the amount awarded for noneconomic dam-10 ages, as defined in ORS 31.705, shall not exceed \$500,000.

"(b) 'Noneconomic damages' means subjective, nonmonetary losses, including but not limited to pain, mental suffering, emotional distress, humiliation, injury to reputation, loss of care, comfort, companionship and society, loss of consortium, inconvenience and interference with normal and usual activities apart from gainful employment.

"(a) A foster home that is maintained by the foster parents and that has been certified by the
 department under the provisions of ORS 418.625 to 418.645;

"(b) An approved home that is maintained by the foster parents and that is receiving payment from the department under the provisions of ORS 418.027 or under the provisions of ORS 420.810 and 420.815; or

20 "(2) As used in subsection (1) of this section, 'cause' does not include the broadcast of an ad-21 vertisement by a radio or television station or cable television company unless the advertisement 22 is for:

"(a) The candidacy of the owner, licensee or operator of the station or company; or

24 "(b) A ballot measure of which a chief petitioner is the owner, licensee or operator of the station 25 or company.

26 "(3) A candidate who knows of and consents to a publication or advertisement prohibited by this 27 section with knowledge or with reckless disregard that it contains a false statement of material fact, 28 violates this section regardless of whether the candidate has participated directly in the publication 29 or advertisement.

30 "(4) There is a rebuttable presumption that a candidate knows of and consents to any publica-31 tion or advertisement prohibited by this section caused by a political committee over which the 32 candidate exercises any direction and control.

"(7) A political committee has standing to bring an action provided by subsection (5) of this section as plaintiff in its own name, if its purpose as evidenced by its preelection activities, solicitations and publications has been injured by the violation and if it has fully complied with the provisions of this chapter. In an action brought by a political committee as provided by subsection (5) of this section, the plaintiff may recover economic and noneconomic damages for all injury to the purpose of the committee as provided in subsection (6) of this section.

68) If a judgment is rendered in an action under this section against a defendant who has been nominated to public office or elected to a public office other than state Senator or state Representative, and it is established by clear and convincing evidence that the false statement was deliberately made or caused to be made by the defendant, the finder of fact shall determine whether the false statement reversed the outcome of the election. If the finder of fact finds by clear and convincing evidence that the false statement reversed the outcome of the election, the defendant shall be deprived of the nomination or election and the nomination or office shall be declared vacant.
