SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines "unarmed combat sports." Authorizes Oregon State Athletic Commission to regulate unarmed combat sports. Permits Superintendent of State Police to approve amateur athletic organizations. Requires promoters of unarmed combat sports events to reimburse medical personnel and certain officials for specified expenses incurred during events.

Applies \$50,000 limit to gross receipts tax per event.

[Declares emergency, effective on passage.]

Takes effect on 91st day following adjournment sine die.

2 Relating to unarmed combat sports; creating new provisions; amending ORS 166.715, 463.015, 463.018,
3 463.025, 463.035, 463.037, 463.047, 463.113, 463.125, 463.145, 463.149, 463.155, 463.165, 463.175,
4 463.185, 463.210, 463.320, 463.322, 463.330 and 463.340; repealing ORS 463.310 and 463.500; and
5 prescribing an effective date.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 463.015 is amended to read:

8 463.015. As used in this chapter:

9 (1) **"Amateur athletic organization" means an entity organized and operated exclusively**
10 **to foster state, national and international amateur unarmed combat sports competition.**

11 *[(1) "Boxing" means a contest between contestants who fight with their fists protected by gloves or*
12 *mittens fashioned of leather or similar material, the duration of which is limited to a stated number*
13 *of rounds separated by rest periods of equal duration. "Boxing" includes kickboxing, a form of boxing*
14 *in which blows are delivered with any part of the arm below the shoulder, including the hand, and any*
15 *part of the leg below the hip, including the foot.]*

16 (2) "Entertainment wrestling" means a noncompetitive performance in which the participants
17 deliver blows or apply holds with no intent to punish or immobilize an opponent. Entertainment
18 wrestling is distinguished from *[boxing, mixed martial arts or other wrestling]* **unarmed combat**
19 **sports** by the fact that the outcome of the performance is predetermined.

20 (3) "Event" means *[a boxing, mixed martial arts or entertainment wrestling match, contest, exhi-*
21 *bition or performance]* **an unarmed combat sports or entertainment wrestling match, bout,**
22 **contest, exhibition or performance.**

23 (4) "Exhibition" means a demonstration of *[boxing or mixed martial arts]* **unarmed combat**
24 **sports** skills, the results of which are not counted toward the official record of the competitors.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(5) “Gross receipts” means the consideration, including money, credits, rights or other**
 2 **items of value, received from the sale of tickets or other admissions indicia or rights, with-**
 3 **out any deduction from the total value of the consideration.**

4 [(5)] **(6) “Judge” means a person licensed by the Superintendent of State Police who is at**
 5 **cageside or ringside during [a boxing or mixed martial arts] an unarmed combat sports event and**
 6 **who has the responsibility of scoring the [performance] bout of the [participants] competitors in the**
 7 **event.**

8 [(6)] **(7) “Manager” means a person licensed by the superintendent who does any of the follow-**
 9 **ing:**

10 (a) By contract or agreement undertakes to represent the interests of [any] a professional [boxer
 11 *or mixed martial arts*] **unarmed combat sports** competitor in procuring or arranging the conduct
 12 of [any *boxing or mixed martial arts*] **an unarmed combat sports** event in which the professional
 13 [boxer *or mixed martial arts*] **unarmed combat sports** competitor is a participant.

14 (b) Receives or is entitled to receive more than 10 percent of the contracted portion of the gross
 15 purse of [any] a professional [boxer *or mixed martial arts*] **unarmed combat sports** competitor for
 16 [any] services related to the [boxer’s *or mixed martial arts*] **unarmed combat sports** competitor’s
 17 participation in [a *boxing or mixed martial arts*] **an unarmed combat sports** event.

18 (c) Is an officer, director or stockholder of [any] a corporation [which] **that** receives or is enti-
 19 tled to receive more than 10 percent of the contracted portion of the gross purse of [any] a profes-
 20 sional [boxer *or mixed martial arts*] **unarmed combat sports** competitor for [any] services relating
 21 to the [boxer’s *or mixed martial arts*] **unarmed combat sports** competitor’s participation in [a *box-*
 22 *ing or mixed martial arts*] **an unarmed combat sports** event.

23 (d) Directs or controls the professional activities of [any] a professional [boxer *or mixed martial*
 24 *arts*] **unarmed combat sports** competitor.

25 (e) Attends to the professional [boxer *or mixed martial arts*] **unarmed combat sports** compet-
 26 itor at **cageside or ringside** or purports to be the manager of a professional [boxer *or mixed martial*
 27 *arts*] **unarmed combat sports** competitor.

28 [(7)] **(8) “Matchmaker” means a person licensed by the superintendent [of State Police] who is**
 29 **employed by or associated with a promoter in the capacity of booking and arranging [boxing or**
 30 ***mixed martial arts*] unarmed combat sports events between [opponents] unarmed combat sports**
 31 **competitors and for whose activities in this regard the promoter is legally responsible.**

32 **(9) “Medical personnel” means a physician licensed under ORS chapter 677 or a physician**
 33 **assistant licensed under ORS 677.505 to 677.525.**

34 [(8)] *“Mixed martial arts” means a combative sporting contest, the rules of which allow two mixed*
 35 *martial arts competitors to attempt to achieve dominance over one another by utilizing a variety of*
 36 *techniques including, but not limited to, striking, grappling and the application of submission holds.*
 37 *“Mixed martial arts” does not include martial arts such as tae kwon do, karate, kempo karate, kenpo*
 38 *karate, judo, sumo, jujitsu, Brazilian jujitsu, submission wrestling and kung fu.]*

39 [(9)] **(10) “Official” means an individual authorized by the [Oregon State Athletic Commission]**
 40 **superintendent or an authorized representative of the superintendent to perform duties as as-**
 41 **signed by [the commission] the superintendent or an authorized representative of the super-**
 42 **intendent. “Official” includes, but is not limited to, a referee, judge, timekeeper[,] or inspector [or**
 43 ***ringside physician or other assigned medical personnel*].**

44 [(10)] **(11) “Person” includes an individual, association, organization, partnership or corpo-**
 45 **ration.**

1 [(11)] (12) “Professional [*boxer or mixed martial arts*] **unarmed combat sports** competitor”
 2 means an individual licensed by the superintendent who competes for or has competed for a money
 3 prize, purse or compensation in [*a boxing event or has competed in a professional or amateur mixed*
 4 *martial arts*] **an unarmed combat sports** event.

5 [(12)] (13) “Promoter” means a [*corporation, partnership, association, individual or other organ-*
 6 *ization*] **person** licensed by the superintendent who arranges, gives, holds or conducts [*a boxing,*
 7 *mixed martial arts or*] **an entertainment wrestling or unarmed combat sports** event in this state
 8 and who is legally responsible for the lawful conduct of the [*boxing, mixed martial arts or enter-*
 9 *tainment wrestling*] event.

10 (14) “**Striking**” means a **physical attack in which an individual uses a part of the**
 11 **individual’s body with the intent to inflict damage on an opponent.**

12 (15) “**Submission**” means an act by an individual who yields to the individual’s opponent
 13 **and that results in the individual’s immediate defeat.**

14 (16) “**Unarmed combat sports**” means a form of competition where the intent is to win
 15 **by striking, knockout, technical knockout or submission. “Unarmed combat sports” does not**
 16 **include tae kwon do, karate, kenpo karate, judo, sumo, jujitsu, Brazilian jujitsu, submission**
 17 **wrestling, kung fu, submission grappling or other martial art where the intent is for the**
 18 **competitor to win by points only and where that martial art is exhibited independently.**

19 (17) “**Unarmed combat sports competitor**” means an individual licensed by the super-
 20 **intendent who competes in an unarmed combat sports event.**

21 **SECTION 2.** ORS 463.018 is amended to read:

22 463.018. The Legislative Assembly finds that the [*boxing, mixed martial arts*] **unarmed combat**
 23 **sports** and entertainment wrestling industries in this state should be regulated in order to protect
 24 the best interests of [*both contestants*] **entertainment wrestlers, unarmed combat sports com-**
 25 **petitors** and the public.

26 **SECTION 3.** ORS 463.025 is amended to read:

27 463.025. (1) A person may not act as [*a professional boxer or mixed martial arts competitor,*
 28 *manager of a professional boxer or mixed martial arts*] **an unarmed combat sports** competitor,
 29 [*referee,*] **official, manager,** [*judge,*] **second for a professional unarmed combat sports compet-**
 30 **itor**[, *timekeeper*] or matchmaker [*until*] **unless** the person [*has been*] **is** licensed pursuant to this
 31 chapter.

32 (2) Application for a license [*shall*] **must** be made upon a form [*furnished*] **provided** by the Su-
 33 perintendent of State Police and [*shall*] **must** be accompanied by an annual license fee established
 34 by the superintendent by rule.

35 (3) Each person licensed under this section shall present the license upon request to promoters
 36 and representatives of the superintendent, including members of the Oregon State Athletic Com-
 37 mission, as evidence of eligibility to act or perform in the person’s licensed capacities in connection
 38 with [*boxing or mixed martial arts*] **unarmed combat sports** events.

39 (4) A person under 18 years of age may not be issued a license to act as [*a mixed martial arts*]
 40 **an unarmed combat sports** competitor, **manager, official, second or matchmaker.**

41 (5) **This section does not apply to an unarmed combat sports competitor, official, man-**
 42 **ager, second for a professional unarmed combat sports competitor or matchmaker competing**
 43 **or participating in an unarmed combat sports event supervised by an amateur athletic or-**
 44 **ganization.**

45 **SECTION 4.** (1) A person may not act as an amateur athletic organization unless the

1 **Superintendent of State Police has approved the person under this section.**

2 (2) **An applicant for approval shall apply to the superintendent on a form provided by the**
3 **superintendent and shall accompany the application with a fee established by the super-**
4 **intendent by rule.**

5 (3) **An applicant shall provide to the superintendent an affidavit stating that the health**
6 **and safety of the unarmed combat sports competitors in unarmed combat sports events**
7 **supervised by the applicant is the responsibility of the applicant.**

8 (4) **The applicant shall meet all requirements for approval as an amateur athletic organ-**
9 **ization as established by the superintendent by rule.**

10 (5) **The superintendent may deny, revoke or suspend approval of an amateur athletic or-**
11 **ganization if the amateur athletic organization:**

12 (a) **Fails to provide information requested by the superintendent or the authorized rep-**
13 **resentative of the superintendent; or**

14 (b) **In the discretion of the superintendent, should not be approved to act as an amateur**
15 **athletic organization.**

16 (6) **If an amateur athletic organization fails or refuses to file an application for approval**
17 **under this section, or the approval of an amateur athletic organization is denied, revoked**
18 **or suspended, the amateur athletic organization may not participate in an amateur unarmed**
19 **combat sports event.**

20 **SECTION 5.** ORS 463.035 is amended to read:

21 463.035. (1)(a) A person may not act as a promoter of [*boxing, mixed martial arts*] **unarmed**
22 **combat sports** or entertainment wrestling until the person has been licensed pursuant to this
23 chapter.

24 (b) **A person who intends to act as a promoter for entertainment wrestling events and**
25 **for unarmed combat sports events shall apply for separate licensure for each type of event.**

26 (2) Application for a promoter's license [*shall*] **must** be made upon a form [*furnished*] **provided**
27 by the Superintendent of State Police [*and must be accompanied by payment of the application fee*
28 *established by the superintendent by rule*]. **The form must specify whether the application is for**
29 **a license as a promoter of entertainment wrestling events or for a license as a promoter of**
30 **unarmed combat sports events.**

31 (3) Before a license is issued to any promoter of [*boxing, mixed martial arts*] **unarmed combat**
32 **sports** or entertainment wrestling, the applicant for licensure must:

33 (a) Pay the annual license fee established by the superintendent by rule; and

34 (b) File with the superintendent a corporate surety bond issued by a company authorized to do
35 business in this state drawn in an amount acceptable to the superintendent and the release of which
36 is conditioned upon:

37 (A) Timely payment of all taxes and civil penalties due the state or its political subdivisions;

38 (B) Payment to the state or a political subdivision [*thereof which*] **of the state that** establishes
39 liability against a promoter for damages, penalties or expenses arising from promotional activity;

40 (C) Payment of the purses of the **entertainment wrestlers or unarmed combat sports** com-
41 petitors;

42 (D) Payment of reimbursement to the superintendent of the cost of approval of an event canceled
43 by the promoter without good cause; and

44 (E) Payment of compensation to inspectors, referees, timekeepers, judges and event medical
45 personnel.

1 (4) In addition to the requirements specified in subsection (3) of this section, prior to being is-
2 sued a license to promote entertainment wrestling, an applicant must provide an affidavit to the
3 superintendent stating that the health and safety of the participants is the responsibility of the
4 promoter.

5 (5) If the circumstances of an event to be promoted so require, the superintendent may increase
6 the required amount of the corporate surety bond previously filed with the superintendent in com-
7 pliance with this section.

8 (6) The superintendent may accept a cash deposit or the assignment of a savings account in lieu
9 of the corporate surety bond required by this section.

10 **(7) A person under 18 years of age may not be issued a license to act as a promoter.**

11 **SECTION 6.** ORS 463.037 is amended to read:

12 463.037. (1) [A boxing match or mixed martial arts] **An unarmed combat sports** event may not
13 take place in this state unless the following Oregon State Athletic Commission representatives are
14 in attendance:

15 [(1)] **(a) [One representative of the commission] The Superintendent of State Police or an au-**
16 **thorized representative of the superintendent** to oversee conduct of the [match] event;

17 [(2)] **(b) Officials assigned by [the commission or by a designee of the commission] the super-**
18 **intendent or an authorized representative of the superintendent;** and

19 [(3)] **(c) Medical personnel assigned [or approved by the commission or by a designee of the com-**
20 **mission] by the superintendent or authorized representative of the superintendent.**

21 **(2) This section does not apply to an event supervised by an approved amateur athletic**
22 **organization.**

23 **SECTION 7.** ORS 463.047 is amended to read:

24 463.047. (1) [The Oregon State Athletic Commission or a designee of the commission] **The Super-**
25 **intendent of State Police or an authorized representative of the superintendent** shall assign
26 or approve medical personnel to each [boxing or mixed martial arts] **unarmed combat sports** event
27 held in this state.

28 **(2) Medical personnel who are not employed by the Department of State Police and who**
29 **are assigned to serve at an unarmed combat sports event must be paid by the promoter at**
30 **a rate established by the superintendent by rule. The promoter shall reimburse the mileage**
31 **and lodging expenses incurred by medical personnel described in this subsection at a rate**
32 **established by the superintendent by rule.**

33 **(3) The promoter of an unarmed combat sports event shall reimburse the Oregon State**
34 **Athletic Commission for medical supplies used at the unarmed combat sports event at rates**
35 **determined by the superintendent by rule.**

36 [(2)] **(4) Prior to the commencement of [any boxing or mixed martial arts] an unarmed combat**
37 **sports** event held in this state, the medical personnel assigned to the event shall [certify that]
38 **medically qualify** each [contestant is medically qualified] **unarmed combat sports competitor** to
39 [participate] **compete** in the event in accordance with rules recommended by the commission and
40 adopted by the superintendent [of State Police]. In determining whether to issue or withhold the re-
41 quired [certification] **medical qualification**, the assigned medical personnel shall consider:

42 (a) The results of a prefight medical examination conducted by [physicians or other] medical
43 personnel approved by the commission; and

44 (b) The recent [ring] record of the [contestant] **unarmed combat sports competitor** seeking
45 [certification] **medical qualification.**

1 [(3)] (5) When [certification] **medical qualification** under this section is withheld from [a
2 *contestant, the commission or a designee of the commission*] **an unarmed combat sports competitor,**
3 **the superintendent or authorized representative of the superintendent** shall immediately notify
4 the promoter or a representative of the promoter and any event involving the [*medically unqualified*
5 *contestant shall*] **unarmed combat sports competitor must** be canceled.

6 (6) **This section does not apply to medical personnel supervised by approved amateur**
7 **athletic organizations.**

8 **SECTION 8.** ORS 463.113 is amended to read:

9 463.113. (1) There is created in the Department of State Police the Oregon State Athletic Com-
10 mission, which shall regulate the promotion of [*all professional boxing, mixed martial arts*] **unarmed**
11 **combat sports** and entertainment wrestling events in this state. The commission shall adopt rules
12 [*for conducting professional boxing and mixed martial arts*] **to conduct** events that promote the
13 safety and best interest of the [*contestants*] **entertainment wrestlers, unarmed combat sports**
14 **competitors** and [*of the*] public.

15 (2) The Superintendent of State Police shall:

16 (a) Adopt and enforce rules for conducting [*professional boxing and mixed martial arts*] **unarmed**
17 **combat sports** events that promote the safety and best interest of the [*contestants*] **unarmed**
18 **combat sports competitors** and of the public.

19 (b) License and regulate [*participants*] **unarmed combat sports competitors, promoters,**
20 **managers, seconds, matchmakers** and officials for [*all professional boxing and professional and*
21 *amateur mixed martial arts events in this state*] **unarmed combat sports events regulated by the**
22 **commission.**

23 (c) Establish and utilize the most efficient methods available for compiling [*boxing and mixed*
24 *martial arts*] **unarmed combat sports** event results and record keeping and for communication of
25 results and records.

26 (d) Make available upon request the records of every [*participant*] **unarmed combat sports**
27 **competitor** in and the results of every [*boxing and mixed martial arts*] **unarmed combat sports**
28 event subject to regulation under this chapter.

29 [(e)] (3) The provisions of [*this*] subsection (2) of this section do not apply to entertainment
30 wrestling.

31 [(3)] (4) If, in the judgment of the superintendent **or authorized representative of the super-**
32 **intendent,** it is necessary to protect the public interest or the health or safety of [*boxing, mixed*
33 *martial arts*] **unarmed combat sports competitors** or entertainment [*wrestling participants*]
34 **wrestlers,** the superintendent **or authorized representative of the superintendent** may tempo-
35 rarily suspend, without prior notice or hearing, any license issued pursuant to this chapter until a
36 final determination is made by the superintendent. If no hearing is held prior to the suspension, the
37 suspended licensee may apply to the superintendent for a hearing to determine if the suspension
38 should be modified, set aside or continued. The application for a hearing [*shall*] **must** be in writing
39 and must be received by the superintendent within 30 days of the date of suspension. The super-
40 intendent shall set the matter for hearing within 30 days of receipt of the written request of the
41 suspended licensee.

42 [(4)] (5) [*Whenever any*] **If a** promoter fails to make a report of any event within the period
43 prescribed by this chapter, or [*whenever*] **if** a required report is unsatisfactory, the superintendent
44 or [*a designee*] **authorized representative** of the superintendent may examine, or cause to be ex-
45 amined, the books and records of the promoter and [*any*] other persons [*or organizations*], and

1 subpoena and examine **those persons** under oath [*such persons*] for the purpose of determining the
 2 total amount of the gross receipts for any event and the amount of tax due pursuant to this chapter.
 3 The superintendent may fix and determine the tax as a result of the examination described in this
 4 subsection.

5 [(5)] (6) The superintendent **or authorized representative of the superintendent** may delegate
 6 to the Oregon State Athletic Commission [*any of*] the powers described in subsection (2) of this
 7 section.

8 **SECTION 9.** ORS 463.125 is amended to read:

9 463.125. (1)(a) The Oregon State Athletic Commission [*shall consist*] **consists** of five members
 10 appointed by the Superintendent of State Police for terms of four years. A member may not serve
 11 more than two terms, **except that a member serves until the member's successor is**
 12 **appointed.**

13 (b) Membership [*shall*] **must** represent distinct geographic areas. The Portland metropolitan
 14 area, central Willamette Valley and two other areas [*shall*] **must** be represented.

15 (c) Vacancies [*occurring shall*] **must** be filled by appointment in the same manner for the bal-
 16 ance of the unexpired term.

17 (d) A member of the commission may be removed from office by the superintendent for cause.

18 (e) Each member of the commission, before [*entering upon*] **assuming** the duties of office, shall

27 (4) The superintendent may employ other personnel as necessary.

28 (5) The commission may meet once a month at a time and place agreed upon. Special additional
 29 meetings may be called by the administrator or at the request of one or more members of the com-
 30 mission.

31 (6) Three members of the commission [*shall constitute*] **constitutes** a quorum.

32 (7) Three votes [*shall constitute*] **constitutes** a majority.

33 (8) Members of the commission and representatives of the commission [*shall*] **must** be paid per
 34 diem and travel expenses as designated under ORS 292.495 when conducting the business of the

37 463.145. (1) A member of the Oregon State Athletic Commission may not have [*any*] **a** financial
 38 interest or investment in [*any professional boxer, mixed martial arts*] **an unarmed combat sports**
 39 competitor or entertainment wrestler.

40 (2) A member of the commission may not have [*any*] **a** financial interest or investment in any
 41 [*boxing, mixed martial arts*] **unarmed combat sports** or entertainment wrestling event or promotion
 42 or [*any*] **a** person or promoter involved in [*a boxing, mixed martial arts*] **an unarmed combat sports**
 43 or entertainment wrestling event or promotion.

44 (3) An official, [*judge, referee, inspector, timekeeper or other employee*] **medical personnel, au-**
 45 **thorized representative of the Superintendent of State Police assigned to the commission or**

1 representative of the commission may not:

2 (a) Have *[any]* a financial interest or investment in *[a professional boxer or mixed martial arts]*:

- 42 (AAA) ORS 164.889;
- 43 (BBB) ORS 165.800; or
- 44 (CCC) ORS 163.263, 163.264 or 163.266.
- 45 (b) Any conduct defined as “racketeering activity” under 18 U.S.C. 1961 (1)(B), (C), (D) and (E).

1 (7) "Unlawful debt" means any money or other thing of value constituting principal or interest
2 of a debt that is legally unenforceable in the state in whole or in part because the debt was incurred
3 or contracted:

4 (a) In violation of any one of the following:

5 (A) ORS chapter 462, relating to racing;

6 (B) ORS 167.108 to 167.164, relating to gambling; or

7 (C) ORS 82.010 to 82.170, relating to interest and usury.

8 (b) In gambling activity in violation of federal law or in the business of lending money at a rate
9 usurious under federal or state law.

10 (8) Notwithstanding contrary provisions in ORS 174.060, when this section references a statute
11 in the Oregon Revised Statutes that is substantially different in the nature of its essential provisions
12 from what the statute was when this section was enacted, the reference shall extend to and include
13 amendments to the statute.

14 **SECTION 22. ORS 463.310 and 463.500 are repealed.**

15 **SECTION 23. (1) Section 4 of this 2017 Act, the amendments to statutes by sections 1 to
16 3 and 5 to 21 of this 2017 Act and the repeal of ORS 463.310 and 463.500 by section 22 of this
17 2017 Act become operative on January 1, 2018.**

18 **(2) The Oregon State Athletic Commission and the Superintendent of State Police may
19 take any action before the operative date specified in subsection (1) of this section that is
20 necessary to enable the commission or the superintendent to exercise, on or after the oper-
21 ative date specified in subsection (1) of this section, all of the duties, functions and powers
22 conferred on the commission and the superintendent by section 4 of this 2017 Act, the
23 amendments to statutes by sections 1 to 3 and 5 to 21 of this 2017 Act and the repeal of ORS
24 463.310 and 463.500 by section 22 of this 2017 Act.**

25 **SECTION 24. This 2017 Act takes effect on the 91st day after the date on which the 2017
26 regular session of the Seventy-ninth Legislative Assembly adjourns sine die.**
