Senate Bill 780

Sponsored by COMMITTEE ON BUSINESS AND TRANSPORTATION

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies process for independent medical examinations of injured workers to provide for random selection of qualified physicians to conduct independent medical examinations in workers' compensation claims. Establishes process for provider selection for out-of-state independent medical examinations.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 656.325 is amended to read:

6 656.325. (1)(a) Any worker entitled to receive compensation under this chapter is required, if 7 requested by the Director of the Department of Consumer and Business Services, the insurer or 8 self-insured employer, to submit to a medical examination at a time reasonably convenient for the 9 worker as may be provided by the rules of the director. No more than three independent medical 10 examinations may be requested except after notification to and authorization by the director. If the 11 worker refuses to submit to any such examination, or obstructs the same, the rights of the worker 12to compensation shall be suspended with the consent of the director until the examination has taken 13 place, and no compensation shall be payable during or for account of such period. The provisions 14 of this paragraph are subject to the limitations on medical examinations provided in ORS 656.268.

(b) When a worker is requested by the director, the insurer or self-insured employer to attend an independent medical examination, the examination must be conducted by a physician selected **at random by the director** from a list of qualified physicians established by the director under ORS 656.328.

(c) The director shall adopt rules applicable to independent medical examinations conducted
 pursuant to paragraph (a) of this subsection that:

21(A) Provide a worker the opportunity to request review by the director of the reasonableness 22of the location selected for an independent medical examination. Upon receipt of the request for 23 review, the director shall conduct an expedited review of the location selected for the independent 24 medical examination and issue an order on the reasonableness of the location of the examination. 25 The director shall determine if there is substantial evidence for the objection to the location for the 26 independent medical examination based on a conclusion that the required travel is medically 27contraindicated or other good cause establishing that the required travel is unreasonable. The de-28terminations of the director about the location of independent medical examinations are not subject 29 to review.

30 (B) Impose a monetary penalty against a worker who fails to attend an independent medical

examination without prior notification or without justification for not attending the examination. A 1 2 penalty imposed under this subparagraph may be imposed only on a worker who is not receiving temporary disability benefits under ORS 656.210 or 656.212. An insurer or self-insured employer may 3 offset any future compensation payable to the worker to recover any penalty imposed under this 4 subparagraph from a claim with the same insurer or self-insured employer. When a penalty is re- $\mathbf{5}$ covered from temporary disability or permanent total disability benefits, the amount recovered from 6 each payment may not exceed 25 percent of the benefit payment without prior authorization from 7 8 the worker.

9 (C) Impose a sanction against a medical service provider that unreasonably fails to provide in 10 a timely manner diagnostic records required for an independent medical examination.

(D) Establish a process for randomly selecting a physician to perform medical examina tions authorized under this section from a list of qualified physicians the director maintains
 as required under ORS 656.328.

(E) Establish a process to select providers to perform independent medical examinations
 outside this state.

(d) Notwithstanding ORS 656.262 (6), if the director determines that the location selected for an
independent medical examination is unreasonable, the insurer or self-insured employer shall accept
or deny the claim within 90 days after the employer has notice or knowledge of the claim.

(e) If the worker has made a timely request for a hearing on a denial of compensability as required by ORS 656.319 (1)(a) that is based on one or more reports of examinations conducted pursuant to paragraph (a) of this subsection and the worker's attending physician or nurse practitioner authorized to provide compensable medical services under ORS 656.245 does not concur with the report or reports, the worker may request an examination to be conducted by a physician selected **at random** by the director from the list described in ORS 656.328. The cost of the examination and the examination report shall be paid by the insurer or self-insured employer.

(f) The insurer or self-insured employer shall pay the costs of the medical examination and related services which are reasonably necessary to allow the worker to submit to any examination requested under this section. As used in this paragraph, "related services" includes, but is not limited to, child care, travel, meals, lodging and an amount equivalent to the worker's net lost wages for the period during which the worker is absent if the worker does not receive benefits pursuant to ORS 656.210 (4) during the period of absence. A claim for "related services" described in this paragraph shall be made in the manner prescribed by the director.

(g) A worker who objects to the location of an independent medical examination must request
 review by the director under paragraph (c)(A) of this subsection within six business days of the date
 the notice of the independent medical examination was mailed.

(2) For any period of time during which any worker commits insanitary or injurious practices which tend to either imperil or retard recovery of the worker, or refuses to submit to such medical or surgical treatment as is reasonably essential to promote recovery, or fails to participate in a program of physical rehabilitation, the right of the worker to compensation shall be suspended with the consent of the director and no payment shall be made for such period. The period during which such worker would otherwise be entitled to compensation may be reduced with the consent of the director to such an extent as the disability has been increased by such refusal.

(3) A worker who has received an award for permanent total or permanent partial disability
should be encouraged to make a reasonable effort to reduce the disability; and the award shall be
subject to periodic examination and adjustment in conformity with ORS 656.268.

(4) When the employer of an injured worker, or the employer's insurer determines that the in-1 2 jured worker has failed to follow medical advice from the attending physician or nurse practitioner authorized to provide compensable medical services under ORS 656.245 or has failed to participate 3 in or complete physical restoration or vocational rehabilitation programs prescribed for the worker 4 pursuant to this chapter, the employer or insurer may petition the director for reduction of any $\mathbf{5}$ benefits awarded the worker. Notwithstanding any other provision of this chapter, if the director 6 finds that the worker has failed to accept treatment as provided in this subsection, the director may 7 reduce any benefits awarded the worker by such amount as the director considers appropriate. 8

9 (5)(a) Except as provided by ORS 656.268 (4)(c) and (11), an insurer or self-insured employer shall 10 cease making payments pursuant to ORS 656.210 and shall commence making payment of such 11 amounts as are due pursuant to ORS 656.212 when an injured worker refuses wage earning em-12 ployment prior to claim determination and the worker's attending physician or nurse practitioner 13 authorized to provide compensable medical services under ORS 656.245, after being notified by the 14 employer of the specific duties to be performed by the injured worker, agrees that the injured 15 worker is capable of performing the employment offered.

(b) If the worker has been terminated for violation of work rules or other disciplinary reasons, the insurer or self-insured employer shall cease payments pursuant to ORS 656.210 and commence payments pursuant to ORS 656.212 when the attending physician or nurse practitioner authorized to provide compensable medical services under ORS 656.245 approves employment in a modified job that would have been offered to the worker if the worker had remained employed, provided that the employer has a written policy of offering modified work to injured workers.

(c) If the worker is a person present in the United States in violation of federal immigration laws, the insurer or self-insured employer shall cease payments pursuant to ORS 656.210 and commence payments pursuant to ORS 656.212 when the attending physician or nurse practitioner authorized to provide compensable medical services under ORS 656.245 approves employment in a modified job whether or not such a job is available.

27 28 (6) Any party may request a hearing on any dispute under this section pursuant to ORS 656.283. **SECTION 2.** ORS 656.328 is amended to read:

656.328. (1) The Director of the Department of Consumer and Business Services shall maintain
a list of providers that are authorized to perform [*independent*] medical examinations that are authorized under this section.

(2) A provider on the list maintained by the director under subsection (1) of this section may 32be excluded from the list by the director after a finding of a violation of standards of professional 33 34 conduct for conducting independent medical examinations adopted by the appropriate health pro-35fessional regulatory board. The director shall adopt by rule standards of professional conduct for providers performing independent medical examinations if the appropriate health professional regu-36 37 latory board has not adopted standards pertaining to independent medical examinations. The rules 38 adopted by the director under this subsection may be consistent with the guidelines of conduct published by the Independent Medical Examination Association in effect on June 4, 2007. The deci-39 40 sion of the director to exclude a provider from the list maintained under subsection (1) of this section is subject to review under ORS 656.704. 41

(3) The director, in consultation with the advisory committee on medical care of the Workers'
Compensation Division of the Department of Consumer and Business Services, the Workers' Compensation Management-Labor Advisory Committee and affected interest groups shall develop, and
the director shall adopt by rule:

(a) Professional licensing training requirements and educational materials for physicians partic-1 $\mathbf{2}$ ipating in the workers' compensation system and conducting independent medical examinations re-3 quired under ORS 656.325 (1); and (b) A process for investigating and reviewing complaints about independent medical examina-4 tions conducted under the requirements of ORS 656.325 (1) that includes, but is not limited to, $\mathbf{5}$ standards for referring complaints to the appropriate health professional regulatory board and an 6 7appeals process for a physician who disagrees with an action taken by the director under subsection 8 (2) of this section. 9 SECTION 3. The amendments to ORS 656.325 and 656.328 by sections 1 and 2 of this 2017 Act apply to requests for independent medical examinations on or after the effective date 10
