

# Senate Bill 930

Sponsored by Senator PROZANSKI

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Specifies that registered owner of vehicle may black out or obscure residence address, business address, mailing address or vehicle address shown on registration card and on proof of insurance or other current proof of compliance.

## A BILL FOR AN ACT

1  
2 Relating to vehicles; amending ORS 803.500 and 806.011.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 803.500 is amended to read:

5 803.500. The Department of Transportation shall furnish for each vehicle and camper registered  
6 by the department, a registration card that shows all of the following information:

7 (1) The name of the registered owner.

8 (2) The make.

9 (3) The year model.

10 (4) The vehicle identification number as denoted by the title issued for the vehicle or camper.

11 (5) The mileage of the vehicle as reported to the department at the time the most recent title  
12 transfer was reported to the department, or the mileage reported to the department at the time the  
13 vehicle was initially titled in Oregon, whichever occurred last.

14 (6) The word "totaled" if the vehicle has been reported to the department as a totaled vehicle  
15 under the provisions of ORS 819.012 or 819.014, unless the reason for the report was theft and the  
16 vehicle has been recovered.

17 (7) Any other information required by the department.

18 **(8) Notwithstanding subsection (7) of this section, after receiving the registration card**  
19 **from the department, the registered owner may black out or otherwise obscure the residence**  
20 **address, business address, mailing address or vehicle address shown on the registration card.**  
21 **No other information on the registration card may be blacked out or otherwise obscured.**

22 **SECTION 2.** ORS 806.011 is amended to read:

23 806.011. (1) Proof of insurance issued as provided in ORS 742.447, or other current proof of  
24 compliance with financial or future responsibility requirements approved by rule by the Department  
25 of Transportation, shall be carried in each motor vehicle that is operating in this state and that is  
26 not exempt from compliance with financial or future responsibility requirements.

27 (2) The use of an electronic device to display proof of insurance does not constitute consent for  
28 a police officer to access other contents of the electronic device.

29 (3) Failure of the driver of a motor vehicle to show proof of insurance or other **current** proof  
30 of compliance when asked to do so by a police officer is reasonable grounds for the officer to believe  
31 that the person is operating the vehicle in violation of ORS 806.010.

1           **(4) The registered owner of the motor vehicle may black out or otherwise obscure the**  
2 **residence address, business address, mailing address or vehicle address shown on the proof**  
3 **of insurance, or other current proof of compliance with financial or future responsibility**  
4 **requirements approved by rule by the department. No other information may be blacked out**  
5 **or otherwise obscured.**
