SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Travel Information Council to manage roadside rest areas along interstate and state highways.

Directs council to develop transition plan with Department of Transportation and State Parks and Recreation Department. Directs council to report to interim committees on transportation about transition plan no later than September 15, 2018.

Becomes operative January 2, 2019.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 377.841 is amended to read:

5 [(1)] (2) The Travel Information Council shall manage, maintain, improve and develop for local
6 economic development and other purposes identified in ORS 377.705 **the** roadside rest areas **listed**

35 section, the council may enter into contracts necessary to accomplish the purposes of subsection (1) of

37 (3) The Department of Transportation **and the State Parks and Recreation Department** shall:

38 (a) Maintain ownership of [*any*] **the** roadside rest [*area located along an interstate highway*]
39 **areas** that the council manages, maintains, improves and develops pursuant to subsection [(1)] (2)
40 of this section; and

41 (b) Enter into [*an*] intergovernmental [*agreement*] **agreements** with the council under which the
42 council has the authority to manage, maintain, improve and develop those **roadside** rest areas
43 owned by the [*department that are listed in subsection (1) of this section*] **departments.**

44 (4) Under the intergovernmental [*agreement*] **agreements** entered into under subsection (3) of
45 this section, the council shall conduct public contracting activities in accordance with the pro-

1 visions of ORS 377.836.

2 (5) For the purpose of funding the management, maintenance, improvement and development of
3 roadside rest areas under this section, the Department **of Transportation** shall allocate to the
4 council, no later than [January 2] **July 1** of each year, [\$6.55] \$_____ million from the State
5 Highway Fund.

6 (6) The council may not use any moneys originating from a local transient lodging tax or a state
7 transient lodging tax, as those terms are defined in ORS 320.300, for the purpose of funding the
8 management, maintenance, improvement and development of roadside rest areas under this section.

9 **SECTION 2. The amendments to ORS 377.841 by section 1 of this 2017 Act become oper-**
10 **ative on January 2, 2019.**

11 **SECTION 3. (1) The Travel Information Council, after consulting with the Department**
12 **of Transportation and the State Parks and Recreation Department, shall develop a plan for**
13 **transitioning the management of roadside rest areas from the departments to the council.**
14 **The council shall manage all of the roadside rest areas listed in ORS 377.841 no later than**
15 **January 1, 2024.**

16 (2) The council shall provide a report on the transition plan to the interim committees
17 related to transportation in the manner provided by ORS 192.245 no later than September 15,
18 2018.
