**PROPOSED AMENDMENTS TO  
SENATE BILL 1057**

1 On page 15 of the printed bill, after line 39, insert:

**“TRACKING**

5 **“SECTION 36c. Section 36d of this 2017 Act is added to and made a**  
6 **part of ORS 475B.400 to 475B.525.**

7 **“SECTION 36d. (1) The Oregon Health Authority shall enter into**  
8 **an agreement with the Oregon Liquor Control Commission under**  
9 **which the commission shall use the system developed and maintained**  
10 **under ORS 475B.150 to track:**

11 **“(a) The propagation of immature marijuana plants and the pro-**  
12 **duction of marijuana by persons designated to produce marijuana by**  
13 **registry identification cardholders;**

14 **“(b) The processing of marijuana into medical cannabinoid pro-**  
15 **ducts, cannabinoid concentrates and cannabinoid extracts that are**  
16 **transferred to a medical marijuana dispensary;**

17 **“(c) The transfer of usable marijuana, immature marijuana plants,**  
18 **medical cannabinoid products, cannabinoid concentrates and**  
19 **cannabinoid extracts by a medical marijuana dispensary to a registry**  
20 **identification cardholder or the designated primary caregiver of a**  
21 **registry identification cardholder; and**

1       “(d) The transfer of usable marijuana, immature marijuana plants,  
2       medical cannabinoid products, cannabinoid concentrates and  
3       cannabinoid extracts between marijuana grow sites, marijuana pro-  
4       cessing sites and medical marijuana dispensaries.

5       “(2) Marijuana grow sites, marijuana processing sites, medical  
6       marijuana dispensaries and any other person that processes marijuana  
7       into medical cannabinoid products and cannabinoid concentrates for  
8       the purpose of transferring the medical cannabinoid products and  
9       cannabinoid concentrates to a medical marijuana dispensary are sub-  
10      ject to tracking under this section. The commission shall adopt by  
11      rule a schedule by which the commission shall subject marijuana grow  
12      sites, marijuana processing sites and medical marijuana dispensaries  
13      to tracking under this section.

14      “(3) On and after the date on which a marijuana grow site becomes  
15      subject to tracking under this section, the marijuana grow site is ex-  
16      empt from the requirements of ORS 475B.423 and the provisions of  
17      ORS 475B.420 that relate to ORS 475B.423.

18      “(4) On and after the date on which a marijuana processing site  
19      becomes subject to tracking under this section, the marijuana pro-  
20      cessing site is exempt from the requirements of ORS 475B.438 and the  
21      provisions of ORS 475B.435 that relate to ORS 475B.438.

22      “(5) On and after the date on which a medical marijuana dispensary  
23      becomes subject to tracking under this section, the medical marijuana  
24      dispensary is exempt from the requirements of ORS 475B.453 and the  
25      provisions of ORS 475B.450 that relate to ORS 475B.453.”.
