**PROPOSED AMENDMENTS TO  
SENATE BILL 1057**

1 On page 1 of the printed bill, line 9, after the semicolon insert “repealing  
2 sections 29 and 29b, chapter 83, Oregon Laws 2016;”.

3 On page 15, after line 39, insert:

5 **“DISTANCE FROM SCHOOLS**

7 **“SECTION 36c. Section 36d of this 2017 Act is added to and made a  
8 part of ORS 475B.010 to 475B.395.**

9 **“SECTION 36d. Notwithstanding ORS 475B.110 (2)(d), a marijuana  
10 retailer may be located within a 1,000 feet of a school if:**

11 **“(1) The marijuana retailer is not located within 500 feet of:**

12 **“(a) A public elementary or secondary school for which attendance  
13 is compulsory under ORS 339.020; or**

14 **“(b) A private or parochial elementary or secondary school, teach-  
15 ing children as described in ORS 339.030 (1)(a); and**

16 **“(2) The Oregon Liquor Control Commission determines that there  
17 is a physical or geographic barrier capable of preventing children from  
18 traversing to the premises of the marijuana retailer.**

19 **“SECTION 36e. Section 36f of this 2017 Act is added to and made a  
20 part of ORS 475B.400 to 475B.525.**

21 **“SECTION 36f. Notwithstanding ORS 475B.450 (3)(d), a medical**

1 marijuana dispensary may be located within a 1,000 feet of a school if:

2 “(1) The medical marijuana dispensary is not located within 500 feet  
3 of:

4 “(a) A public elementary or secondary school for which attendance  
5 is compulsory under ORS 339.020; or

6 “(b) A private or parochial elementary or secondary school, teach-  
7 ing children as described in ORS 339.030 (1)(a); and

8 “(2) The Oregon Liquor Control Commission determines that there  
9 is a physical or geographic barrier capable of preventing children from  
10 traversing to the premises of the medical marijuana dispensary.”.

11 On page 36, delete lines 43 through 45.

12 On page 37, delete lines 1 through 9.

13 In line 10, delete “85” and insert “84”.

14 On page 39, after line 7, insert:

16 “REPEALS

18 “SECTION 85. Sections 29 and 29b, chapter 83, Oregon Laws 2016,  
19 are repealed.”.

20 Delete lines 18 through 26 and insert:

21 “SECTION 88. (1) Sections 23 to 26 and 30 of this 2017 Act, the  
22 amendments to ORS 475B.605 and 475B.655 by sections 32 and 33 of this  
23 2017 Act and the repeal of sections 29 and 29b, chapter 83, Oregon Laws  
24 2016, by section 85 of this 2017 Act become operative on January 1, 2018.

25 “(2) The Oregon Liquor Control Commission and the Oregon Health  
26 Authority may take any action before the operative date specified in  
27 subsection (1) of this section that is necessary to enable the commis-  
28 sion and authority to exercise, on and after the operative date speci-  
29 fied in subsection (1) of this section, all the duties, powers and  
30 functions conferred on the commission and authority by sections 23

1 to 26 and 30 of this 2017 Act, the amendments to ORS 475B.605 and  
2 475B.655 by sections 32 and 33 of this 2017 Act and the repeal of sections  
3 29 and 29b, chapter 83, Oregon Laws 2017, by section 85 of this 2017  
4 Act.”.
