**PROPOSED AMENDMENTS TO
HOUSE BILL 3353**

1 On page 1 of the printed bill, line 2, delete “creating new provisions;
2 amending ORS 336.213;”.

3 Delete lines 5 through 30 and delete pages 2 and 3 and insert:

4 **“SECTION 1. (1) As used in this section:**

5 **“(a) ‘Dental screening’ has the meaning given that term in ORS**
6 **336.213.**

7 **“(b) ‘Prekindergarten program’ means a program that is recognized**
8 **as an Oregon prekindergarten program under ORS 329.170 to 329.200.**

9 **“(2) A school district or prekindergarten program that causes a**
10 **dental screening to be conducted of all of the students in one or more**
11 **classrooms or in one or more grades where the students are 14 years**
12 **of age or younger must provide the students or the parents or guard-**
13 **ians of the students an opportunity to request not to participate in the**
14 **dental screening.**

15 **“(3) At least two weeks before a school district or prekindergarten**
16 **program causes to be conducted a dental screening of all of the stu-**
17 **dents in one or more classrooms or in one or more grades where the**
18 **students are 14 years of age or younger, the school district or**
19 **prekindergarten program must provide written notice of the dental**
20 **screening to each student for whom the dental screening will be con-**
21 **ducted.**

1 **“(4) The notice required by subsection (3) of this section must:**

2 **“(a) Explain that either a student or a parent or guardian of a**
3 **student has the right to request in writing that the student not par-**
4 **ticipate in the dental screening;**

5 **“(b) Explain that, on the day of the dental screening, a student or**
6 **a parent or guardian of a student may request, orally or in writing,**
7 **that the student not participate in the screening;**

8 **“(c) Explain who will administer the dental screening and who will**
9 **have access to the results of screening; and**

10 **“(d) Meet any other requirements established by the State Board**
11 **of Education by rule.**

12 **“(5) This section does not authorize a school district or a**
13 **prekindergarten program to cause a dental screening to be conducted**
14 **on an individual student who is 14 years of age or younger without**
15 **first receiving the written consent of a parent or guardian of the stu-**
16 **dent if the dental screening is not conducted as part of a dental**
17 **screening of all students in one or more classrooms or one or more**
18 **grades.**

19 **“SECTION 2. Section 1 of this 2017 Act first applies to actions**
20 **causing a dental screening to be conducted during the 2017-2018 school**
21 **year.**

22 **“SECTION 3. This 2017 Act takes effect on the 91st day after the**
23 **date on which the 2017 regular session of the Seventy-ninth Legislative**
24 **Assembly adjourns sine die.”.**
