**PROPOSED AMENDMENTS TO
SENATE CONCURRENT RESOLUTION 17**

1 Delete lines 2 through 25 of the printed concurrent resolution and insert:

2 “Whereas Oregon State University (OSU) earned its first official victory
3 in women’s basketball on December 7, 1976; and

4 “Whereas the 2015-2016 and 2016-2017 seasons will also be remembered as
5 times of notable victories and achievements for the OSU Women’s Basketball
6 Team; and

7 “Whereas in 2016, the OSU Women’s Basketball Team made the National
8 Collegiate Athletic Association (NCAA) Women’s Final Four for the first
9 time in program history; and

10 “Whereas in 2017, the OSU Women’s Basketball Team advanced to the
11 NCAA Women’s Sweet 16 for the second year in a row; and

12 “Whereas the OSU Women’s Basketball Team won consecutive Pacific-12
13 (Pac-12) regular-season championships in 2015, 2016 and 2017; and

14 “Whereas the OSU Women’s Basketball Team earned its first ever Pac-12
15 Tournament championship in 2016; and

16 “Whereas Oregon State University was selected to host the first two
17 rounds of the NCAA Tournament in 2015, 2016 and 2017; and

18 “Whereas the OSU Women’s Basketball Team ended the 2015-2016 season
19 ranked as the number two team in the nation, according to the Women’s
20 Basketball Coaches Association (WBCA) coaches poll, and ended the
21 2016-2017 season ranked ninth in the USA Today coaches poll; and

1 “Whereas in February 2017, the OSU Women’s Basketball Team set a
2 program record for single-game attendance, when the team played against
3 Stanford University before a sold-out crowd of 9,604 fans at Gill Coliseum;
4 and

5 “Whereas OSU Women’s Basketball Team guard Jamie Weisner was
6 named an All-American and Pac-12 Conference Player of the Year in 2016;
7 and

8 “Whereas OSU Women’s Basketball Team center Ruth Hamblin was
9 named an Academic All-American and Senior CLASS Award All-American in
10 2016 and was chosen as Pac-12 Defensive Player of the Year for the second
11 consecutive season; and

12 “Whereas in 2017, OSU Women’s Basketball Team guard Sydney Wiese
13 was named to the All-Pac-12 team, becoming only the 14th player in Pac-12
14 history to receive that honor four times, and was chosen as Pac-12 Scholar
15 Athlete of the Year and a Wooden Award All-American; and

16 “Whereas OSU Women’s Basketball Team center Marie Gulich was named
17 to the 2017 All-Pac-12 team; and

18 “Whereas OSU Women’s Basketball Team guard Gabriella Hanson was
19 chosen as Pac-12 Defensive Player of the Year in 2017; and

20 “Whereas OSU Women’s Basketball Team guard Mikayla Pivec was
21 named to the Pac-12 All-Freshman team in 2017; and

22 “Whereas the OSU women’s basketball program has embodied standards
23 of high academic and athletic success, creating a family-friendly environment
24 for fans; and

25 “Whereas the OSU women’s basketball program has fostered a team cul-
26 ture of integrity, honesty, high character and grit that sets a sterling exam-
27 ple for younger players; now, therefore,”.

28 In line 29, delete “season” and insert “and 2016-2017 seasons”.
