**PROPOSED AMENDMENTS TO
HOUSE BILL 3370**

1 On page 1 of the printed bill, line 2, after “projects;” delete the rest of
2 the line and insert “and de-”.

3 Delete lines 5 through 30 and delete pages 2 and 3 and insert:

4 **“SECTION 1. (1) As used in this section:**

5 **“(a) ‘Coordinate’ means to provide proactive and systematic assist-**
6 **ance in obtaining, facilitation of and connection with health and social**
7 **services, through communication, collaboration and sharing of infor-**
8 **mation among providers of health and social services.**

9 **“(b) ‘Health and social services’ means:**

10 **“(A) Case management;**

11 **“(B) Health navigation;**

12 **“(C) Mental health and addiction supports and services;**

13 **“(D) In-home supports, including housekeeping, personal care, meal**
14 **preparation, laundry services and transportation; and**

15 **“(E) Food insecurity interventions.**

16 **“(c)(A) ‘Housing with services project’ means an entity that coor-**
17 **dinates two or more health and social services for senior citizens and**
18 **people with disabilities who are living in publicly subsidized or private**
19 **congregate settings.**

20 **“(B) ‘Housing with services project’ does not include:**

21 **“(i) A health care facility licensed under ORS 441.015.**

1 “(ii) A residential facility licensed under ORS 443.410.
2 “(iii) An adult foster home licensed under ORS 443.725.
3 “(iv) A continuing care retirement community as defined in ORS
4 101.020.
5 “(v) A program of all-inclusive care for the elderly as described in
6 42 C.F.R. 460.6.
7 “(vi) Transient lodging as defined in ORS 320.300.
8 “(vii) A hotel as defined in ORS 699.005.
9 “(2) Except as provided in subsection (3) of this section, a housing
10 with services project shall register with the Department of Human
11 Services by submitting the name, address and primary contact of the
12 housing with services project to the department.
13 “(3)(a) A housing with services project is not required to register
14 with the Department of Human Services under this section if the
15 housing with services project is regulated by the Housing and Com-
16 munity Services Department or the federal Department of Housing and
17 Urban Development.
18 “(b) The Department of Human Services and the Housing and
19 Community Services Department shall collaborate to develop a joint
20 inventory of the names and addresses of housing with services projects
21 that are not required to register under this section.
22 “(c) The Department of Human Services shall collaborate with the
23 federal Department of Housing and Urban Development to obtain the
24 names and addresses of subsidized senior housing properties regulated
25 by or on record at the federal Department of Housing and Urban De-
26 velopment.
27 “(4) The Department of Human Services shall provide housing with
28 services projects with information on resources available for tenants,
29 including but not limited to:
30 “(a) Information about the Aging and Disability Resource Con-

2 **“(b) Information about hotlines for reporting abuse.**

3 **“(5) The Department of Human Services may adopt rules imple-**
4 **menting this section.**

5 **“SECTION 2. (1) Section 1 of this 2017 Act becomes operative on**
6 **January 1, 2018.**

7 **“(2) The Department of Human Services and the Housing and**
8 **Community Services Department may take any action before the op-**
9 **erative date specified in subsection (1) of this section that is necessary**
10 **to enable the departments, on and after the operative date specified**
11 **in subsection (1) of this section, to exercise the duties, functions and**
12 **powers conferred on the departments by section 1 of this 2017 Act.**

13 **“SECTION 3. This 2017 Act being necessary for the immediate**
14 **preservation of the public peace, health and safety, an emergency is**
15 **declared to exist, and this 2017 Act takes effect on its passage.”.**
