(1) The Oregon Department of Energy and Climate, in coordination with the Oregon Energy and Climate Board, shall develop and submit a proposal, including recommendations for legislation, for restructuring this state's policies and programs related to greenhouse gas emissions or climate change, with the goals of ensuring that:

"(a) The State of Oregon has a designated agency that is charged
with a definitive leadership role in climate policy and program coordination, development, analysis and prioritization;

"(b) All state climate policies and programs are administered in a
 well-coordinated manner that positions this state to achieve the
 greenhouse gas emissions reduction goals set forth in ORS 468A.205;
