**PROPOSED AMENDMENTS TO  
HOUSE BILL 3203**

1 On page 1 of the printed bill, line 4, delete “declaring an emergency” and  
2 insert “prescribing an effective date”.

3 Delete lines 6 through 24 and delete pages 2 through 9 and insert:

4 **“SECTION 1.** ORS 279C.305 is amended to read:

5 “279C.305. (1) [*It is*] The policy of the State of Oregon **is** that contracting  
6 agencies shall make every effort to construct public improvements at the  
7 least cost to the contracting agency.

8 “(2) Not less than 30 days [*prior to adoption of the contracting agency’s*]  
9 **before adopting a** budget for the subsequent budget period, each contracting  
10 agency shall prepare and file with the Commissioner of the Bureau of Labor  
11 and Industries a list of every public improvement [*known to the contracting*  
12 *agency*] that the contracting agency plans to fund in the budget period,  
13 identifying each improvement by name and estimating the total on-site con-  
14 struction costs. The list [*shall*] **must** also [*contain a statement as to*] **state**  
15 whether the contracting agency intends to perform the construction through  
16 a private contractor. If the contracting agency intends to perform con-  
17 struction work using the contracting agency’s own equipment and personnel  
18 on a project estimated to cost more than \$125,000, the contracting agency  
19 shall [*also show*] **include with the list an analysis that shows** that the  
20 contracting agency’s decision conforms to the policy stated in subsection (1)  
21 of this section. The list [*is a*] **and the analysis are** public [*record*] **records**

1 and the contracting agency may periodically revise the list or analysis  
2 [*may be revised periodically by the agency*].

3 “(3) As part of the analysis described in subsection (2) of this sec-  
4 tion, a contracting agency shall:

5 “(a) Estimate the cost of constructing a public improvement by  
6 contracting with a private contractor;

7 “(b) Include in the contracting agency’s estimate of the costs the  
8 contracting agency would incur in constructing the public improve-  
9 ment with the contracting agency’s own equipment and personnel:

10 “(A) The cost of labor, including all benefits, workers’ compen-  
11 sation insurance premiums and the cost of traveling to and from the  
12 site of the public improvement that the contracting agency pays to or  
13 on behalf of the contracting agency’s employees;

14 “(B) The cost of equipment, including any costs associated with  
15 acquiring, owning, insuring, storing, operating, repairing and main-  
16 taining the equipment and transporting the equipment to and from the  
17 site of the public improvement;

18 “(C) The costs of administration and overhead the contracting  
19 agency will incur, including costs associated with maintaining a shop  
20 or office and the costs of insurance that the contracting agency allo-  
21 cates to the public improvement;

22 “(D) The cost of tools and materials;

23 “(E) Costs associated with any contracts into which the contracting  
24 agency must enter;

25 “(F) The reasonable value of warranties and quality control if the  
26 contracting agency would require warranties and quality control of a  
27 private contractor that constructed the public improvement; and

28 “(G) Any other costs that the contracting agency would incur to  
29 construct the public improvement with the contracting agency’s own  
30 equipment and personnel; and

1       “(c) Compare the cost the contracting agency estimates under par-  
2       agraph (a) of this subsection with the cost the contracting agency  
3       would incur to construct the public improvement with the contracting  
4       agency’s own equipment and personnel, taking into account all of the  
5       elements specified in paragraph (b) of this subsection.

6       “[(3)] (4) Before a contracting agency constructs a public improvement  
7       with [its] **the contracting agency’s** own equipment or personnel, **the con-**  
8       **tracting agency shall:**

9       “[(a) *If the estimated cost exceeds \$125,000, the contracting agency shall*  
10       *prepare adequate plans and specifications and the estimated unit cost of each*  
11       *classification of work. The estimated cost of the work must include a reason-*  
12       *able allowance for the cost, including investment cost, of any equipment used.*  
13       *As used in this paragraph, ‘adequate’ means sufficient to control the perform-*  
14       *ance of the work and to ensure satisfactory quality of construction by the*  
15       *contracting agency personnel.*]

16       “(a) **Prepare plans, specifications and estimates of the unit cost of**  
17       **each classification of work that are sufficient to control the perform-**  
18       **ance of the work and ensure satisfactory construction quality, if the**  
19       **estimated cost of the public improvement exceeds \$125,000.**

20       “(b) [*The contracting agency shall cause to be kept and preserved*] **Prepare**  
21       **and preserve** a full, true and accurate account of the **actual** costs of per-  
22       forming the work, including all [*engineering and administrative expenses and*  
23       *the cost, including investment costs, of any equipment used*] **costs described**  
24       **in subsection (3)(b) of this section, and use the costs in future cost**  
25       **estimates for the public improvement.** The final account of the costs is  
26       a public record.

27       “[(4)] (5) Subsections (2) [*and (3)*] **to (4)** of this section do not apply to  
28       a contracting agency [*when*] **if** the public improvement is [*to be used for the*  
29       *distribution or transmission of*] **for distributing or transmitting** electric  
30       power.

1       **“[(5)] (6)(a) Except as provided in paragraph (b) of this subsection,**  
2 **for purposes of this section, resurfacing [of] highways, roads or streets at a**  
3 **depth of two or more inches [and] or at an estimated cost that exceeds**  
4 **\$125,000 is a public improvement.**

5       **“(b) For purposes of this section, a public improvement does not**  
6 **include:**

7       **“(A) Maintaining a road with patching, chip seals or other seals as**  
8 **a maintenance treatment on highways, roads, streets or bridges; or**

9       **“(B) Maintenance resurfacing for a single road, highway or street**  
10 **in different locations along the road, highway or street, even if the**  
11 **total cost of the resurfacing exceeds \$125,000, provided that the cost**  
12 **of resurfacing any one location on the road, highway or street does**  
13 **not exceed \$125,000 and provided that the contracting agency does not**  
14 **artificially separate the resurfacing project into smaller projects in**  
15 **order to avoid the application of this section.**

16       **“SECTION 2. Section 3 of this 2017 Act is added to and made a part**  
17 **of ORS chapter 279C.**

18       **“SECTION 3. (1)(a) A contractor that would be eligible to construct**  
19 **a public improvement under this chapter or a trade association of**  
20 **contractors acting on behalf of a member of the trade association may**  
21 **allege in a complaint to the Commissioner of the Bureau of Labor and**  
22 **Industries that a contracting agency has violated ORS 279C.305 or**  
23 **279C.310.**

24       **“(b) A complaint under paragraph (a) of this subsection must set**  
25 **forth the acts or omissions that constitute the alleged violation. The**  
26 **contractor or trade association must file the complaint with the com-**  
27 **missioner within one year after the alleged violation occurred.**

28       **“(c) A contractor or trade association may not file a complaint**  
29 **under this subsection if the contractor or trade association has**  
30 **brought an action in a court of this state that alleges an act or omis-**

1 sion that is the same or substantially similar to an act or omission the  
2 contractor or trade association would allege in the complaint. The  
3 commissioner may not act on a complaint described in this paragraph.

4 “(2) The commissioner shall investigate an alleged violation of ORS  
5 279C.305 or 279C.310. In the course of an investigation under this sub-  
6 section, the commissioner may:

7 “(a) Compel attendance from witnesses, receive testimony and ex-  
8 amine the witnesses under oath;

9 “(b) Require a contracting agency or an employee of a contracting  
10 agency to produce books, records, files and other documents; and

11 “(c) Take any other action the commissioner deems necessary to  
12 conduct the investigation.

13 “(3)(a) If after an investigation under this section the commissioner  
14 finds substantial evidence of a violation of ORS 279C.305 or 279C.310,  
15 the commissioner shall:

16 “(A) Notify the contracting agency in writing that the commis-  
17 sioner has found substantial evidence of a violation of ORS 279C.305  
18 or 279C.310, describe the nature of the violation and, if the commis-  
19 sioner has not found a violation previously, state that for future vio-  
20 lations, including any future violations that occur during construction  
21 of the same public improvement, the commissioner will require the  
22 contracting agency to negotiate and enter into an agreement under  
23 paragraph (b) of this subsection.

24 “(B) Provide a copy of any notice the commissioner issued under  
25 subparagraph (A) of this paragraph to any contractor or trade associ-  
26 ation that filed a complaint concerning the violation under subsection  
27 (1) of this section.

28 “(b) If the commissioner in the course of the investigation under  
29 paragraph (a) of this subsection finds that the same contracting  
30 agency previously violated ORS 279C.305 or 279C.310, the commissioner

1 shall require the contracting agency to negotiate and enter into an  
2 agreement with the contractor or trade association that submitted a  
3 complaint under subsection (1) of this section to remedy the violation  
4 and prevent future violations. The commissioner in an order may set  
5 forth, and direct the contracting agency to comply with, the terms of  
6 the agreement.

7 “(4)(a) If a contracting agency that is a party to an agreement set  
8 forth in accordance with an order of the commissioner under sub-  
9 section (3)(b) of this section breaches the agreement, a contractor or  
10 trade association that is also a party to the agreement may bring an  
11 action against the contracting agency in a court of this state to:

12 “(A) Petition the court for an injunction to prevent the contracting  
13 agency from breaching or continuing to breach the terms of the  
14 agreement; or

15 “(B) Seek a writ of mandamus under ORS 34.105 to 34.240 to compel  
16 the contracting agency to perform an action required under the terms  
17 of the agreement.

18 “(b) A contractor or trade association must bring an action under  
19 this subsection within one year after the contracting agency’s alleged  
20 breach of the agreement.

21 **“SECTION 4.** ORS 279A.010 is amended to read:

22 “279A.010. (1) As used in the Public Contracting Code, unless the context  
23 or a specifically applicable definition requires otherwise:

24 “(a) ‘Bidder’ means a person that submits a bid in response to an invita-  
25 tion to bid.

26 “(b) ‘Contracting agency’ means a public body authorized by law to con-  
27 duct a procurement. ‘Contracting agency’ includes, but is not limited to, the  
28 Director of the Oregon Department of Administrative Services and any per-  
29 son authorized by a contracting agency to conduct a procurement on the  
30 contracting agency’s behalf. ‘Contracting agency’ does not include the judi-

1 cial department or the legislative department.

2 “(c) ‘Days’ means calendar days.

3 “(d) ‘Department’ means the Oregon Department of Administrative Ser-  
4 vices.

5 “(e) ‘Director’ means the Director of the Oregon Department of Adminis-  
6 trative Services or a person designated by the director to carry out the au-  
7 thority of the director under the Public Contracting Code.

8 “(f) ‘Emergency’ means circumstances that:

9 “(A) Could not have been reasonably foreseen;

10 “(B) Create a substantial risk of loss, damage or interruption of services  
11 or a substantial threat to property, public health, welfare or safety; and

12 “(C) Require prompt execution of a contract to remedy the condition.

13 “(g) ‘Energy savings performance contract’ means a public contract be-  
14 tween a contracting agency and a qualified energy service company for the  
15 identification, evaluation, recommendation, design and construction of en-  
16 ergy conservation measures, including a design-build contract, that guaran-  
17 tee energy savings or performance.

18 “(h) ‘Executive department’ has the meaning given that term in ORS  
19 174.112.

20 “(i) ‘Goods’ includes supplies, equipment, materials, personal property,  
21 including any tangible, intangible and intellectual property and rights and  
22 licenses in relation thereto, and combinations of any of the items identified  
23 in this paragraph.

24 “(j) ‘Goods and services’ or ‘goods or services’ includes combinations of  
25 any of the items identified in the definitions of ‘goods’ and ‘services.’

26 “(k)(A) ‘Grant’ means:

27 “(i) An agreement under which a contracting agency receives moneys,  
28 property or other assistance, including but not limited to federal assistance  
29 that is characterized as a grant by federal law or regulations, loans, loan  
30 guarantees, credit enhancements, gifts, bequests, commodities or other assets,

1 from a grantor for the purpose of supporting or stimulating a program or  
2 activity of the contracting agency and in which no substantial involvement  
3 by the grantor is anticipated in the program or activity other than involve-  
4 ment associated with monitoring compliance with the grant conditions; or

5 “(ii) An agreement under which a contracting agency provides moneys,  
6 property or other assistance, including but not limited to federal assistance  
7 that is characterized as a grant by federal law or regulations, loans, loan  
8 guarantees, credit enhancements, gifts, bequests, commodities or other assets,  
9 to a recipient for the purpose of supporting or stimulating a program or ac-  
10 tivity of the recipient and in which no substantial involvement by the con-  
11 tracting agency is anticipated in the program or activity other than  
12 involvement associated with monitoring compliance with the grant condi-  
13 tions.

14 “(B) ‘Grant’ does not include a public contract for a public improvement,  
15 for public works, as defined in ORS 279C.800, or for emergency work, minor  
16 alterations or ordinary repair or maintenance necessary to preserve a public  
17 improvement, when under the public contract a contracting agency pays, in  
18 consideration for contract performance intended to realize or to support the  
19 realization of the purposes for which grant funds were provided to the con-  
20 tracting agency, moneys that the contracting agency has received under a  
21 grant.

22 “(L) ‘Industrial oil’ means any compressor, turbine or bearing oil, hy-  
23 draulic oil, metal-working oil or refrigeration oil.

24 “(m) ‘Judicial department’ has the meaning given that term in ORS  
25 174.113.

26 “(n) ‘Legislative department’ has the meaning given that term in ORS  
27 174.114.

28 “(o) ‘Local contract review board’ means a local contract review board  
29 described in ORS 279A.060.

30 “(p) ‘Local contracting agency’ means a local government or special gov-

1 ernment body authorized by law to conduct a procurement. ‘Local contract-  
2 ing agency’ includes any person authorized by a local contracting agency to  
3 conduct a procurement on behalf of the local contracting agency.

4 “(q) ‘Local government’ has the meaning given that term in ORS 174.116.

5 “(r) ‘Lowest responsible bidder’ means the lowest bidder who:

6 “(A) Has substantially complied with all prescribed public contracting  
7 procedures and requirements;

8 “(B) Has met the standards of responsibility set forth in ORS 279B.110  
9 or 279C.375;

10 “(C) Has not been debarred or disqualified by the contracting agency un-  
11 der ORS 279B.130 or 279C.440; and

12 “(D) If the advertised contract is a public improvement contract, is not  
13 on the list created by the Construction Contractors Board under ORS  
14 701.227.

15 “(s) ‘Lubricating oil’ means any oil intended for use in an internal com-  
16 bustion crankcase, transmission, gearbox or differential or an automobile,  
17 bus, truck, vessel, plane, train, heavy equipment or machinery powered by  
18 an internal combustion engine.

19 “(t) ‘Person’ means a natural person capable of being legally bound, a sole  
20 proprietorship, a corporation, a partnership, a limited liability company or  
21 partnership, a limited partnership, a for-profit or nonprofit unincorporated  
22 association, a business trust, two or more persons having a joint or common  
23 economic interest, any other person with legal capacity to contract or a  
24 public body.

25 “(u) ‘Post-consumer waste’ means a finished material that would normally  
26 be disposed of as solid waste, having completed its life cycle as a consumer  
27 item. ‘Post-consumer waste’ does not include manufacturing waste.

28 “(v) ‘Price agreement’ means a public contract for the procurement of  
29 goods or services at a set price with:

30 “(A) No guarantee of a minimum or maximum purchase; or

1       “(B) An initial order or minimum purchase combined with a continuing  
2 contractor obligation to provide goods or services in which the contracting  
3 agency does not guarantee a minimum or maximum additional purchase.

4       “(w) ‘Procurement’ means the act of purchasing, leasing, renting or oth-  
5 erwise acquiring goods or services. ‘Procurement’ includes each function and  
6 procedure undertaken or required to be undertaken by a contracting agency  
7 to enter into a public contract, administer a public contract and obtain the  
8 performance of a public contract under the Public Contracting Code.

9       “(x) ‘Proposer’ means a person that submits a proposal in response to a  
10 request for proposals.

11       “(y) ‘Public body’ has the meaning given that term in ORS 174.109.

12       “(z) ‘Public contract’ means a sale or other disposal, or a purchase, lease,  
13 rental or other acquisition, by a contracting agency of personal property,  
14 services, including personal services, public improvements, public works,  
15 minor alterations, or ordinary repair or maintenance necessary to preserve  
16 a public improvement. ‘Public contract’ does not include grants.

17       “(aa) ‘Public contracting’ means procurement activities described in the  
18 Public Contracting Code relating to obtaining, modifying or administering  
19 public contracts or price agreements.

20       “(bb) ‘Public Contracting Code’ or ‘code’ means ORS chapters 279A, 279B  
21 and 279C.

22       “(cc) ‘Public improvement’ means a project for construction, recon-  
23 struction or major renovation on real property by or for a contracting  
24 agency. ‘Public improvement’ does not include:

25       “(A) Projects for which no funds of a contracting agency are directly or  
26 indirectly used, except for participation that is incidental or related prima-  
27 rily to project design or inspection; or

28       “(B) Emergency work, minor alteration, ordinary repair or maintenance  
29 necessary to preserve a public improvement.

30       “(dd) ‘Public improvement contract’ means a public contract for a public

1 improvement. 'Public improvement contract' does not include a public con-  
2 tract for emergency work, minor alterations, or ordinary repair or mainte-  
3 nance necessary to preserve a public improvement.

4 "(ee) 'Recycled material' means any material that would otherwise be a  
5 useless, unwanted or discarded material except for the fact that the material  
6 still has useful physical or chemical properties after serving a specific pur-  
7 pose and can, therefore, be reused or recycled.

8 "(ff) 'Recycled oil' means used oil that has been prepared for reuse as a  
9 petroleum product by refining, rerefining, reclaiming, reprocessing or other  
10 means, provided that the preparation or use is operationally safe, environ-  
11 mentally sound and complies with all laws and regulations.

12 "(gg) 'Recycled paper' means a paper product with not less than:

13 "(A) Fifty percent of its fiber weight consisting of secondary waste ma-  
14 terials; or

15 "(B) Twenty-five percent of its fiber weight consisting of post-consumer  
16 waste.

17 "(hh) 'Recycled PETE' means post-consumer polyethylene terephthalate  
18 material.

19 "(ii) 'Recycled product' means all materials, goods and supplies, not less  
20 than 50 percent of the total weight of which consists of secondary and post-  
21 consumer waste with not less than 10 percent of its total weight consisting  
22 of post-consumer waste. 'Recycled product' includes any product that could  
23 have been disposed of as solid waste, having completed its life cycle as a  
24 consumer item, but otherwise is refurbished for reuse without substantial  
25 alteration of the product's form.

26 "(jj) 'Secondary waste materials' means fragments of products or finished  
27 products of a manufacturing process that has converted a virgin resource  
28 into a commodity of real economic value. 'Secondary waste materials' in-  
29 cludes post-consumer waste. 'Secondary waste materials' does not include  
30 excess virgin resources of the manufacturing process. For paper, 'secondary

1 waste materials' does not include fibrous waste generated during the manu-  
2 facturing process such as fibers recovered from waste water or trimmings of  
3 paper machine rolls, mill broke, wood slabs, chips, sawdust or other wood  
4 residue from a manufacturing process.

5 “(kk) ‘Services’ mean services other than personal services designated  
6 under ORS 279A.055, except that, for state contracting agencies with pro-  
7 curement authority under ORS 279A.050 or 279A.140, ‘services’ includes per-  
8 sonal services as designated by the state contracting agencies.

9 “(LL) ‘Special government body’ has the meaning given that term in ORS  
10 174.117.

11 “(mm) ‘State agency’ means the executive department, except the Secre-  
12 tary of State and the State Treasurer in the performance of the duties of  
13 their constitutional offices.

14 “(nn) ‘State contracting agency’ means an executive department entity  
15 authorized by law to conduct a procurement.

16 “(oo) ‘State government’ has the meaning given that term in ORS 174.111.

17 “(pp) ‘Used oil’ has the meaning given that term in ORS 459A.555.

18 “(qq) ‘Virgin oil’ means oil that has been refined from crude oil and that  
19 has not been used or contaminated with impurities.
