PROPOSED AMENDMENTS TO SENATE BILL 301

- In line 2 of the printed bill, after "practices;" delete the rest of the line
- 2 and insert "creating new provisions; amending ORS 475B.410, 659A.124,
- 3 659A.139 and 659A.885; and prescribing an effective date.".
- 4 Delete lines 4 through 15 and insert:
- 5 "SECTION 1. Section 2 of this 2017 Act is added to and made a part of ORS chapter 659A.
- ⁷ "SECTION 2. (1) It is an unlawful employment practice for an em-
- 8 ployer to refuse to employ an individual or to discharge or otherwise
- 9 penalize an individual because:
- "(a) The individual is a registry identification cardholder, as defined in ORS 475B.410; or
- 12 "(b) The individual is a registry identification cardholder, as defined 13 in ORS 475B.410, and the individual tested positive for cannabis.
- "(2) It is an unlawful employment practice for an employer to discriminate against an employee with respect to compensating the employee or with respect to the terms, conditions or privileges of
- 17 **employment because:**
- 18 "(a) The employee is a registry identification cardholder, as defined 19 in ORS 475B.410; or
- 20 "(b) The employee is a registry identification cardholder, as defined 21 in ORS 475B.410, and the employee tested positive for cannabis.

- "(3) This section does not apply to an employment practice related 1 to: 2
- "(a) The performance of work while impaired; 3
- "(b) The essence of the employer's business, provided that: 4
- "(A) All users or substantially all users of cannabis or cannabis-5 derived products would be unable to perform their work duties safely 6 and efficiently; or 7
- "(B) Some users of cannabis or cannabis-derived products would be 8 unable to perform their work duties safely and efficiently, and determining who is a user of cannabis or cannabis-derived products on an individual basis is impossible or impracticable;
 - "(c) An applicable collective bargaining agreement that prohibits using cannabis or cannabis-derived products during nonworking hours;
 - "(d) A federal law or regulation requiring an employer to test employees or prospective employees for use of cannabis or cannabisderived products; or
 - "(e) A contract between an employer and the federal government under which the receipt of federal moneys is contingent on the employer having a drug-free workplace.
- **"SECTION 3.** ORS 659A.124 is amended to read: 20
- "659A.124. (1) Subject to the provisions of subsection (2) of this section, 21 the protections of ORS 659A.112 do not apply to any job applicant or em-22 ployee who is currently engaging in the illegal use of drugs if the employer 23 takes action based on that conduct. 24
- "(2) The protections of ORS 659A.112 apply to the following individuals: 25
- "(a) An individual who: 26

- "(A) Has successfully completed a supervised drug rehabilitation 27 program; and 28
- "(B)(i) Is no longer engaging in the illegal use of drugs; or 29

- "(b) An individual who is participating in a supervised rehabilitation program and is no longer engaging in the illegal use of drugs.
- "(c) An individual who is erroneously regarded as engaging in the illegal use of drugs.
- "(3) An employer may adopt or administer reasonable policies or procedures, including but not limited to drug testing, designed to ensure that an individual described in subsection (2)(a) or (b) of this section is no longer engaging in the illegal use of drugs.
 - "(4) This section does not apply to the use of marijuana items, as defined in ORS 475B.015, by a registry identification cardholder, as that term is defined in ORS 475B.410.
 - **"SECTION 4.** ORS 659A.139 is amended to read:
 - "659A.139.  - "(8) When the commissioner or the Attorney General has reasonable cause to believe that a person or group of persons is engaged in a pattern or practice of resistance to the rights protected by ORS 659A.145 or 659A.421 or federal housing law, or that a group of persons has been denied any of the rights protected by ORS 659A.145 or 659A.421 or federal housing law, the commissioner or the Attorney General may file a civil action on behalf of the aggrieved persons in the same manner as a person or group of persons may file a civil action under this section. In a civil action filed under this subsection, the court may assess against the respondent, in addition to the relief authorized under subsections (1) and (3) of this section, a civil penalty:
 - "(a) In an amount not exceeding \$50,000 for a first violation; and
 - "(b) In an amount not exceeding \$100,000 for any subsequent violation.
 - "(9) In any action under subsection (1) of this section alleging a violation of ORS 659A.145 or 659A.421 or alleging discrimination under federal housing law, when the commissioner is pursuing the action on behalf of an aggrieved complainant, the court shall award reasonable attorney fees to the commissioner if the commissioner prevails in the action. The court may award reasonable attorney fees and expert witness fees incurred by a defendant that prevails in the action if the court determines that the commissioner had no objectively reasonable basis for asserting the claim or for appealing an ad-

- verse decision of the trial court.
- "(10) In an action under subsection (1) or (8) of this section alleging a
- 3 violation of ORS 659A.145 or 659A.421 or discrimination under federal hous-
- 4 ing law:
- 5 "(a) 'Aggrieved person' includes a person who believes that the person:
- 6 "(A) Has been injured by an unlawful practice or discriminatory housing 7 practice; or
- 8 "(B) Will be injured by an unlawful practice or discriminatory housing 9 practice that is about to occur.
- "(b) An aggrieved person in regard to issues to be determined in an action may intervene as of right in the action. The Attorney General may intervene in the action if the Attorney General certifies that the case is of general public importance. The court may allow an intervenor prevailing party costs and reasonable attorney fees at trial and on appeal.
- "SECTION 6. ORS 475B.410 is amended to read:
- 16 "475B.410. As used in ORS 475B.400 to 475B.525:
- "(1) 'Attending physician' means a physician licensed under ORS chapter 677 who has primary responsibility for the care and treatment of a person diagnosed with a debilitating medical condition.
- 20 "(2) 'Cannabinoid' means any of the chemical compounds that are the 21 active constituents of marijuana.
- "(3) 'Cannabinoid concentrate' means a substance obtained by separating cannabinoids from marijuana by:
- "(a) A mechanical extraction process;
- "(b) A chemical extraction process using a nonhydrocarbon-based solvent, such as vegetable glycerin, vegetable oils, animal fats, isopropyl alcohol or ethanol;
- "(c) A chemical extraction process using the hydrocarbon-based solvent carbon dioxide, provided that the process does not involve the use of high heat or pressure; or

- "(d) Any other process identified by the Oregon Health Authority, in consultation with the Oregon Liquor Control Commission, by rule.
- "(4) 'Cannabinoid edible' means food or potable liquid into which a cannabinoid concentrate, cannabinoid extract or dried leaves or flowers of marijuana have been incorporated.
- 6 "(5) 'Cannabinoid extract' means a substance obtained by separating 7 cannabinoids from marijuana by:
- 8 "(a) A chemical extraction process using a hydrocarbon-based solvent, 9 such as butane, hexane or propane;
- "(b) A chemical extraction process using the hydrocarbon-based solvent carbon dioxide, if the process uses high heat or pressure; or
- "(c) Any other process identified by the Oregon Health Authority, in consultation with the Oregon Liquor Control Commission, by rule.
- "(6) 'Debilitating medical condition' means:
- "(a) Cancer, glaucoma, a degenerative or pervasive neurological condition, positive status for human immunodeficiency virus or acquired immune deficiency syndrome, or a side effect related to the treatment of those medical conditions;
- 19 "(b) A medical condition or treatment for a medical condition that 20 produces, for a specific patient, one or more of the following:
- 21 "(A) Cachexia;
- 22 "(B) Severe pain;
- 23 "(C) Severe nausea;
- 24 "(D) Seizures, including seizures caused by epilepsy; or
- 25 "(E) Persistent muscle spasms, including spasms caused by multiple 26 sclerosis;

- 7 "(B) Who has significant responsibility for managing the well-being of a

- 6 "(A) Usable marijuana by itself;
- 7 "(B) A cannabinoid concentrate by itself;
- 8 "(C) A cannabinoid extract by itself; or
- 9 "(D) Industrial hemp, as defined in ORS 571.300.
- "(16) 'Medical marijuana dispensary' means a medical marijuana dispensary registered under ORS 475B.450 or a site for which an applicant has submitted an application for registration under ORS 475B.450.
- "(17) 'Medical use of marijuana' means the production, processing, possession, delivery or administration of marijuana, or use of paraphernalia used to administer marijuana, to mitigate the symptoms or effects of a debilitating medical condition.
- "(18) 'Person designated to produce marijuana by a registry identification cardholder' means a person designated to produce marijuana by a registry identification cardholder under ORS 475B.420 who produces marijuana for a registry identification cardholder at an address other than the address where the registry identification cardholder resides or at an address where more than 12 mature marijuana plants are produced.
- "(19) 'Process' means the compounding or conversion of marijuana into medical cannabinoid products, cannabinoid concentrates or cannabinoid extracts.

- "(a) Planting, cultivating, growing, trimming or harvesting marijuana; or
- 28 "(b) Drying marijuana leaves or flowers.
- "(21) 'Registry identification card' means a document issued by the Oregon Health Authority under ORS 475B.415 that identifies a person [au-

- 4 "(22) 'Registry identification cardholder' means a person to whom a reg-
- 5 istry identification card has been issued under ORS 475B.415.
- 6 "(23)(a) 'Usable marijuana' means the dried leaves and flowers of marijuana.
- - "(b) 'Usable marijuana' does not include:
- 9 "(A) The seeds, stalks and roots of marijuana; or
 - "(B) Waste material that is a by-product of producing marijuana.
- "(24) 'Written documentation' means a statement signed by the attending
- 12 physician of a person diagnosed with a debilitating medical condition or
- copies of the person's relevant medical records.
- "SECTION 7. This 2017 Act takes effect on the 91st day after the
- date on which the 2017 regular session of the Seventy-ninth Legislative
- 16 Assembly adjourns sine die.".
