PROPOSED AMENDMENTS TO SENATE BILL 36

1 On page 1 of the printed bill, line 2, delete "807.050 and 807.072" and in-2 sert "807.040, 807.050, 807.072, 807.110, 807.140, 807.285, 807.370 and 807.730".

4 **"SECTION 4.** ORS 807.040 is amended to read:

5 "807.040. (1) The Department of Transportation shall issue a driver license
6 to any person who complies with all of the following requirements:

7 "(a) The person must complete an application for a license under ORS
8 807.050.

9 "(b) As required by ORS 807.021 and 807.730, the person must provide the 10 Social Security number assigned to the person by the United States Social 11 Security Administration and proof of legal presence in the United States or, 12 if the person is not eligible for a Social Security number, proof of legal 13 presence in the United States and proof that the person is not eligible for 14 a Social Security number.

"(c) The person must submit to collection of biometric data by the de partment that establish the identity of the person as described in ORS
 807.024.

"(d) The person must not be ineligible for the license under ORS 807.060
and must be eligible for the license under ORS 807.062.

"(e) The person must successfully pass all examination requirements un der ORS 807.070 for the class of license sought.

"(f) The person must pay the appropriate license fee under ORS 807.370
for the class of license sought.

"(g) The person must pay the Student Driver Training Fund eligibility fee.
"(h) If the application is for a commercial driver license, the person must
be the holder of a Class C license or any higher class of license.

"(i) If the application is for a commercial driver license, the person must 6 submit to the department, in a form approved by the department, the report 7 of a medical examination that establishes that the person meets the medical 8 requirements for the particular class of license. The department, by rule, 9 shall establish medical requirements for purposes of this paragraph. The 10 medical requirements established under this paragraph may include any re-11 quirements the department determines are necessary for the safe operation 12of vehicles permitted to be operated under the class of license for which the 13 requirements are established. 14

"(j) If the application is for a commercial driver license, the person must:
 "(A) Have at least one year's driving experience, including relevant experience obtained in the military;

"(B) Not be subject to a lifetime suspension of commercial driving privileges under ORS 809.520;

20 "(C) Not be otherwise ineligible to hold a commercial driver license;

"(D) Hold a commercial learner driver permit if the person must complete
a skills demonstration under ORS 807.070 (3); and

"(E) In addition to meeting the requirement of providing proof of legal presence under ORS 807.021 and this section, the person must submit valid documentation, as defined by the department by rule, that the person is a citizen or permanent legal resident of the United States.

"(2) Subsection (1)(j)(E) of this section does not apply to a limited
term commercial driver license or a limited term commercial learner
driver permit issued under ORS 807.730.

(2) (3) The department shall work with other agencies and organiza-

1 tions to attempt to improve the issuance system for driver licenses.

² "SECTION 5. ORS 807.285 is amended to read:

"807.285. (1) The Department of Transportation shall issue commercial 3 learner driver permits in the manner provided by this section. Except as 4 provided in this section, a person who is issued a commercial learner driver $\mathbf{5}$ permit may exercise the same driving privileges as those under the class of 6 commercial driver license or endorsement for which the permit is issued. 7 Except as provided in this section, a commercial learner driver permit is 8 subject to the provisions, conditions, prohibitions and penalties applicable 9 to a license or endorsement granting the same driving privileges. 10

"(2) The department may issue commercial learner driver permits under
this section that grant the driving privileges of a Class A commercial, Class
B commercial, or Class C commercial driver license, subject to the requirements and restrictions of subsections (6) and (7) of this section.

companying person must have the permit holder under observation and direct 1 supervision and must be occupying a seat beside the holder of the permit or, $\mathbf{2}$ in the case of a commercial passenger vehicle, directly behind or in the first 3 row behind the driver. 4

"(7) The holder of a commercial learner permit may not operate: $\mathbf{5}$

"(a) Any vehicle transporting hazardous materials. 6

"(b) A tank vehicle, unless the tank is empty. 7

"(c) A commercial passenger vehicle while transporting passengers, unless 8 9 the passengers are federal or state auditors or inspectors, test examiners or other trainees and there is a commercial driver license holder accompanying 10

"807.730. (1) The Department of Transportation may issue or replace a 24limited term driver license, limited term commercial driver license, lim-25ited term driver permit, limited term commercial learner driver permit 26or limited term identification card only for a person who provides proof, as 27determined by the department by rule, that the person is legally present in 28the United States on a temporary basis. 29

"807.140. (1) Before the expiration of any license or a license with an endorsement under the vehicle code, the Department of Transportation shall notify the person to whom the license was issued of the approaching expiration. Within a reasonable time prior to the expiration date, the notice shall be mailed to the person to whom the license was issued at the address shown in the files maintained by the department.

"(2) The department is not required to notify the person of an approaching
expiration if the person's license has been suspended, canceled or revoked
or if the person has failed to notify the department of a change of address
as required under ORS 807.560.

"(3) Notwithstanding subsection (1) of this section, the department is not required to notify the person of an approaching expiration if the person received a limited term driver license, **limited term commercial driver license**, limited term driver permit, **limited term commercial learner driver permit** or limited term identification card under ORS 807.730 for a period of less than one year.

"(4) Failure to receive a notice of expiration from the department is not a defense to a charge of driving with an expired license. However, the court may dismiss the charge if the person renews the license before the scheduled court appearance.

"(5) The department's responsibility to maintain records concerning notice
under this section is as provided under ORS 802.210.".
