**PROPOSED AMENDMENTS TO
HOUSE BILL 2906**

1 On page 1 of the printed bill, line 2, delete “declaring an emergency” and
2 insert “prescribing an effective date”.

3 On page 2, after line 28, insert:

4 “(K) One member who is a geographic information systems manager for
5 a county or city in this state;”.

6 In line 29, delete “(K)” and insert “(L)”.

7 In line 31, delete “(L)” and insert “(M)”.

8 In line 33, delete “(M)” and insert “(N)”.

9 Delete lines 36 and 37 and insert:

10 “(O) Three members from state agencies with responsibility for water,
11 land, air quality, natural resources or infrastructure;”.

12 In line 38, delete “(O)” and insert “(P)”.

13 In line 40, delete “(P)” and insert “(Q)”.

14 On page 3, delete lines 5 and 6 and insert:

15 “(6) The council shall elect one of the council’s members to serve as
16 chairperson and one member to serve as vice chairperson. The council shall
17 specify in the charter described in section 3 (1)(d) of this 2017 Act a process
18 by which the council selects the chairperson and vice chairperson and the
19 terms of office for the chairperson and vice chairperson.”.

20 Delete lines 30 through 39 and insert:

21 “(a) Serve as the statewide governing body for sharing and managing

1 geospatial framework data that public bodies share under sections 1 to 6 of
2 this 2017 Act;

3 “(b) Develop and update every four years a strategic plan to manage
4 geospatial framework data that aligns as closely as possible with the Enter-
5 prise Information Resources Management Strategy described in ORS 291.039
6 and oversee the implementation of the plan;

7 “(c) Adopt, in consultation with the State Chief Information Officer,
8 rules, policies and standards that identify geospatial framework data that
9 public bodies must share and that specify how frequently public bodies must
10 share the geospatial framework data;

11 “(d) Recommend an allocation of responsibilities among public bodies for
12 collecting, using, managing, sharing and maintaining geospatial framework
13 data and devise and recommend terms under which public bodies share
14 geospatial framework data;”.

15 In line 40, delete “(d)” and insert “(e)”.

16 In line 42, delete “(e)” and insert “(f)”.

17 In line 45, delete “(f)” and insert “(g)”.

18 On page 4, delete lines 32 through 34 and insert:

19 “(G) Recommend to the Legislative Assembly strategies for eliminating
20 the fees that public bodies charge to other public bodies for geospatial
21 framework data under ORS 190.050 or 192.440.”.

22 On page 6, delete lines 11 through 14 and insert:

23 “(C) Prohibit the sharing or redistribution of the public body’s geospatial
24 framework data if the public body notifies the Oregon Geographic Informa-
25 tion Council in writing that the geospatial framework data is exempt from
26 disclosure under ORS 192.410 to 192.505 because the public body claims a
27 copyright or other proprietary interest in the geospatial framework data or
28 for another reason the public body specifies in the notice.”.

29 In line 31, delete “and”.

30 Delete line 32 and insert:

1 “(B) Protect the availability, integrity and confidentiality of the
2 geospatial data library; and

3 “(C) Ensure that a recipient of geospatial framework data complies with
4 the prohibitions a public body places on sharing or redistributing the
5 geospatial framework data under subsection (2)(b)(C) of this section.”.

6 On page 7, delete lines 4 through 7 and insert:

7 “(4) The State Chief Information Officer may accept gifts, grants, do-
8 nations and contributions from the federal government or agencies of the
9 federal government or from any other public or private source and may agree
10 to any conditions placed on the gift, grant, donation or contribution that is
11 in accordance with applicable law and sections 1 to 6 of this 2017 Act.”.

12 On page 8, delete lines 21 through 23 and insert:

13 **“SECTION 8. This 2017 Act takes effect on the 91st day after the**
14 **date on which the 2017 regular session of the Seventy-ninth Legislative**
15 **Assembly adjourns sine die.”.**
