## PROPOSED AMENDMENTS TO A-ENGROSSED SENATE BILL 561

- On page 1 of the printed A-engrossed bill, line 2, after "679.025" delete the
- 2 rest of the line and insert ", 680.020 and 680.200; and declaring an
- 3 emergency.".
- 4 On page 3, after line 27, insert:
- **"SECTION 3.** ORS 680.200 is amended to read:
- 6 "680.200. (1) Upon application accompanied by the fee established by the
- 7 Oregon Board of Dentistry, the board shall grant a permit to practice as an
- 8 expanded practice dental hygienist to an applicant who:
- 9 "(a) Holds a valid, unrestricted Oregon dental hygiene license;
- "(b) Presents proof of current professional liability insurance coverage;
- "(c) Presents documentation satisfactory to the board of successful com-
- 12 pletion of an emergency life support course for health professionals, includ-
- ing cardiopulmonary resuscitation, from an agency or educational institution
- 14 approved by the board; and
- "(d) Presents documentation satisfactory to the board that the applicant has:
- "(A)(i) Completed 2,500 hours of supervised dental hygiene practice; and
- "(ii) After licensure as a dental hygienist, completed 40 hours of courses,
- 19 chosen by the applicant, in clinical dental hygiene or public health sponsored
- 20 by continuing education providers approved by the board; or
- 21 "(B) Completed a course of study approved by the board that includes at

- least 500 hours of dental hygiene practice, completed before or after gradu-
- 2 ation from a dental hygiene program, on patients described in ORS 680.205
- 3 while under the [direct] indirect supervision of a member of the faculty of
- 4 a dental program or dental hygiene program accredited by the Commission
- 5 on Dental Accreditation of the American Dental Association or its successor
- 6 agency.
- 7 "(2) A permit issued pursuant to subsection (1) of this section expires two
- 8 years following the date of issuance unless renewed on or before that date
- 9 by:

- "(a) Payment of the renewal fee as set by the board;
- "(b) Submission to the board of satisfactory evidence of completion of at
- least 36 hours of continuing education;
  - "(c) Presentation to the board of proof of professional liability insurance
- 14 coverage; and
- 15 "(d) Completion of a survey developed by the board that measures the
  - success of the expanded practice dental hygienist program against baseline
- 17 data.
- 18 "(3) The board may refuse to issue or renew an expanded practice dental
- 19 hygienist permit or may suspend or revoke the permit of an expanded prac-
- 20 tice dental hygienist who has been convicted of an offense or been disci-
- 21 plined by a dental licensing body in a manner that bears, in the judgment
- of the board, a demonstrable relationship to the ability of the applicant to
- 23 practice expanded practice dental hygiene in accordance with the provisions
- of this chapter or ORS chapter 679, or who has falsified an application for
- 25 permit, or any person for any cause described under ORS 679.140 or
- 26 679.170.".
