(1) Notwithstanding section 40 (8), chapter ____, Oregon 8 Laws 2017 (Enrolled Senate Bill 1057), the additional fee imposed by the 9 Oregon Health Authority under section 40 (8), chapter ____, Oregon 10 Laws 2017 (Enrolled Senate Bill 1057), may not be greater than the fee 11 imposed under ORS 475B.420 for marijuana grow sites, ORS 475B.435 12 for marijuana processing sites and ORS 475B.450 for medical marijuana 13 dispensaries. 14 "(2) Pursuant to ORS 475B.025 (2)(d)(G), the Oregon Liquor Control 15 Commission shall impose a fee on licensees, as defined in ORS 16 475B.015, that is calculated to pay costs incurred under section 40, 17 chapter ____, Oregon Laws 2017 (Enrolled Senate Bill 1057), other than 18 costs paid pursuant to section 40 (7) and (8), chapter ____, Oregon Laws 19 2017 (Enrolled Senate Bill 1057). Moneys collected pursuant to this 20 subsection shall be deposited into the Marijuana Control and Regu-21

- lation Fund established under ORS 475B.240 and are continuously ap-
- 2 propriated to the commission for purposes of this subsection.
- "SECTION 3. If Senate Bill 1057 does not become law, section 2 of
 this 2017 Act is repealed.
- "SECTION 4. (1) For the biennium beginning July 1, 2017, in lieu 5 of imposing fees under section 40 (8), chapter ____, Oregon Laws 2017 6 (Enrolled Senate Bill 1057), and section 2 (2) of this 2017 Act, as part 7 of the agreement entered into under section 40, chapter ____, Oregon 8 Laws 2017 (Enrolled Senate Bill 1057), the Oregon Health Authority 9 shall transfer an amount of moneys to the Oregon Liquor Control 10 Commission for deposit in the Marijuana Control and Regulation Fund 11 established under ORS 475B.240 to pay costs incurred under section 40, 12 chapter ____, Oregon Laws 2017 (Enrolled Senate Bill 1057), other than 13 costs paid pursuant to section 40 (7), chapter ___, Oregon Laws 2017 14 (Enrolled Senate Bill 1057). 15
 - "(2) Moneys transferred to the commission under this section must be from moneys collected by the authority as a registration fee under ORS 475B.400 to 475B.525 that are not allocated, appropriated or otherwise dedicated to administering or enforcing ORS 475B.400 to 475B.525.
 - "SECTION 5. If Senate Bill 1057 does not become law, section 4 of this 2017 Act is repealed.
 - "SECTION 6. This 2017 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect on its passage."
