**PROPOSED AMENDMENTS TO
HOUSE BILL 2198**

1 On page 1 of the printed bill, line 2, after “cannabis;” insert “and de-
2 claring an emergency.” and delete the rest of the line and delete lines 3
3 through 23.

4 On page 2, delete lines 1 through 15.

5 Delete lines 17 through 45 and delete pages 3 through 186 and insert:

6 **“SECTION 1. Section 2 of this 2017 Act is added to and made a part
7 of ORS 475B.400 to 475B.525.**

8 **“SECTION 2. (1) Notwithstanding section 40 (8), chapter __, Oregon
9 Laws 2017 (Enrolled Senate Bill 1057), the additional fee imposed by the
10 Oregon Health Authority under section 40 (8), chapter __, Oregon
11 Laws 2017 (Enrolled Senate Bill 1057), may not be greater than the fee
12 imposed under ORS 475B.420 for marijuana grow sites, ORS 475B.435
13 for marijuana processing sites and ORS 475B.450 for medical marijuana
14 dispensaries.**

15 **“(2) Pursuant to ORS 475B.025 (2)(d)(G), the Oregon Liquor Control
16 Commission shall impose a fee on licensees, as defined in ORS
17 475B.015, that is calculated to pay costs incurred under section 40,
18 chapter __, Oregon Laws 2017 (Enrolled Senate Bill 1057), other than
19 costs paid pursuant to section 40 (7) and (8), chapter __, Oregon Laws
20 2017 (Enrolled Senate Bill 1057). Moneys collected pursuant to this
21 subsection shall be deposited into the Marijuana Control and Regu-**

1 lation Fund established under ORS 475B.240 and are continuously ap-
2 propriated to the commission for purposes of this subsection.

3 **“SECTION 3. If Senate Bill 1057 does not become law, section 2 of**
4 **this 2017 Act is repealed.**

5 **“SECTION 4. (1) For the biennium beginning July 1, 2017, in lieu**
6 **of imposing fees under section 40 (8), chapter __, Oregon Laws 2017**
7 **(Enrolled Senate Bill 1057), and section 2 (2) of this 2017 Act, as part**
8 **of the agreement entered into under section 40, chapter __, Oregon**
9 **Laws 2017 (Enrolled Senate Bill 1057), the Oregon Health Authority**
10 **shall transfer an amount of moneys to the Oregon Liquor Control**
11 **Commission for deposit in the Marijuana Control and Regulation Fund**
12 **established under ORS 475B.240 to pay costs incurred under section 40,**
13 **chapter __, Oregon Laws 2017 (Enrolled Senate Bill 1057), other than**
14 **costs paid pursuant to section 40 (7), chapter __, Oregon Laws 2017**
15 **(Enrolled Senate Bill 1057).**

16 **“(2) Moneys transferred to the commission under this section must**
17 **be from moneys collected by the authority as a registration fee under**
18 **ORS 475B.400 to 475B.525 that are not allocated, appropriated or oth-**
19 **erwise dedicated to administering or enforcing ORS 475B.400 to**
20 **475B.525.**

21 **“SECTION 5. If Senate Bill 1057 does not become law, section 4 of**
22 **this 2017 Act is repealed.**

23 **“SECTION 6. This 2017 Act being necessary for the immediate**
24 **preservation of the public peace, health and safety, an emergency is**
25 **declared to exist, and this 2017 Act takes effect on its passage.”.**
