2 “413.590.”.

3 On page 5, after line 14, insert:

4 **“SECTION 12.** ORS 413.590 is amended to read:

5 “413.590. (1)(a) A [*physician assistant licensed under ORS chapter 677, a*
6 *nurse licensed under ORS chapter 678, a psychologist licensed under ORS*
7 *675.010 to 675.150, a chiropractic physician licensed under ORS chapter 684,*
8 *a naturopath licensed under ORS chapter 685, an acupuncturist licensed under*
9 *ORS 677.759, a pharmacist licensed under ORS chapter 689, a dentist licensed*
10 *under ORS chapter 679, an occupational therapist licensed under ORS 675.210*
11 *to 675.340 and a physical therapist licensed under ORS 688.010 to 688.201 must*
12 *complete one pain management education program described under ORS*
13 *413.572.] **person authorized to practice one of the following professions***
14 **must complete the pain management education program described in**
15 **ORS 413.572:**

16 **“(A) A physician assistant licensed under ORS chapter 677;**

17 **“(B) A nurse licensed under ORS chapter 678;**

18 **“(C) A psychologist licensed under ORS 675.010 to 675.150;**

19 **“(D) A chiropractic physician licensed under ORS chapter 684;**

20 **“(E) A naturopathic physician licensed under ORS chapter 685;**

21 **“(F) An acupuncturist licensed under ORS 677.759;**

1 “(G) A pharmacist licensed under ORS chapter 689;

2 “(H) A dentist licensed under ORS chapter 679;

3 “(I) An occupational therapist licensed under ORS 675.210 to 675.340;

4 “(J) A physical therapist licensed under ORS 688.010 to 688.201;

5 “(K) An optometrist licensed under ORS chapter 683;

6 “(L) A clinical social worker licensed under ORS 675.530;

7 “(M) A professional counselor licensed under ORS 675.715;

8 “(N) A marriage and family therapist licensed under ORS 675.715;

9 “(O) A massage therapist licensed under ORS 687.011 to 687.250;

10 “(P) An expanded practice dental hygienist who holds a permit is-
11 sued under ORS 680.200; and

12 “(Q) A speech-language pathologist licensed under ORS chapter 681.

13 “(b) A person who holds a certificate of certified alcohol drug
14 counselor from the Addiction Counselor Certification Board of Oregon
15 or its successor organization must complete the pain management
16 education program described in ORS 413.572.

17 “(2) The Oregon Medical Board, in consultation with the Pain Manage-
18 ment Commission, shall identify by rule physicians licensed under ORS
19 chapter 677 who, on an ongoing basis, treat patients in chronic or terminal
20 pain and who must complete [one] **the** pain management education program
21 established under ORS 413.572. The board may identify by rule circumstances
22 under which the requirement under this section may be waived.

23 “(3) **Any state board that regulates a person authorized to practice**
24 **a profession listed in subsection (1)(a) of this section may impose any**
25 **form of discipline on the person under the laws of this state for vio-**
26 **lating this section.”.**

27 In line 15, delete “12” and insert “13” and after “ORS” insert “413.590,”.

28 In line 16, delete “11” and insert “12”.

29 In line 18, after “Act” insert “or that regulates a person authorized to
30 practice a profession listed in ORS 413.590, as amended by section 12 of this

1 2017 Act”.

2 In line 20, delete “board” and insert “boards”.

3 In line 23, after “ORS” insert “413.590,”.

4 In line 24, delete “11” and insert “12”.

5 In line 25, delete “13” and insert “14”.
