"OREGON CANNABIS COMMISSION

10

"SECTION 1. (1) The Oregon Cannabis Commission is established
 within the Oregon Health Authority. The commission consists of:
 "(a) The Public Health Officer or the Public Health Officer's
 designee; and

15 **"(b) Eight members appointed by the Governor as follows:**

"(A) A registry identification cardholder, as defined in ORS
 475B.410;

"(B) A person designated to produce marijuana by a registry iden tification cardholder, as defined in ORS 475B.410;

20 "(C) An attending physician, as defined in ORS 475B.410;

1 "(D) A person representing the Oregon Health Authority;

² "(E) A person representing the Oregon Liquor Control Commission;

3 "(F) A local health officer, as described in ORS 431.418;

"(2) The term of office of each member of the commission is four years, but a member serves at the pleasure of the Governor. Before the expiration of the term of a member, the Governor shall appoint a successor whose term begins on January 1 of the following year. A member is eligible for reappointment. If there is a vacancy for any cause, the Governor shall make an appointment to become immediately effective for the unexpired term.

"(3) The appointment of each member of the commission is subject
 to confirmation by the Senate in the manner prescribed in ORS 171.562
 and 171.565.

"(4) Members of the commission are not entitled to compensation,
but may be reimbursed for actual and necessary travel and other expenses incurred by them in the performance of their official duties in
the manner and amounts provided for in ORS 292.495.

21 "<u>SECTION 2.</u> (1) The Oregon Cannabis Commission shall select one 22 of its members as chairperson and another as vice chairperson, for 23 terms and with duties and powers necessary for the performance of the 24 functions of the offices as the commission determines.

(1) As soon as practicable after the effective date of 4 this 2017 Act, the Oregon Cannabis Commission shall determine: $\mathbf{5}$ "(a) A possible framework for the future governance of the Oregon 6 Medical Marijuana Program, including: 7 "(A) Proper oversight and regulation of each of the following: 8 "(i) Registry identification cardholders and designated primary 9 caregivers, as those terms are defined in ORS 475B.410; 10 "(ii) Attending physicians, as defined in ORS 475B.410; 11 "(iii) Marijuana grow sites, as defined in ORS 475B.410; 12"(iv) Marijuana processing sites, as defined in ORS 475B.410; and 13 "(v) Medical marijuana dispensaries, as defined in ORS 475B.410; 14 "(B) Necessary amendments to the laws of the state pertaining to 15cannabis, including any necessary amendments to ORS 475B.010 to 16 475B.395 and 475B.400 to 475B.525; and 17 "(C) The future role of the commission with respect to the possible 18 framework. 19 "(b) Steps that the state must take, whether administrative or leg-20islative in nature, to ensure that research on cannabis and cannabis-21derived products is being conducted for public purposes, including the 22advancement of: 23"(A) Public health policy and public safety policy; 24"(B) Agronomic and horticultural best practices; and 25"(C) Medical and pharmacopoeial best practices. 26"(2) In determining the possible framework for the future 27governance of the Oregon Medical Marijuana Program under sub-28section (1)(a) of this section, the commission shall consider: 29 "(a) Potential factors that could prevent access to cannabis for 30

1 medical use;

"(b) Potential laws and rules that will facilitate access to cannabis
for medical use; and

 marijuana grow site may transfer up to 20 pounds of usable marijuana

"(b) A person who is designated to produce marijuana by a registry identification cardholder may produce no more than six mature marijuana plants and no more than 12 immature marijuana plants **that are 24 inches or more in height** for a registry identification cardholder who designates the person to produce marijuana.

 ORS 475B.420 is located within city limits in an area zoned for residential
 use:

"(a) Except as provided in paragraph (b) of this subsection, no more than
12 mature marijuana plants and no more than 24 immature marijuana plants

Oregon Health Authority under ORS 475B.420 before January 1, 2015:

address on December 31, 2014, in excess of 12 mature marijuana plants, not
to exceed 24 mature marijuana plants, may be produced at the address; and
"(B) No more than 48 immature marijuana plants that are 24 inches or
more in height may be produced at the address.

"(4) If the address of a person responsible for a marijuana grow site under
 ORS 475B.420 is located in an area other than an area described in sub section (3) of this section:

"(a) Except as provided in paragraph (b) of this subsection, no more than
48 mature marijuana plants and no more than 96 immature marijuana plants
that are 24 inches or more in height may be produced at the address; or
"(b) Subject to subsections (5) and (6) of this section, if each person responsible for a marijuana grow site located at the address first registered
with the authority under ORS 475B.420 before January 1, 2015:

"(A) no more than the amount of mature marijuana plants located at that
address on December 31, 2014, in excess of 48 mature marijuana plants, not
to exceed 96 mature marijuana plants, may be produced at the address; and
"(B) No more than 192 immature marijuana plants that are 24 inches
or more in height may be produced at the address.

"(5) If the authority suspends or revokes the registration of a person responsible for a marijuana grow site that is located at an address described in subsection (3)(b) or (4)(b) of this section:

"(a) No more than 12 mature marijuana plants and no more than 24 immature marijuana plants **that are 24 inches or more in height** may be subsequently produced at any address described in subsection (3) of this section at which the person responsible for that marijuana grow site

1 produces marijuana.

2 "(b) No more than 48 mature marijuana plants and no more than 96 im-3 mature marijuana plants **that are 24 or more inches in height** may be 4 subsequently produced at any address described in subsection (4) of this 5 section at which the person responsible for that marijuana grow site 6 produces marijuana.

"(6) If a registry identification cardholder who designated a person to 7 produce marijuana for the registry identification cardholder pursuant to ORS 8 475B.420 terminates the designation, the person responsible for the marijuana 9 grow site whose designation has been terminated may not be designated to 10 produce marijuana by another registry identification cardholder, except that 11 the person may be designated by another registry identification cardholder 12if no more than 48 mature marijuana plants and no more than 96 immature 13 marijuana plants that are 24 or more inches in height are produced at the 14 address for the marijuana grow site at which the person produces marijuana. 15"(7) Subject to the limits described in subsections (2) to (6) of this section, 16 if multiple persons responsible for a marijuana grow site under ORS 475B.420 17 are located at the same address, the persons designated to produce marijuana 18 by registry identification cardholders who are located at that address may 19

marijuana dispensary, if different from the name of the individual who owns
the medical marijuana dispensary;

1 "(c) The address of the medical marijuana dispensary;

2 "(d) Proof that each individual responsible for the medical marijuana 3 dispensary is 21 years of age or older;

"(e) Documentation, as required by the authority by rule, that demonstrates the medical marijuana dispensary meets the requirements of subsection (3) of this section; and

7 "(f) Any other information that the authority considers necessary.

8 "(3) To qualify for registration under this section, a medical marijuana9 dispensary:

10 "(a) May not be located in an area that is zoned for residential use;

11 "(b) May not be located at the same address as a marijuana grow site;

"(c) Must be registered as a business, or have filed an application to
 register as a business, with the office of the Secretary of State;

"(d) Except as provided under [section 29, chapter 83, Oregon Laws 2016]
 section 22 of this 2017 Act, may not be located within 1,000 feet of:

"(A) A public elementary or secondary school for which attendance is
 compulsory under ORS 339.020; or

"(B) A private or parochial elementary or secondary school, teaching
children as described in ORS 339.030 (1)(a);

"(e) Must not be located within 1,000 feet of another medical marijuana
 dispensary; and

"(f) Must meet the requirements of any rule adopted by the authority
under subsection (10) of this section.

"(4)(a) The authority shall conduct a criminal records check under ORS
181A.195 for each individual named in an application submitted under subsection (2) of this section.

"(b) An individual convicted for the manufacture or delivery of a controlled substance in Schedule I or Schedule II may not own or be responsible for a medical marijuana dispensary for two years from the date the individual is convicted. "(c) An individual convicted more than once for the manufacture or delivery of a controlled substance in Schedule I or Schedule II may not own or be responsible for a medical marijuana dispensary.

"(5) If a person submits the application required under subsection (2) of 4 this section, if the medical marijuana dispensary identified in the application $\mathbf{5}$ meets the requirements of this section and any rules adopted under this 6 section and if each individual named in the application passes the criminal 7 records check required under subsection (4) of this section, the authority 8 shall register the medical marijuana dispensary and issue proof of registra-9 tion. Proof of registration must be displayed on the premises of the medical 10 marijuana dispensary at all times. 11

"(6) A medical marijuana dispensary that is registered under this section
 is not required to register with the State Board of Pharmacy under ORS
 475.125.

15 "(7) The individual or individuals responsible for a medical marijuana 16 dispensary shall maintain documentation of each transfer of usable 17 marijuana, medical cannabinoid products, cannabinoid concentrates, 18 cannabinoid extracts, immature marijuana plants and seeds.

19 "(8) The authority may inspect:

"(a) The premises of a proposed medical marijuana dispensary or a regis tered medical marijuana dispensary to ensure compliance with this section
 and ORS 475B.453 and any rules adopted under this section or ORS 475B.453;
 and

"(b) The records of a registered medical marijuana dispensary to ensure
 compliance with subsection (7) of this section.

²⁶ "(9) Subject to the provisions of ORS chapter 183, the authority may re-²⁷ fuse to register an applicant under this section or may suspend or revoke the ²⁸ registration of a medical marijuana dispensary if the authority determines ²⁹ that the applicant, the owner of the medical marijuana dispensary, a person ³⁰ responsible for the medical marijuana dispensary, or an employee of the medical marijuana dispensary, violated a provision of ORS 475B.400 to

 public health and safety; and

"(e) Impose any other standard on the operation of a medical marijuanadispensary to ensure the public health and safety.
