**PROPOSED AMENDMENTS TO  
SENATE BILL 140**

1 Delete lines 4 through 10 of the printed bill and insert:

2 **“SECTION 1. There is established in the State Treasury, separate**  
3 **and distinct from the General Fund, the Veterans’ Services Fund, to**  
4 **be administered by the Oregon Department of Administrative Services.**  
5 **Interest earned by the fund is credited to the fund. Pursuant to Article**  
6 **XV, section 4f, of the Oregon Constitution, one and one-half percent**  
7 **of the net proceeds from the Oregon State Lottery shall be deposited**  
8 **in the Veterans’ Services Fund. All moneys transferred from the State**  
9 **Lottery Fund and all other moneys authorized to be transferred to the**  
10 **Veterans’ Services Fund from whatever source are appropriated con-**  
11 **tinuously to provide services for the benefit of veterans.**

12 **“SECTION 2. (1) On December 31 in each odd-numbered year, all**  
13 **amounts remaining unspent by a state agency from statutory allo-**  
14 **cations made from the Veterans’ Services Fund to that agency for the**  
15 **prior biennium shall revert to the Veterans’ Services Fund.**

16 **“(2) Subsection (1) of this section does not apply to allocations for**  
17 **debt service, capital construction, continuing contracts, contested**  
18 **claims or special allocations designated by legislative action.**

19 **“SECTION 3. The Veterans’ Department of Veterans’ Affairs Dedi-**  
20 **cated Lottery Fund is established in the State Treasury, separate and**  
21 **distinct from the General Fund. The Veterans’ Department of**

1 **Veterans' Affairs Dedicated Lottery Fund consists of moneys allocated**  
2 **or transferred to the fund from the Veterans' Services Fund estab-**  
3 **lished under section 1 of this 2017 Act. The moneys in the Veterans'**  
4 **Department of Veterans' Affairs Dedicated Lottery Fund are contin-**  
5 **uously appropriated to the Department of Veterans' Affairs to provide**  
6 **services for the benefit of veterans. Moneys in the fund may be used**  
7 **only for purposes for which moneys in the Veterans' Services Fund**  
8 **may be used under section 1 of this 2017 Act and Article XV, section**  
9 **4f, of the Oregon Constitution.**

10 **“SECTION 4. The Veterans' Housing and Community Services De-**  
11 **partment Dedicated Lottery Fund is established in the State Treasury,**  
12 **separate and distinct from the General Fund. The Veterans' Housing**  
13 **and Community Services Department Dedicated Lottery Fund consists**  
14 **of moneys allocated or transferred to the fund from the Veterans'**  
15 **Services Fund established under section 1 of this 2017 Act or from the**  
16 **Veterans' Department of Veterans' Affairs Dedicated Lottery Fund**  
17 **established under section 3 of this 2017 Act. The moneys in the**  
18 **Veterans' Housing and Community Services Department Dedicated**  
19 **Lottery Fund are continuously appropriated to the Housing and Com-**  
20 **munity Services Department to provide services for the benefit of**  
21 **veterans. Moneys in the fund may be used only for purposes for which**  
22 **moneys in the Veterans' Services Fund may be used under section 1**  
23 **of this 2017 Act and Article XV, section 4f, of the Oregon Constitution.**

24 **“SECTION 5. This 2017 Act being necessary for the immediate**  
25 **preservation of the public peace, health and safety, an emergency is**  
26 **declared to exist, and this 2017 Act takes effect July 1, 2017.”.**
