"SECTION 6a. (1) There is created an Energy Industry Advisory
 Committee consisting of nine members appointed by the Oregon En ergy and Climate Board as follows:

- "(a) Two members who represent electric investor-owned utilities
 as that term is defined in ORS 469.631;
- 21 "(b) One member who represents a natural gas investor-owned

1 utility as that term is defined in ORS 469.631;

"(c) Two members who represent consumer-owned utilities as that
term is defined in ORS 469A.005;

4 "(d) One member who represents the interests of renewable energy
5 developers;

6 "(e) One member who represents the interests of energy efficiency
7 contractors; and

8 "(f) Two at-large members.

9 "(2) The committee shall provide information and recommendations
10 to the board on:

11 "(a) Energy production, distribution and utilization;

12 "(b) Energy portfolio resources and energy infrastructure
 13 resiliency;

"(c) Energy industry trends related to matters described in para graphs (a) and (b) of this subsection; and

"(d) Proposals by the Oregon Department of Energy and Climate
 related to planning, policy and technical analysis.

"(3) Members of the committee shall be appointed to serve for terms
 of four years each. A vacancy on the committee shall be filled by appointment by the board for the unexpired term.

"(4) The committee shall select from among themselves a chairperson and any other officers with such terms and duties as the committee considers necessary. A majority of the members of the committee constitutes a quorum. The committee shall meet at least two times per year at the call of the chairperson of the board.

"(5) Members of the committee are not entitled to compensation
 or reimbursement for expenses and shall serve as volunteers on the
 committee.

29 "(6) The Oregon Department of Energy and Climate shall provide 30 personnel services to assist the committee within the limits of avail-

1 able funds.".

"(A) State actions that may be taken to help mitigate and adapt to theimpacts of climate change; and

"(B) The utilization and development of resources for funding state programs, projects and activities related to mitigating and adapting to the impacts of climate change.".
