**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2355**

1 On page 20 of the printed A-engrossed bill, after line 12, insert:

2 **“SECTION 26. Notwithstanding any other provision of law, the**
3 **General Fund appropriation made to the Oregon Criminal Justice**
4 **Commission by section 1, chapter _____, Oregon Laws 2017 (Enrolled**
5 **House Bill 5005), for the biennium beginning July 1, 2017, is increased**
6 **by \$347,351 for the purpose of implementing the provisions of this 2017**
7 **Act.**

8 **“SECTION 27. Notwithstanding any other provision of law, the**
9 **General Fund appropriation made to the Department of State Police**
10 **by section 1 (4), chapter _____, Oregon Laws 2017 (Enrolled House Bill**
11 **5031), for the biennium beginning July 1, 2017, for administrative ser-**
12 **vices, agency support, criminal justice information services and office**
13 **of the State Fire Marshal, is increased by \$780,418 for the purpose of**
14 **implementing the provisions of this 2017 Act.**

15 **“SECTION 28. Notwithstanding any other law limiting expenditures,**
16 **the limitation on expenditures established by section 2 (4), chapter**
17 **_____, Oregon Laws 2017 (Enrolled House Bill 5031), for the biennium**
18 **beginning July 1, 2017, as the maximum limit for payment of expenses**
19 **from fees, moneys or other revenues, including Miscellaneous Re-**
20 **ceipts, but excluding lottery funds and federal funds, collected or re-**
21 **ceived by the Department of State Police for administrative services,**

1 agency support, criminal justice information services and office of the
2 State Fire Marshal, is increased by \$750,000 for the purpose of imple-
3 menting the provisions of this 2017 Act.

4 **“SECTION 29. Notwithstanding any other law limiting expenditures,**
5 **the limitation on expenditures established by section 2 (1), chapter**
6 **——, Oregon Laws 2017 (Enrolled House Bill 5034), for the biennium**
7 **beginning July 1, 2017, as the maximum limit for payment of expenses**
8 **from fees, moneys or other revenues, including Miscellaneous Re-**
9 **ceipts, but excluding lottery funds and federal funds, collected or re-**
10 **ceived by the Department of Public Safety Standards and Training, for**
11 **operations, is increased by \$431,330 for the purpose of implementing**
12 **the provisions of this 2017 Act.”.**

13 In line 13, delete “26” and insert “30”.

14 In line 21, delete “27” and insert “31”.
